Mr. MCINNIS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

---

## RESOLUTION

Providing for the consideration of the bill (H.R. 926) to promote regulatory flexibility and enhance public participation in Federal agency rulemaking, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 1(b) of  
3 rule XXIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 926) to promote regulatory flexibil-  
6 ity and enhance public participation in Federal agency

1 rulemaking, and for other purposes. The first reading of  
2 the bill shall be dispensed with. General debate shall be  
3 confined to the bill and shall not exceed ninety minutes,  
4 with sixty minutes equally divided and controlled by the  
5 chairman and ranking minority member of the Committee  
6 on the Judiciary and thirty minutes equally divided and  
7 controlled by the chairman and ranking minority member  
8 of the Committee on Small Business. After general debate  
9 the bill shall be considered for amendment under the five-  
10 minute rule. It shall be in order to consider as an original  
11 bill for the purpose of amendment under the five-minute  
12 rule the amendment in the nature of a substitute rec-  
13 ommended by the Committee on the Judiciary now printed  
14 in the bill. The committee amendment in the nature of  
15 a substitute shall be considered by title rather than by  
16 section. Each title shall be considered as read. During con-  
17 sideration of the bill for amendment, the Chairman of the  
18 Committee of the Whole may accord priority in recognition  
19 on the basis of whether the Member offering an amend-  
20 ment has caused it to be printed in the portion of the Con-  
21 gressional Record designated for that purpose in clause  
22 6 of rule XXIII. Amendments so printed shall be consid-  
23 ered as read. At the conclusion of consideration of the bill  
24 for amendment the Committee shall rise and report the  
25 bill to the House with such amendments as may have been

1 adopted. Any Member may demand a separate vote in the  
2 House on any amendment adopted in the Committee of  
3 the Whole to the bill or to the committee amendment in  
4 the nature of a substitute. The previous question shall be  
5 considered as ordered on the bill and amendments thereto  
6 to final passage without intervening motion except one  
7 motion to recommit with or without instructions.
