Mr. SOLOMON, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the concurrent resolution (H. Con. Res. 67) setting forth the congressional budget for the United States Government for the fiscal years 1996, 1997, 1998, 1999, 2000, 2001, and 2002.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the concurrent resolution (H. Con. Res. 67) set-
6 ting forth the congressional budget for the United States

1 Government for the fiscal years 1996, 1997, 1998, 1999,
2 2000, 2001, and 2002. The first reading of the concurrent
3 resolution shall be dispensed with. All points of order
4 against the concurrent resolution and against its consider-
5 ation are waived. General debate shall be confined to the
6 congressional budget and shall not exceed six hours (in-
7 cluding one hour on the subject of economic goals and
8 policies) equally divided and controlled by the chairman
9 and ranking minority member of the Committee on the
10 Budget. After general debate the concurrent resolution
11 shall be considered for amendment under the five-minute
12 rule. The amendment printed in the report of the Commit-
13 tee on Rules accompanying this resolution shall be consid-
14 ered as adopted in the House and in the Committee of
15 the Whole. The concurrent resolution, as amended, shall
16 be considered as read. No further amendment shall be in
17 order except those designated in section 2 of this resolu-
18 tion. Each amendment may be offered only in the order
19 designated, may be offered only by a Member designated,
20 shall be considered as read, shall be debatable for one hour
21 equally divided and controlled by the proponent and an
22 opponent, and shall not be subject to amendment. All
23 points of order against the amendments designated in sec-
24 tion 2 are waived except that the adoption of an amend-
25 ment in the nature of a substitute shall constitute the con-

1 clusion of consideration of the concurrent resolution for
2 amendment. After the conclusion of consideration of the
3 concurrent resolution for amendment, and a final period
4 of general debate, which shall not exceed ten minutes
5 equally divided and controlled by the chairman and rank-
6 ing minority member of the Committee on the Budget, the
7 Committee shall rise and report the concurrent resolution
8 to the House with such amendment as may have been
9 adopted. The previous question shall be considered as or-
10 dered on the concurrent resolution and amendments there-
11 to to final adoption without intervening motion except
12 amendments offered by the chairman of the Committee
13 on the Budget pursuant to section 305(a)(5) of the Con-
14 gressional Budget Act of 1974 to achieve mathematical
15 consistency. The concurrent resolution shall not be subject
16 to a demand for division of the question of its adoption.

17 SEC. 2. The following amendments are in order pur-
18 suant to the first section of this resolution:

19 (1) An amendment in the nature of a substitute
20 by Representative Gephardt of Missouri printed not
21 later than May 16, 1995, in the portion of the Con-
22 gressional Record designated for that purpose in
23 clause 6 of rule XXIII, if proposing a Congressional
24 budget in which total outlays for the fiscal year
25 2002 do not exceed total receipts for that fiscal year.

1 (2) An amendment in the nature of a substitute
2 by Representative Neumann of Wisconsin or Rep-
3 resentative Solomon of New York consisting of the
4 text of House Concurrent Resolution 66.

5 (3) An amendment in the nature of a substitute
6 by Representative Payne of New Jersey or Rep-
7 resentative Owens of New York printed by Rep-
8 resentative Payne on May 16, 1995, in the portion
9 of the Congressional Record designated for that pur-
10 pose in clause 6 of rule XXIII.

11 (4) An amendment in the nature of a substitute
12 by the minority leader or a designee printed by him
13 not later than May 17, 1995, in the portion of the
14 Congressional Record designated for that purpose in
15 clause 6 of rule XXIII, if proposing a Congressional
16 budget based on a revised budget submission by the
17 President to the Congress in which total outlays for
18 the fiscal year 2002 do not exceed total receipts for
19 that fiscal year.

20 SEC. 3. Rule XLIX shall not apply with respect to
21 the adoption by the Congress of a conference report to
22 accompany a concurrent resolution setting forth the con-
23 gressional budget for the United States Government for
24 the fiscal years 1996, 1997, 1998, 1999, 2000, 2001, and
25 2002.
