5 tend beyond the calendar day of Tuesday, February 6,

1        SEC. 2. The Speaker may declare recesses subject to  
2 the call of the Chair on the calendar days of Tuesday,  
3 February 6, 1996, through Friday, February 9, 1996. A  
4 recess declared pursuant to this subsection may not extend  
5 beyond the calendar day of Friday, February 9, 1996.

6        SEC. 3. The Speaker may declare recesses subject to  
7 the call of the Chair on the calendar days of Friday, Feb-  
8 ruary 9, 1996, through Tuesday, February 13, 1996. A  
9 recess declared pursuant to this subsection may not extend  
10 beyond the calendar day of Tuesday, February 13, 1996.

13 February 13, 1996, through Friday, February 16, 1996.

19 ruary 16, 1996, through Tuesday, February 20, 1996. A

21 beyond the calendar day of Tuesday, February 20, 1996.
