Mr. SOLOMON, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

# RESOLUTION

Providing for consideration of the bill (H.R. 3820) to amend the Federal Election Campaign Act of 1971 to reform the financing of Federal election campaigns, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 1(b) of  
3 rule XXIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 3820) to amend the Federal Elec-  
6 tion Campaign Act of 1971 to reform the financing of

1 Federal election campaigns, and for other purposes. The  
2 first reading of the bill shall be dispensed with. General  
3 debate shall be confined to the bill and shall not exceed  
4 one hour equally divided and controlled by the chairman  
5 and ranking minority member of the Committee on House  
6 Oversight. After general debate the bill shall be considered  
7 for amendment under the five-minute rule and shall be  
8 considered as read. No amendment shall be in order except  
9 an amendment in the nature of a substitute consisting of  
10 the text of H.R. 3505, modified by the amendment printed  
11 in the report of the Committee on Rules accompanying  
12 this resolution. That amendment may be offered only by  
13 the minority leader or his designee, shall be considered as  
14 read, shall be debatable for one hour equally divided and  
15 controlled by the proponent and an opponent, and shall  
16 not be subject to amendment. All points of order against  
17 that amendment are waived. At the conclusion of consider-  
18 ation of the bill for amendment the Committee shall rise  
19 and report the bill to the House with such amendment  
20 as may have been adopted. The previous question shall  
21 be considered as ordered on the bill and any amendment  
22 thereto to final passage without intervening motion except  
23 one motion to recommit with or without instructions.
