TITLE I

MILITARY PERSONNEL

MILITARY PERSONNEL, ARMY

For pay, allowances, individual clothing, interest on deposits, gratuities, permanent change of station travel (including all expenses thereof for organizational movements), and expenses of temporary duty travel between permanent duty stations, for members of the Army on active duty (except members of reserve components provided for elsewhere), cadets, and aviation cadets; and for payments pursuant to section 156 of Public Law 97-377, as amended (42 U.S.C. 402 note), to section 229(b) of the Social Security Act (42 U.S.C. 429(b)), and to the Department of Defense Military Retirement Fund; \$19,776,587,000.

MILITARY PERSONNEL, NAVY

For pay, allowances, individual clothing, interest on deposits, gratuities, permanent change of station travel (including all expenses thereof for organizational movements), and expenses of temporary duty travel between permanent duty stations, for members of the Navy on active duty (except members of the Reserve provided for elsewhere), midshipmen, and aviation cadets; and for payments pursuant to section 156 of Public Law 97-377, as amended (42 U.S.C. 402 note), to section 229(b) of the

1 Social Security Act (42 U.S.C. 429(b)), and to the De-  
2 partment of Defense Military Retirement Fund;  
3 \$16,979,209,000.

4 MILITARY PERSONNEL, MARINE CORPS

5 For pay, allowances, individual clothing, interest on  
6 deposits, gratuities, permanent change of station travel  
7 (including all expenses thereof for organizational move-  
8 ments), and expenses of temporary duty travel between  
9 permanent duty stations, for members of the Marine  
10 Corps on active duty (except members of the Reserve pro-  
11 vided for elsewhere); and for payments pursuant to section  
12 156 of Public Law 97-377, as amended (42 U.S.C. 402  
13 note), to section 229(b) of the Social Security Act (42  
14 U.S.C. 429(b)), and to the Department of Defense Mili-  
15 tary Retirement Fund; \$5,886,540,000.

16 MILITARY PERSONNEL, AIR FORCE

17 For pay, allowances, individual clothing, interest on  
18 deposits, gratuities, permanent change of station travel  
19 (including all expenses thereof for organizational move-  
20 ments), and expenses of temporary duty travel between  
21 permanent duty stations, for members of the Air Force  
22 on active duty (except members of reserve components  
23 provided for elsewhere), cadets, and aviation cadets; and  
24 for payments pursuant to section 156 of Public Law 97-  
25 377, as amended (42 U.S.C. 402 note), to section 229(b)

1 of the Social Security Act (42 U.S.C. 429(b)), and to the  
2 Department of Defense Military Retirement Fund;  
3 \$17,156,443,000.

4 RESERVE PERSONNEL, ARMY

5 For pay, allowances, clothing, subsistence, gratuities,  
6 travel, and related expenses for personnel of the Army Re-  
7 serve on active duty under sections 265, 3021, and 3038  
8 of title 10, United States Code, or while serving on active  
9 duty under section 672(d) of title 10, United States Code,  
10 in connection with performing duty specified in section  
11 678(a) of title 10, United States Code, or while under-  
12 going reserve training, or while performing drills or equiv-  
13 alent duty or other duty, and for members of the Reserve  
14 Officers' Training Corps, and expenses authorized by sec-  
15 tion 2131 of title 10, United States Code; and for pay-  
16 ments to the Department of Defense Military Retirement  
17 Fund; \$2,102,466,000.

18 RESERVE PERSONNEL, NAVY

19 For pay, allowances, clothing, subsistence, gratuities,  
20 travel, and related expenses for personnel of the Navy Re-  
21 serve on active duty under section 265 of title 10, United  
22 States Code, or while serving on active duty under section  
23 672(d) of title 10, United States Code, in connection with  
24 performing duty specified in section 678(a) of title 10,  
25 United States Code, or while undergoing reserve training,

1 or while performing drills or equivalent duty, and for  
2 members of the Reserve Officers' Training Corps, and ex-  
3 penses authorized by section 2131 of title 10, United  
4 States Code; and for payments to the Department of De-  
5 fense Military Retirement Fund; \$1,349,323,000.

6           RESERVE PERSONNEL, MARINE CORPS

7           For pay, allowances, clothing, subsistence, gratuities,  
8 travel, and related expenses for personnel of the Marine  
9 Corps Reserve on active duty under section 265 of title  
10 10, United States Code, or while serving on active duty  
11 under section 672(d) of title 10, United States Code, in  
12 connection with performing duty specified in section  
13 678(a) of title 10, United States Code, or while under-  
14 going reserve training, or while performing drills or equiv-  
15 alent duty, and for members of the Marine Corps platoon  
16 leaders class, and expenses authorized by section 2131 of  
17 title 10, United States Code; and for payments to the De-  
18 partment of Defense Military Retirement Fund;  
19 \$364,551,000.

20           RESERVE PERSONNEL, AIR FORCE

21           For pay, allowances, clothing, subsistence, gratuities,  
22 travel, and related expenses for personnel of the Air Force  
23 Reserve on active duty under sections 265, 8021, and  
24 8038 of title 10, United States Code, or while serving on  
25 active duty under section 672(d) of title 10, United States

1 Code, in connection with performing duty specified in sec-  
2 tion 678(a) of title 10, United States Code, or while un-  
3 dergoing reserve training, or while performing drills or  
4 equivalent duty or other duty, and for members of the Air  
5 Reserve Officers' Training Corps, and expenses authorized  
6 by section 2131 of title 10, United States Code; and for  
7 payments to the Department of Defense Military Retire-  
8 ment Fund; \$783,861,000.

9 NATIONAL GUARD PERSONNEL, ARMY

10 For pay, allowances, clothing, subsistence, gratuities,  
11 travel, and related expenses for personnel of the Army Na-  
12 tional Guard while on duty under section 265, 3021, or  
13 3496 of title 10 or section 708 of title 32, United States  
14 Code, or while serving on duty under section 672(d) of  
15 title 10 or section 502(f) of title 32, United States Code,  
16 in connection with performing duty specified in section  
17 678(a) of title 10, United States Code, or while under-  
18 going training, or while performing drills or equivalent  
19 duty or other duty, and expenses authorized by section  
20 2131 of title 10, United States Code; and for payments  
21 to the Department of Defense Military Retirement Fund;  
22 \$3,222,422,000.

23 NATIONAL GUARD PERSONNEL, AIR FORCE

24 For pay, allowances, clothing, subsistence, gratuities,  
25 travel, and related expenses for personnel of the Air Na-

1 tional Guard on duty under section 265, 8021, or 8496  
2 of title 10 or section 708 of title 32, United States Code,  
3 or while serving on duty under section 672(d) of title 10  
4 or section 502(f) of title 32, United States Code, in con-  
5 nection with performing duty specified in section 678(a)  
6 of title 10, United States Code, or while undergoing train-  
7 ing, or while performing drills or equivalent duty or other  
8 duty, and expenses authorized by section 2131 of title 10,  
9 United States Code; and for payments to the Department  
10 of Defense Military Retirement Fund; \$1,259,627,000.

## 11 TITLE II

### 12 OPERATION AND MAINTENANCE

#### 13 OPERATION AND MAINTENANCE, ARMY

##### 14 (INCLUDING TRANSFER OF FUNDS)

15 For expenses, not otherwise provided for, necessary  
16 for the operation and maintenance of the Army, as author-  
17 ized by law; and not to exceed \$14,437,000 can be used  
18 for emergencies and extraordinary expenses, to be ex-  
19 pended on the approval or authority of the Secretary of  
20 the Army, and payments may be made on his certificate  
21 of necessity for confidential military purposes;  
22 \$17,947,229,000 and, in addition, \$50,000,000 shall be  
23 derived by transfer from the National Defense Stockpile  
24 Transaction Fund: *Provided*, That of the funds appro-  
25 priated in this paragraph, not less than \$388,599,000

1 shall be made available only for conventional ammunition  
2 care and maintenance: *Provided further*, That of the funds  
3 provided under this heading, \$1,418,000,000 shall be  
4 available only for Real Property Maintenance activities,  
5 and shall remain available for obligation until September  
6 30, 1997: *Provided further*, That not less than  
7 \$15,000,000 shall be made available only for the imple-  
8 mentation and execution of the 1988 agreement between  
9 the Department of the Army and National Presto Indus-  
10 tries Inc. for the remediation of environmental contamina-  
11 tion at the National Presto Industries Inc. site at Eau  
12 Claire, WI. These funds shall be made available no later  
13 than sixty days following the enactment of this Act.

14 OPERATION AND MAINTENANCE, NAVY

15 (INCLUDING TRANSFER OF FUNDS)

16 For expenses, not otherwise provided for, necessary  
17 for the operation and maintenance of the Navy and the  
18 Marine Corps, as authorized by law; and not to exceed  
19 \$4,151,000 can be used for emergencies and extraordinary  
20 expenses, to be expended on the approval or authority of  
21 the Secretary of the Navy, and payments may be made  
22 on his certificate of necessity for confidential military pur-  
23 poses; \$21,195,301,000 and, in addition, \$50,000,000  
24 shall be derived by transfer from the National Defense  
25 Stockpile Transaction Fund: *Provided*, That of the funds

1 provided under this heading, \$1,150,000,000 shall be  
2 available only for Real Property Maintenance activities,  
3 and shall remain available for obligation until September  
4 30, 1997.

5 OPERATION AND MAINTENANCE, MARINE CORPS

6 For expenses, not otherwise provided for, necessary  
7 for the operation and maintenance of the Marine Corps,  
8 as authorized by law; \$2,341,737,000: *Provided*, That of  
9 the funds provided under this heading, \$366,800,000 shall  
10 be available only for Real Property Maintenance activities,  
11 and shall remain available for obligation until September  
12 30, 1997.

13 OPERATION AND MAINTENANCE, AIR FORCE

14 (INCLUDING TRANSFER OF FUNDS)

15 For expenses, not otherwise provided for, necessary  
16 for the operation and maintenance of the Air Force, as  
17 authorized by law; and not to exceed \$8,326,000 can be  
18 used for emergencies and extraordinary expenses, to be ex-  
19 pended on the approval or authority of the Secretary of  
20 the Air Force, and payments may be made on his certifi-  
21 cate of necessity for confidential military purposes;  
22 \$18,202,437,000 and, in addition, \$50,000,000 shall be  
23 derived by transfer from the National Defense Stockpile  
24 Transaction Fund: *Provided*, That the Secretary of the Air  
25 Force may acquire all right, title, and interest of any party

1 in and to parcels of real property, including improvements  
2 thereon, consisting of not more than 92 acres, located near  
3 King Salmon Air Force Station for the purpose of con-  
4 ducting a response action in accordance with the Com-  
5 prehensive Environmental Response, Compensation, and  
6 Liability Act (42 U.S.C. 9601–9675) and the Air Force  
7 Installation Restoration Program: *Provided further*, That  
8 of the funds provided under this heading, \$1,633,000,000  
9 shall be available only for Real Property Maintenance ac-  
10 tivities, and shall be available for obligation until Septem-  
11 ber 30, 1997: *Provided further*, That from within the  
12 funds appropriated under this heading, the Air Force may  
13 enter into a long-term lease or purchase agreement to re-  
14 place the existing fleet of VC–137 aircraft.

15 OPERATION AND MAINTENANCE, DEFENSE-WIDE

16 For expenses, not otherwise provided for, necessary  
17 for the operation and maintenance of activities and agen-  
18 cies of the Department of Defense (other than the military  
19 departments), as authorized by law; \$9,844,068,000, of  
20 which not to exceed \$25,000,000 may be available for the  
21 CINC initiative fund account; and of which not to exceed  
22 \$28,588,000 can be used for emergencies and extraor-  
23 dinary expenses, to be expended on the approval or author-  
24 ity of the Secretary of Defense, and payments may be  
25 made on his certificate of necessity for confidential mili-

1 tary purposes: *Provided*, That of the funds appropriated  
2 under this heading, \$20,000,000 shall be made available  
3 only for use in federally owned education facilities located  
4 on military installations for the purpose of transferring  
5 title of such facilities to the local education agency: *Pro-*  
6 *vided further*, That of the funds provided under this head-  
7 ing, \$169,800,000 shall be available only for Real Prop-  
8 erty Maintenance activities, and shall remain available for  
9 obligation until September 30, 1997.

10 OPERATION AND MAINTENANCE, ARMY RESERVE

11 For expenses, not otherwise provided for, necessary  
12 for the operation and maintenance, including training, or-  
13 ganization, and administration, of the Army Reserve; re-  
14 pair of facilities and equipment; hire of passenger motor  
15 vehicles; travel and transportation; care of the dead; re-  
16 cruiting; procurement of services, supplies, and equip-  
17 ment; and communications; \$1,068,312,000: *Provided*,  
18 That of the funds provided under this heading,  
19 \$47,589,000 shall be available only for Real Property  
20 Maintenance activities, and shall remain available for obli-  
21 gation until September 30, 1997.

22 OPERATION AND MAINTENANCE, NAVY RESERVE

23 For expenses, not otherwise provided for, necessary  
24 for the operation and maintenance, including training, or-  
25 ganization, and administration, of the Navy Reserve; re-

1 pair of facilities and equipment; hire of passenger motor  
2 vehicles; travel and transportation; care of the dead; re-  
3 cruiting; procurement of services, supplies, and equip-  
4 ment; and communications; \$826,042,000: *Provided*, That  
5 of the funds provided under this heading, \$31,954,000  
6 shall be available only for Real Property Maintenance ac-  
7 tivities, and shall remain available for obligation until Sep-  
8 tember 30, 1997.

9 OPERATION AND MAINTENANCE, MARINE CORPS

10 RESERVE

11 For expenses, not otherwise provided for, necessary  
12 for the operation and maintenance, including training, or-  
13 ganization, and administration, of the Marine Corps Re-  
14 serve; repair of facilities and equipment; hire of passenger  
15 motor vehicles; travel and transportation; care of the dead;  
16 recruiting; procurement of services, supplies, and equip-  
17 ment; and communications; \$90,283,000: *Provided*, That  
18 of the funds provided under this heading, \$4,911,000 shall  
19 be available only for Real Property Maintenance activities,  
20 and shall remain available for obligation until September  
21 30, 1997.

22 OPERATION AND MAINTENANCE, AIR FORCE RESERVE

23 For expenses, not otherwise provided for, necessary  
24 for the operation and maintenance, including training, or-  
25 ganization, and administration, of the Air Force Reserve;

1 repair of facilities and equipment; hire of passenger motor  
2 vehicles; travel and transportation; care of the dead; re-  
3 cruiting; procurement of services, supplies, and equip-  
4 ment; and communications; \$1,485,947,000: *Provided,*  
5 That of the funds provided under this heading,  
6 \$63,062,000 shall be available only for Real Property  
7 Maintenance activities, and shall remain available for obli-  
8 gation until September 30, 1997.

9 OPERATION AND MAINTENANCE, ARMY NATIONAL  
10 GUARD

11 For expenses of training, organizing, and administer-  
12 ing the Army National Guard, including medical and hos-  
13 pital treatment and related expenses in non-Federal hos-  
14 pitals; maintenance, operation, and repairs to structures  
15 and facilities; hire of passenger motor vehicles; personnel  
16 services in the National Guard Bureau; travel expenses  
17 (other than mileage), as authorized by law for Army per-  
18 sonnel on active duty, for Army National Guard division,  
19 regimental, and battalion commanders while inspecting  
20 units in compliance with National Guard Bureau regula-  
21 tions when specifically authorized by the Chief, National  
22 Guard Bureau; supplying and equipping the Army Na-  
23 tional Guard as authorized by law; and expenses of repair,  
24 modification, maintenance, and issue of supplies and  
25 equipment (including aircraft); \$2,361,708,000: *Provided,*

1 That of the funds provided under this heading,  
2 \$150,188,000 shall be available only for Real Property  
3 Maintenance activities, and shall be available for obliga-  
4 tion until September 30, 1997.

5 OPERATION AND MAINTENANCE, AIR NATIONAL GUARD

6 For operation and maintenance of the Air National  
7 Guard, including medical and hospital treatment and re-  
8 lated expenses in non-Federal hospitals; maintenance, op-  
9 eration, repair, and other necessary expenses of facilities  
10 for the training and administration of the Air National  
11 Guard, including repair of facilities, maintenance, oper-  
12 ation, and modification of aircraft; transportation of  
13 things; hire of passenger motor vehicles; supplies, mate-  
14 rials, and equipment, as authorized by law for the Air Na-  
15 tional Guard; and expenses incident to the maintenance  
16 and use of supplies, materials, and equipment, including  
17 such as may be furnished from stocks under the control  
18 of agencies of the Department of Defense; travel expenses  
19 (other than mileage) on the same basis as authorized by  
20 law for Air National Guard personnel on active Federal  
21 duty, for Air National Guard commanders while inspecting  
22 units in compliance with National Guard Bureau regula-  
23 tions when specifically authorized by the Chief, National  
24 Guard Bureau; \$2,724,021,000: *Provided*, That of the  
25 funds provided under this heading, \$85,571,000 shall be

1 available only for Real Property Maintenance activities,  
2 and shall remain available for obligation until September  
3 30, 1997.

4 UNITED STATES COURT OF APPEALS FOR THE ARMED  
5 FORCES

6 For salaries and expenses necessary for the United  
7 States Court of Appeals for the Armed Forces;  
8 \$6,521,000, of which not to exceed \$2,500 can be used  
9 for official representation purposes.

10 ENVIRONMENTAL RESTORATION, DEFENSE  
11 (INCLUDING TRANSFER OF FUNDS)

12 For the Department of Defense; \$1,487,000,000, to  
13 remain available until transferred: *Provided*, That the Sec-  
14 retary of Defense shall, upon determining that such funds  
15 are required for environmental restoration, reduction and  
16 recycling of hazardous waste, removal of unsafe buildings  
17 and debris of the Department of Defense, or for similar  
18 purposes (including programs and operations at sites for-  
19 merly used by the Department of Defense), transfer the  
20 funds made available by this appropriation to other appro-  
21 priations made available to the Department of Defense,  
22 to be merged with and to be available for the same pur-  
23 poses and for the same period as the appropriations of  
24 funds to which transferred, as follows:



## 1 HUMANITARIAN ASSISTANCE

2 For training and activities related to the clearing of  
3 landmines for humanitarian purposes, \$20,000,000.

## 4 FORMER SOVIET UNION THREAT REDUCTION

5 For assistance to the republics of the former Soviet  
6 Union, including assistance provided by contract or by  
7 grants, for facilitating the elimination and the safe and  
8 secure transportation and storage of nuclear, chemical and  
9 other weapons; for providing incentives for demilitariza-  
10 tion; for establishing programs to prevent the proliferation  
11 of weapons, weapons components, and weapon-related  
12 technology and expertise; for programs relating to the  
13 training and support of defense and military personnel for  
14 demilitarization and protection of weapons, weapons com-  
15 ponents and weapons technology and expertise;  
16 \$325,000,000 to remain available until expended.

## 19 AIRCRAFT PROCUREMENT, ARMY

20 For construction, procurement, production, modifica-  
21 tion, and modernization of aircraft, equipment, including  
22 ordnance, ground handling equipment, spare parts, and  
23 accessories therefor; specialized equipment and training  
24 devices; expansion of public and private plants, including  
25 the land necessary therefor, for the foregoing purposes,

1 and such lands and interests therein, may be acquired,  
2 and construction prosecuted thereon prior to approval of  
3 title; and procurement and installation of equipment, ap-  
4 pliances, and machine tools in public and private plants;  
5 reserve plant and Government and contractor-owned  
6 equipment layaway; and other expenses necessary for the  
7 foregoing purposes; \$1,498,623,000, to remain available  
8 for obligation until September 30, 1998.

9 MISSILE PROCUREMENT, ARMY

10 For construction, procurement, production, modifica-  
11 tion, and modernization of missiles, equipment, including  
12 ordnance, ground handling equipment, spare parts, and  
13 accessories therefor; specialized equipment and training  
14 devices; expansion of public and private plants, including  
15 the land necessary therefor, for the foregoing purposes,  
16 and such lands and interests therein, may be acquired,  
17 and construction prosecuted thereon prior to approval of  
18 title; and procurement and installation of equipment, ap-  
19 pliances, and machine tools in public and private plants;  
20 reserve plant and Government and contractor-owned  
21 equipment layaway; and other expenses necessary for the  
22 foregoing purposes; \$846,555,000, to remain available for  
23 obligation until September 30, 1998.

15 lic and private plants, including the land necessary there-  
16 for, for the foregoing purposes, and such lands and inter-  
17 ests therein, may be acquired, and construction prosecuted  
18 thereon prior to approval of title; and procurement and  
19 installation of equipment, appliances, and machine tools

2 For construction, procurement, production, modifica-  
3 tion, and modernization of aircraft, equipment, including  
4 ordnance, spare parts, and accessories therefor; specialized  
5 equipment; expansion of public and private plants, includ-  
6 ing the land necessary therefor, and such lands and inter-  
7 ests therein, may be acquired, and construction prosecuted  
8 thereon prior to approval of title; and procurement and  
9 installation of equipment, appliances, and machine tools  
10 in public and private plants; reserve plant and Govern-  
11 ment and contractor-owned equipment layaway;  
12 \$4,897,393,000, to remain available for obligation until  
13 September 30, 1998.

## 14 WEAPONS PROCUREMENT, NAVY

15 For construction, procurement, production, modifica-  
16 tion, and modernization of missiles, torpedoes, other weap-  
17 ons, other ordnance and ammunition, and related support  
18 equipment including spare parts, and accessories therefor;  
19 expansion of public and private plants, including the land  
20 necessary therefor, and such lands and interests therein,  
21 may be acquired, and construction prosecuted thereon  
22 prior to approval of title; and procurement and installation  
23 of equipment, appliances, and machine tools in public and  
24 private plants; reserve plant and Government and contrac-

1 tor-owned equipment layaway; \$1,771,421,000, to remain  
2 available for obligation until September 30, 1998.

3 SHIPBUILDING AND CONVERSION, NAVY

4 For expenses necessary for the construction, acquisi-  
5 tion, or conversion of vessels as authorized by law, includ-  
6 ing armor and armament thereof, plant equipment, appli-  
7 ances, and machine tools and installation thereof in public  
8 and private plants; reserve plant and Government and con-  
9 tractor-owned equipment layaway; procurement of critical,  
10 long leadtime components and designs for vessels to be

12 TITLE VIII

13 GENERAL PROVISIONS

14 SEC. 8001. No part of any appropriation contained  
15 in this Act shall be used for publicity or propaganda pur-  
16 poses not authorized by the Congress.

17 SEC. 8002. During the current fiscal year, provisions  
18 of law prohibiting the payment of compensation to, or em-  
19 ployment of, any person not a citizen of the United States  
20 shall not apply to personnel of the Department of Defense:  
21 *Provided*, That salary increases granted to direct and indi-  
22 rect hire foreign national employees of the Department of  
23 Defense funded by this Act shall not be at a rate in excess  
24 of the percentage increase authorized by law for civilian  
25 employees of the Department of Defense whose pay is

1 computed under the provisions of section 5332 of title 5,  
2 United States Code, or at a rate in excess of the percent-  
3 age increase provided by the appropriate host nation to  
4 its own employees, whichever is higher: *Provided further,*  
5 That this section shall not apply to Department of De-  
6 fense foreign service national employees serving at United  
7 States diplomatic missions whose pay is set by the Depart-  
8 ment of State under the Foreign Service Act of 1980: *Pro-*  
9 *vided further,* That the limitations of this provision shall  
10 not apply to foreign national employees of the Department  
11 of Defense in the Republic of Turkey.

12 SEC. 8003. No part of any appropriation contained  
13 in this Act shall remain available for obligation beyond  
14 the current fiscal year, unless expressly so provided herein.

15 SEC. 8004. No more than 20 per centum of the ap-  
16 propriations in this Act which are limited for obligation  
17 during the current fiscal year shall be obligated during  
18 the last two months of the fiscal year: *Provided,* That this  
19 section shall not apply to obligations for support of active  
20 duty training of reserve components or summer camp  
21 training of the Reserve Officers' Training Corps.

22 (TRANSFER OF FUNDS)

23 SEC. 8005. Upon determination by the Secretary of  
24 Defense that such action is necessary in the national inter-  
25 est, he may, with the approval of the Office of Manage-  
26 ment and Budget, transfer not to exceed \$2,400,000,000

1 of working capital funds of the Department of Defense  
2 or funds made available in this Act to the Department  
3 of Defense for military functions (except military con-  
4 struction) between such appropriations or funds or any  
5 subdivision thereof, to be merged with and to be available  
6 for the same purposes, and for the same time period, as  
7 the appropriation or fund to which transferred: *Provided,*  
8 That such authority to transfer may not be used unless  
9 for higher priority items, based on unforeseen military re-  
10 quirements, than those for which originally appropriated  
11 and in no case where the item for which funds are re-  
12 quested has been denied by Congress: *Provided further,*  
13 That the Secretary of Defense shall notify the Congress  
14 promptly of all transfers made pursuant to this authority  
15 or any other authority in this Act: *Provided further,* That  
16 no part of the funds in this Act shall be available to pre-  
17 pare or present a request to the Committees on Appropria-  
18 tions for reprogramming of funds, unless for higher prior-  
19 ity items, based on unforeseen military requirements, than  
20 those for which originally appropriated and in no case  
21 where the item for which reprogramming is requested has  
22 been denied by the Congress.

23 (TRANSFER OF FUNDS)

24 SEC. 8006. During the current fiscal year, cash bal-  
25 ances in working capital funds of the Department of De-  
26 fense established pursuant to section 2208 of title 10,

1 United States Code, may be maintained in only such  
2 amounts as are necessary at any time for cash disburse-  
3 ments to be made from such funds: *Provided*, That trans-  
4 fers may be made between such funds and the “Foreign  
5 Currency Fluctuations, Defense” and “Operation and  
6 Maintenance” appropriation accounts in such amounts as  
7 may be determined by the Secretary of Defense, with the  
8 approval of the Office of Management and Budget, except  
9 that such transfers may not be made unless the Secretary  
10 of Defense has notified the Congress of the proposed  
11 transfer. Except in amounts equal to the amounts appro-  
12 priated to working capital funds in this Act, no obligations  
13 may be made against a working capital fund to procure  
14 or increase the value of war reserve material inventory,  
15 unless the Secretary of Defense has notified the Congress  
16 prior to any such obligation.

17 SEC. 8007. Using funds available by this Act or any  
18 other Act, the Secretary of the Air Force, pursuant to a  
19 determination under section 2690 of title 10, United  
20 States Code, may implement cost-effective agreements  
21 for required heating facility modernization in the  
22 Kaiserslautern Military Community in the Federal Repub-  
23 lic of Germany: *Provided*, That in the City of  
24 Kaiserslautern such agreements will include the use of  
25 United States anthracite as the base load energy for mu-

1 nicipal district heat to the United States Defense installa-  
2 tions: *Provided further*, That at Landstuhl Army Regional  
3 Medical Center and Ramstein Air Base, furnished heat  
4 may be obtained from private, regional or municipal serv-  
5 ices, if provisions are included for the consideration of  
6 United States coal as an energy source: *Provided further*,  
7 That none of the funds available to the Department of  
8 Defense in this Act shall be used by the Secretary of a  
9 military department to purchase coal or coke from foreign  
10 nations for use at United States defense facilities in Eu-  
11 rope when coal from the United States is available.

12 SEC. 8008. Funds appropriated by this Act may not  
13 be used to initiate a special access program without prior  
14 notification 30 calendar days in session in advance to the  
15 Committees on Appropriations, Armed Services, and Na-  
16 tional Security of the Senate and House of Representa-  
17 tives.

18 SEC. 8009. None of the funds contained in this Act  
19 available for the Civilian Health and Medical Program of  
20 the Uniformed Services shall be available for payments to  
21 physicians and other authorized individual health care pro-  
22 viders in excess of the amounts allowed in fiscal year 1994  
23 for similar services, except that: (a) for services for which  
24 the Secretary of Defense determines an increase is justi-  
25 fied by economic circumstances, the allowable amounts

1 may be increased in accordance with appropriate economic  
2 index data similar to that used pursuant to title XVIII  
3 of the Social Security Act; and (b) for services the Sec-  
4 retary determines are overpriced based on allowable pay-  
5 ments under title XVIII of the Social Security Act, the  
6 allowable amounts shall be reduced by not more than 15  
7 percent (except that the reduction may be waived if the  
8 Secretary determines that it would impair adequate access  
9 to health care services for beneficiaries). The Secretary  
10 shall solicit public comment prior to promulgating regula-

23 order quantity procurement in excess of \$20,000,000 in  
24 any one year, unless the Committees on Appropriations  
25 and Armed Services of the Senate and House of Rep-

1 representatives have been notified at least thirty days in ad-  
2 vance of the proposed contract award: *Provided*, That no  
3 part of any appropriation contained in this Act shall be  
4 available to initiate a multiyear contract for which the eco-  
5 nomic order quantity advance procurement is not funded  
6 at least to the limits of the Government's liability: *Pro-*  
7 *vided further*, That no part of any appropriation contained

24 SEC. 8011. Within the funds appropriated for the op-  
25 eration and maintenance of the Armed Forces, funds are

1 hereby appropriated pursuant to section 401 of title 10,  
2 United States Code, for humanitarian and civic assistance  
3 costs under chapter 20 of title 10, United States Code.  
4 Such funds may also be obligated for humanitarian and  
5 civic assistance costs incidental to authorized operations  
6 and pursuant to authority granted in section 401 of chap-  
7 ter 20 of title 10, United States Code, and these obliga-  
8 tions shall be reported to Congress on September 30 of  
9 each year: *Provided*, That funds available for operation  
10 and maintenance shall be available for providing humani-  
11 tarian and similar assistance by using Civic Action Teams  
12 in the Trust Territories of the Pacific Islands and freely  
13 associated states of Micronesia, pursuant to the Compact  
14 of Free Association as authorized by Public Law 99-  
15 239: *Provided further*, That upon a determination by the  
16 Secretary of the Army that such action is beneficial for

1       SEC. 8012. None of the funds provided in this Act  
2 shall be available either to return any IOWA Class Battle-  
3 ships to the Naval Register, or to retain the logistical sup-  
4 port necessary for support of any IOWA Class Battleships  
5 in active service.

6       SEC. 8013. (a) The provisions of section 115(a)(4)  
7 of title 10, United States Code, shall not apply with re-  
8 spect to fiscal year 1996 or with respect to the appropria-  
9 tion of funds for that year.

10       (b) During fiscal year 1996, the civilian personnel of  
11 the Department of Defense may not be managed on the  
12 basis of any end-strength, and the management of such  
13 personnel during that fiscal year shall not be subject to  
14 any constraint or limitation (known as an end-strength)  
15 on the number of such personnel who may be employed  
16 on the last day of such fiscal year.

17       (c) The fiscal year 1997 budget request for the De-  
18 partment of Defense as well as all justification material  
19 and other documentation supporting the fiscal year 1997  
20 Department of Defense budget request shall be prepared  
21 and submitted to the Congress as if subsections (a) and  
22 (b) of this provision were effective with regard to fiscal  
23 year 1996.

24       SEC. 8014. Notwithstanding any other provision of  
25 law, none of the funds made available by this Act shall

1 be used by the Department of Defense to exceed, outside  
2 the fifty United States, its territories, and the District of  
3 Columbia, 125,000 civilian workyears: *Provided*, That  
4 workyears shall be applied as defined in the Federal Per-  
5 sonnel Manual: *Provided further*, That workyears ex-  
6 pended in dependent student hiring programs for dis-  
7 advantaged youths shall not be included in this workyear  
8 limitation.

9       SEC. 8015. None of the funds made available by this  
10 Act shall be used in any way, directly or indirectly, to in-  
11 fluence congressional action on any legislation or appro-  
12 priation matters pending before the Congress.

13       SEC. 8016. None of the funds appropriated by this  
14 Act, during the current fiscal year and hereafter, shall be  
15 obligated for the pay of any individual who is initially em-  
16 ployed after the date of enactment of this Act as a techni-  
17 cian in the administration and training of the Army Re-  
18 serve and the maintenance and repair of supplies issued  
19 to the Army Reserve unless such individual is also a mili-  
20 tary member of the Army Reserve troop program unit that  
21 he or she is employed to support. Those technicians em-  
22 ployed by the Army Reserve in areas other than Army Re-  
23 serve troop program units need only be members of the  
24 Selected Reserve.

1        SEC. 8017. Notwithstanding any other provision of  
2 law, during the current fiscal year and hereafter, the Sec-  
3 retaries of the Army and Air Force may authorize the re-  
4 tention in an active status until age sixty of any person  
5 who would otherwise be removed from an active status and  
6 who is employed as a National Guard or Reserve techni-  
7 cian in a position in which active status in a reserve com-  
8 ponent of the Army or Air Force is required as a condition  
9 of that employment.

10        SEC. 8018. (a) None of the funds appropriated by  
11 this Act shall be used to make contributions to the Depart-  
12 ment of Defense Education Benefits Fund pursuant to  
13 section 2006(g) of title 10, United States Code, represent-  
14 ing the normal cost for future benefits under section  
15 1415(c) of title 38, United States Code, for any member  
16 of the armed services who, on or after the date of enact-  
17 ment of this Act—

18            (1) enlists in the armed services for a period of  
19 active duty of less than three years; or

20            (2) receives an enlistment bonus under section  
21 308a or 308f of title 37, United States Code,

22 nor shall any amounts representing the normal cost of  
23 such future benefits be transferred from the Fund by the  
24 Secretary of the Treasury to the Secretary of Veterans  
25 Affairs pursuant to section 2006(d) of title 10, United

1 States Code; nor shall the Secretary of Veterans Affairs  
2 pay such benefits to any such member: *Provided*, That,  
3 in the case of a member covered by clause (1), these limi-  
4 tations shall not apply to members in combat arms skills  
5 or to members who enlist in the armed services on or after  
6 July 1, 1989, under a program continued or established  
7 by the Secretary of Defense in fiscal year 1991 to test  
8 the cost-effective use of special recruiting incentives in-  
9 volving not more than nineteen noncombat arms skills ap-  
10 proved in advance by the Secretary of Defense: *Provided*  
11 *further*, That this subsection applies only to active compo-  
12 nents of the Army.

13 (b) None of the funds appropriated by this Act shall  
14 be available for the basic pay and allowances of any mem-  
15 ber of the Army participating as a full-time student and  
16 receiving benefits paid by the Secretary of Veterans Af-  
17 fairs from the Department of Defense Education Benefits  
18 Fund when time spent as a full-time student is credited  
19 toward completion of a service commitment: *Provided*,  
20 That this subsection shall not apply to those members who  
21 have reenlisted with this option prior to October 1, 1987:  
22 *Provided further*, That this subsection applies only to ac-  
23 tive components of the Army.

24 SEC. 8019. Funds appropriated in this Act shall be  
25 available for the payment of not more than 75 percent

1 of the charges of a postsecondary educational institution  
2 for the tuition or expenses of an officer in the Ready Re-  
3 serve of the Army National Guard or Army Reserve for  
4 education or training during his off-duty periods, except  
5 that no part of the charges may be paid unless the officer  
6 agrees to remain a member of the Ready Reserve for at  
7 least four years after completion of such training or edu-  
8 cation.

9       SEC. 8020. None of the funds appropriated by this  
10 Act shall be available to convert to contractor performance  
11 an activity or function of the Department of Defense that,  
12 on or after the date of enactment of this Act, is performed  
13 by more than ten Department of Defense civilian employ-  
14 ees until a most efficient and cost-effective organization  
15 analysis is completed on such activity or function and cer-  
16 tification of the analysis is made to the Committees on  
17 Appropriations of the House of Representatives and the  
18 Senate: *Provided*, That this section shall not apply to a  
19 commercial or industrial type function of the Department  
20 of Defense that: (1) is included on the procurement list  
21 established pursuant to section 2 of the Act of June 25,  
22 1938 (41 U.S.C. 47), popularly referred to as the Javits-  
23 Wagner-O'Day Act; (2) is planned to be converted to per-  
24 formance by a qualified nonprofit agency for the blind or  
25 by a qualified nonprofit agency for other severely handi-

1 capped individuals in accordance with that Act; or (3) is  
2 planned to be converted to performance by a qualified firm  
3 under 51 percent Native American ownership.

4 SEC. 8021. Notwithstanding any other provision of  
5 law, the Secretary of the Navy may use funds appro-  
6 priated to charter ships to be used as auxiliary mine-  
7 sweepers providing that the owner agrees that these ships  
8 may be activated as Navy Reserve ships with Navy Re-  
9 serve crews used in training exercises conducted in accord-  
10 ance with law and policies governing Naval Reserve forces.

11 SEC. 8022. For the purposes of the Balanced Budget  
12 and Emergency Deficit Control Act of 1985 (Public Law  
13 99-177) as amended by the Balanced Budget and Emer-  
14 gency Deficit Control Reaffirmation Act of 1987 (Public  
15 Law 100-119) and by the Budget Enforcement Act of  
16 1990 (Public Law 101-508), the term program, project,  
17 and activity for appropriations contained in this Act shall  
18 be defined as the most specific level of budget items identi-  
19 fied in the Department of Defense Appropriations Act,  
20 1996, the accompanying House and Senate Committee re-  
21 ports, the conference report and accompanying joint ex-  
22 planatory statement of the managers of the Committee of  
23 Conference, the related classified annexes and reports, and  
24 the P-1 and R-1 budget justification documents as subse-

1 quently modified by Congressional action: *Provided*, That  
2 the following exception to the above definition shall apply:

3       For the Military Personnel and the Operation and  
4 Maintenance accounts, the term “program, project, and  
5 activity” is defined as the appropriations accounts con-  
6 tained in the Department of Defense Appropriations Act:  
7 *Provided further*, That at the time the President submits  
8 his budget for fiscal year 1997, the Department of De-  
9 fense shall transmit to the Committees on Appropriations  
10 and the Committees on Armed Services of the Senate and  
11 the House of Representatives a budget justification docu-  
12 ment to be known as the “O-1” which shall identify, at  
13 the budget activity, activity group, and subactivity group  
14 level, the amounts requested by the President to be appro-  
15 priated to the Department of Defense for operation and  
16 maintenance in any budget request, or amended budget  
17 request, for fiscal year 1997.

18       SEC. 8023. Of the funds made available by this Act  
19 in title III, Procurement, \$8,000,000, drawn pro rata  
20 from each appropriations account in title III, shall be  
21 available for incentive payments authorized by section 504  
22 of the Indian Financing Act of 1974, 25 U.S.C. 1544.  
23 These payments shall be available only to contractors  
24 which have submitted subcontracting plans pursuant to 15  
25 U.S.C. 637(d), and according to regulations which shall

1 be promulgated by the Secretary of Defense within 90  
2 days of the passage of this Act.

3 SEC. 8024. During the current fiscal year, none of  
4 the funds available to the Department of Defense may be  
5 used to procure or acquire (1) defensive handguns or de-  
6 fensive handgun ammunition unless such handguns or  
7 handgun ammunition are the M9 9mm Department of De-  
8 fense standard handgun or ammunition for such hand-  
9 guns, or (2) offensive handguns and ammunition except  
10 for the Special Operations Forces: *Provided*, That the  
11 foregoing shall not apply to handguns and ammunition for  
12 marksmanship competitions.

13 (TRANSFER OF FUNDS)

14 SEC. 8025. Notwithstanding any other provision of  
15 law, the Department of Defense may transfer prior year,  
16 unobligated balances and funds appropriated in this Act  
17 to the operation and maintenance appropriations for the  
18 purpose of providing military technician and Department  
19 of Defense medical personnel pay and medical programs  
20 (including CHAMPUS) the same exemption from seques-  
21 tration set forth in the Balanced Budget and Emergency  
22 Deficit Control Act of 1985 (Public Law 99-177) as  
23 amended by the Balanced Budget and Emergency Deficit  
24 Control Reaffirmation Act of 1987 (Public Law 100-119)  
25 and by the Budget Enforcement Act of 1990 (Public Law  
26 101-508) as that granted the other military personnel ac-

1 counts: *Provided*, That any transfer made pursuant to any  
2 use of the authority provided by this provision shall be  
3 limited so that the amounts reprogrammed to the oper-  
4 ation and maintenance appropriations do not exceed the  
5 amounts sequestered under the Balanced Budget and  
6 Emergency Deficit Control Act of 1985 (Public Law 99-  
7 177) as amended by the Balanced Budget and Emergency  
8 Deficit Control Reaffirmation Act of 1987 (Public Law  
9 100-119) and by the Budget Enforcement Act of 1990  
10 (Public Law 101-508): *Provided further*, That the author-  
11 ity to make transfers pursuant to this section is in addi-  
12 tion to the authority to make transfers under other provi-  
13 sions of this Act: *Provided further*, That the Secretary of  
14 Defense may proceed with such transfer after notifying  
15 the Appropriations Committees of the House of Rep-  
16 resentatives and the Senate twenty calendar days in ses-  
17 sion before any such transfer of funds under this provi-  
18 sion.

19 SEC. 8026. None of the funds available to the De-  
20 partment of the Navy may be used to enter into any con-  
21 tract for the overhaul, repair, or maintenance of any naval  
22 vessel homeported on the West Coast of the United States  
23 which includes charges for interport differential as an  
24 evaluation factor for award.

1       SEC. 8027. None of the funds appropriated by this  
2 Act available for the Civilian Health and Medical Program  
3 of the Uniformed Services (CHAMPUS) shall be available  
4 for the reimbursement of any health care provider for in-  
5 patient mental health service for care received when a pa-  
6 tient is referred to a provider of inpatient mental health  
7 care or residential treatment care by a medical or health  
8 care professional having an economic interest in the facil-  
9 ity to which the patient is referred: *Provided*, That this  
10 limitation does not apply in the case of inpatient mental  
11 health services provided under the program for the handi-  
12 capped under subsection (d) of section 1079 of title 10,  
13 United States Code, provided as partial hospital care, or  
14 provided pursuant to a waiver authorized by the Secretary  
15 of Defense because of medical or psychological cir-  
16 cumstances of the patient that are confirmed by a health  
17 professional who is not a Federal employee after a review,  
18 pursuant to rules prescribed by the Secretary, which takes  
19 into account the appropriate level of care for the patient,  
20 the intensity of services required by the patient, and the  
21 availability of that care.

22       SEC. 8028. Funds available in this Act may be used  
23 to provide transportation for the next-of-kin of individuals  
24 who have been prisoners of war or missing in action from  
25 the Vietnam era to an annual meeting in the United

1 States, under such regulations as the Secretary of Defense  
2 may prescribe.

3 SEC. 8029. Notwithstanding any other provision of  
4 law, funds available to the Department of Defense shall  
5 be made available to provide transportation of medical  
6 supplies and equipment, on a nonreimbursable basis, to  
7 American Samoa: *Provided*, That notwithstanding any  
8 other provision of law, funds available to the Department  
9 of Defense shall be made available to provide transpor-  
10 tation of medical supplies and equipment, on a  
11 nonreimbursable basis, to the Indian Health Service when  
12 it is in conjunction with a civil-military project.

13 SEC. 8030. Notwithstanding any other provision of  
14 law, during the current fiscal year, the Secretary of De-  
15 fense may, by Executive Agreement, establish with host  
16 nation governments in NATO member states a separate  
17 account into which such residual value amounts negotiated  
18 in the return of United States military installations in  
19 NATO member states may be deposited, in the currency  
20 of the host nation, in lieu of direct monetary transfers to  
21 the United States Treasury: *Provided*, That such credits  
22 may be utilized only for the construction of facilities to  
23 support United States military forces in that host nation,  
24 or such real property maintenance and base operating  
25 costs that are currently executed through monetary trans-

1   fers to such host nations: *Provided further*, That the De-  
2   partment of Defense's budget submission for fiscal year  
3   1997 shall identify such sums anticipated in residual value  
4   settlements, and identify such construction, real property  
5   maintenance or base operating costs that shall be funded  
6   by the host nation through such credits: *Provided further*,  
7   That all military construction projects to be executed from  
8   such accounts must be previously approved in a prior Act  
9   of Congress: *Provided further*, That each such Executive  
10  Agreement with a NATO member host nation shall be re-  
11  ported to the Committees on Appropriations and Armed  
12  Services of the House of Representatives and the Senate  
13  thirty days prior to the conclusion and endorsement of any  
14  such agreement established under this provision.

15       SEC. 8031. None of the funds available to the De-  
16  partment of Defense in this Act shall be used to demili-  
17  tarize or dispose of more than 310,784 unserviceable M-  
18  1 Garand rifles and M-1 Carbines.

19       SEC. 8032. Notwithstanding any other provision of  
20  law, none of the funds appropriated by this Act shall be  
21  available to pay more than 50 percent of an amount paid  
22  to any person under section 308 of title 37, United States  
23  Code, in a lump sum.

24       SEC. 8033. None of the funds appropriated during  
25  the current fiscal year and hereafter, may be used by the

1 Department of Defense to assign a supervisor's title or  
2 grade when the number of people he or she supervises is  
3 considered as a basis for this determination: *Provided*,  
4 That savings that result from this provision are rep-  
5 resented as such in future budget proposals.

6 SEC. 8034. Notwithstanding any other provision of  
7 law, each contract awarded by the Department of Defense  
8 in fiscal year 1996 for construction or service performed  
9 in whole or in part in a State which is not contiguous  
10 with another State and has an unemployment rate in ex-  
11 cess of the national average rate of unemployment as de-  
12 termined by the Secretary of Labor shall include a provi-  
13 sion requiring the contractor to employ, for the purpose  
14 of performing that portion of the contract in such State  
15 that is not contiguous with another State, individuals who  
16 are residents of such State and who, in the case of any  
17 craft or trade, possess or would be able to acquire prompt-  
18 ly the necessary skills: *Provided*, That the Secretary of De-  
19 fense may waive the requirements of this section in the  
20 interest of national security.

21 SEC. 8035. During the current fiscal year, funds ap-  
22 propriated or otherwise available for any Federal agency,  
23 the Congress, the judicial branch, or the District of Co-  
24 lumbia may be used for the pay, allowances, and benefits  
25 of an employee as defined by section 2105 of title 5 or

1 an individual employed by the government of the District  
2 of Columbia, permanent or temporary indefinite, who—

3 (1) is a member of a Reserve component of the  
4 Armed Forces, as described in section 261 of title  
5 10, or the National Guard, as described in section  
6 101 of title 32;

7 (2) performs, for the purpose of providing mili-  
8 tary aid to enforce the law or providing assistance  
9 to civil authorities in the protection or saving of life  
10 or property or prevention of injury—

11 (A) Federal service under section 331,  
12 332, 333, 3500, or 8500 of title 10, or other  
13 provision of law, as applicable, or

14 (B) full-time military service for his State,  
15 the District of Columbia, the Commonwealth of  
16 Puerto Rico, or a territory of the United States;  
17 and

18 (3) requests and is granted—

19 (A) leave under the authority of this sec-  
20 tion; or

21 (B) annual leave, which may be granted  
22 without regard to the provisions of sections  
23 5519 and 6323(b) of title 5, if such employee  
24 is otherwise entitled to such annual leave:

1 *Provided*, That any employee who requests leave under  
2 subsection (3)(A) for service described in subsection (2)  
3 of this section is entitled to such leave, subject to the pro-  
4 visions of this section and of the last sentence of section  
5 6323(b) of title 5, and such leave shall be considered leave  
6 under section 6323(b) of title 5.

7       SEC. 8036. None of the funds appropriated by this  
8 Act shall be available to perform any cost study pursuant  
9 to the provisions of OMB Circular A-76 if the study being  
10 performed exceeds a period of twenty-four months after  
11 initiation of such study with respect to a single function  
12 activity or forty-eight months after initiation of such study  
13 for a multi-function activity.

14       SEC. 8037. Funds appropriated by this Act for the  
15 American Forces Information Service shall not be used for  
16 any national or international political or psychological ac-  
17 tivities.

18       SEC. 8038. Notwithstanding any other provision of  
19 law or regulation, the Secretary of Defense may adjust  
20 wage rates for civilian employees hired for certain health  
21 care occupations as authorized for the Secretary of Veter-  
22 ans Affairs by section 7455 of title 38, United States  
23 Code.

24       SEC. 8039. Of the funds made available in this Act,  
25 not less than \$24,197,000 shall be available for the Civil

1 Air Patrol, of which \$14,259,000 shall be available for Op-  
2 eration and Maintenance.

3 SEC. 8040. None of the funds appropriated or made  
4 available in this Act shall be used to reduce or disestablish  
5 the operation of the 53rd Weather Reconnaissance Squad-  
6 ron of the Air Force Reserve, if such action would reduce  
7 the WC-130 Weather Reconnaissance mission below the  
8 levels funded in this Act.

9 SEC. 8041. (a) Of the funds for the procurement of  
10 supplies or services appropriated by this Act, qualified  
11 nonprofit agencies for the blind or other severely handi-  
12 capped shall be afforded the maximum practicable oppor-  
13 tunity to participate as subcontractors and suppliers in the  
14 performance of contracts let by the Department of De-  
15 fense.

16 (b) During the current fiscal year, a business concern  
17 which has negotiated with a military service or defense  
18 agency a subcontracting plan for the participation by  
19 small business concerns pursuant to section 8(d) of the  
20 Small Business Act (15 U.S.C. 637(d)) shall be given  
21 credit toward meeting that subcontracting goal for any  
22 purchases made from qualified nonprofit agencies for the  
23 blind or other severely handicapped.

24 (c) For the purpose of this section, the phrase “quali-  
25 fied nonprofit agency for the blind or other severely handi-

1 capped” means a nonprofit agency for the blind or other  
2 severely handicapped that has been approved by the Com-  
3 mittee for the Purchase from the Blind and Other Severely  
4 Handicapped under the Javits-Wagner-O’Day Act (41  
5 U.S.C. 46–48).

6 SEC. 8042. During the current fiscal year, net re-  
7 ceipts pursuant to collections from third party payers pur-  
8 suant to section 1095 of title 10, United States Code, shall  
9 be made available to the local facility of the uniformed  
10 services responsible for the collections and shall be over  
11 and above the facility’s direct budget amount.

12 SEC. 8043. Notwithstanding any other provision of  
13 law, of the funds appropriated for the Defense Health  
14 Program during this fiscal year and hereafter, the amount  
15 payable for services provided under this section shall not  
16 be less than the amount calculated under the coordination  
17 of benefits reimbursement formula utilized when  
18 CHAMPUS is a secondary payor to medical insurance  
19 programs other than Medicare, and such appropriations  
20 as necessary shall be available (notwithstanding the last  
21 sentence of section 1086(c) of title 10, United States  
22 Code) to continue Civilian Health and Medical Program  
23 of the Uniformed Services (CHAMPUS) benefits, until  
24 age 65, under such section for a former member of a uni-  
25 formed service who is entitled to retired or retainer pay

1 or equivalent pay, or a dependent of such a member, or  
2 any other beneficiary described by section 1086(c) of title  
3 10, United States Code, who becomes eligible for hospital  
4 insurance benefits under part A of title XVIII of the So-  
5 cial Security Act (42 U.S.C. 1395 et seq.) solely on the  
6 grounds of physical disability, or end stage renal disease:  
7 *Provided*, That expenses under this section shall only be  
8 covered to the extent that such expenses are not covered  
9 under parts A and B of title XVIII of the Social Security  
10 Act and are otherwise covered under CHAMPUS: *Pro-*  
11 *vided further*, That no reimbursement shall be made for  
12 services provided prior to October 1, 1991.

13 SEC. 8044. During the current fiscal year, the De-  
14 partment of Defense is authorized to incur obligations of  
15 not to exceed \$250,000,000 for purposes specified in sec-  
16 tion 2350j(c) of title 10, United States Code, in anticipa-  
17 tion of receipt of contributions, only from the Government  
18 of Kuwait, under that section: *Provided*, That, upon re-  
19 ceipt, such contributions from the Government of Kuwait  
20 shall be credited to the appropriation or fund which in-  
21 curred such obligations.

22 SEC. 8045. None of the unobligated balances avail-  
23 able in the National Defense Stockpile Transaction Fund  
24 during the current fiscal year may be obligated or ex-  
25 pended to finance any grant or contract to conduct re-

1 search, development, test and evaluation activities for the  
2 development or production of advanced materials, unless  
3 amounts for such purposes are specifically appropriated  
4 in a subsequent appropriations Act.

5 SEC. 8046. For the purposes of this Act, the term  
6 “congressional defense committees” means the National  
7 Security Committee of the House of Representatives, the  
8 Armed Services Committee of the Senate, the subcommit-  
9 tee on Defense of the Committee on Appropriations of the  
10 Senate, and the Subcommittee on National Security of the  
11 Committee on Appropriations of the House of Representa-  
12 tives.

13 SEC. 8047. Notwithstanding any other provision of  
14 law, during the current fiscal year, the Department of De-  
15 fense may acquire the modification, depot maintenance  
16 and repair of aircraft, vehicles and vessels as well as the  
17 production of components and other Defense-related arti-  
18 cles, through competition between Department of Defense  
19 depot maintenance activities and private firms: *Provided,*  
20 That the Senior Acquisition Executive of the military de-  
21 partment or defense agency concerned, with power of dele-  
22 gation, shall certify that successful bids include com-  
23 parable estimates of all direct and indirect costs for both  
24 public and private bids: *Provided further,* That Office of

1 Management and Budget Circular A-76 shall not apply  
2 to competitions conducted under this section.

3 SEC. 8048. None of the funds appropriated by this  
4 Act shall be used for the support of any nonappropriated  
5 funds activity of the Department of Defense that procures  
6 malt beverages and wine with nonappropriated funds for  
7 resale (including such alcoholic beverages sold by the  
8 drink) on a military installation located in the United  
9 States unless such malt beverages and wine are procured  
10 within that State, or in the case of the District of Colum-  
11 bia, within the District of Columbia, in which the military  
12 installation is located: *Provided*, That in a case in which  
13 the military installation is located in more than one State,  
14 purchases may be made in any State in which the installa-  
15 tion is located: *Provided further*, That such local procure-  
16 ment requirements for malt beverages and wine shall  
17 apply to all alcoholic beverages only for military installa-  
18 tions in States which are not contiguous with another  
19 State: *Provided further*, That alcoholic beverages other  
20 than wine and malt beverages, in contiguous States and  
21 the District of Columbia shall be procured from the most  
22 competitive source, price and other factors considered.

23 SEC. 8049. Appropriations contained in this Act that  
24 remain available at the end of the current fiscal year as  
25 a result of energy cost savings realized by the Department

1 of Defense shall remain available for obligation for the  
2 next fiscal year to the extent, and for the purposes, pro-  
3 vided in section 2865 of title 10, United States Code.

4 SEC. 8050. During the current fiscal year, voluntary  
5 separation incentives payable under 10 U.S.C. 1175 may  
6 be paid in such amounts as are necessary from the assets  
7 of the Voluntary Separation Incentive Fund established by  
8 section 1175(h)(1).

9 (INCLUDING TRANSFER OF FUNDS)

10 SEC. 8051. Amounts deposited during the current fis-  
11 cal year and hereafter to the special account established  
12 under 40 U.S.C. 485(h)(2) and to the special account es-  
13 tablished under 10 U.S.C. 2667(d)(1) are appropriated  
14 and shall be available until transferred by the Secretary  
15 of Defense to current applicable appropriations or funds  
16 of the Department of Defense under the terms and condi-  
17 tions specified by 40 U.S.C. 485(h)(2) (A) and (B) and  
18 10 U.S.C. 2667(d)(1)(B), to be merged with and to be  
19 available for the same time period and the same purposes  
20 as the appropriation to which transferred.

21 SEC. 8052. None of the funds in this or any other  
22 Act shall be available for the preparation of studies on—

23 (a) the feasibility of removal and transportation  
24 of unitary chemical weapons from the eight chemical  
25 storage sites within the continental United States to  
26 Johnston Atoll: *Provided*, That this prohibition shall

1 not apply to General Accounting Office studies re-  
2 quested by a Member of Congress or a Congres-  
3 sional Committee; and

4 (b) the potential future uses of the nine chemi-  
5 cal disposal facilities other than for the destruction  
6 of stockpile chemical munitions and as limited by  
7 section 1412(c)(2), Public Law 99-145: *Provided*,  
8 That this prohibition does not apply to future use  
9 studies for the CAMDS facility at Tooele, Utah.

10 SEC. 8053. During the current fiscal year, appropria-  
11 tions available to the Department of Defense may be used  
12 to reimburse a member of a reserve component of the  
13 Armed Forces who is not otherwise entitled to travel and  
14 transportation allowances and who occupies transient gov-  
15 ernment housing while performing active duty for training  
16 or inactive duty training: *Provided*, That such members  
17 may be provided lodging in kind if transient government  
18 quarters are unavailable as if the member was entitled to  
19 such allowances under subsection (a) of section 404 of title  
20 37, United States Code: *Provided further*, That if lodging  
21 in kind is provided, any authorized service charge or cost  
22 of such lodging may be paid directly from funds appro-  
23 priated for operation and maintenance of the reserve com-  
24 ponent of the member concerned.

1       SEC. 8054. For fiscal year 1996, the total amount  
2 appropriated to fund the Uniformed Services Treatment  
3 Facilities program, operated pursuant to section 911 of  
4 Public Law 97-99 (42 U.S.C. 248c), is limited to  
5 \$329,000,000, of which not more than \$300,000,000 may  
6 be provided by the funds appropriated by this Act.

7       SEC. 8055. Notwithstanding any other provision of  
8 law, the Naval shipyards of the United States shall be eli-  
9 gible to participate in any manufacturing extension pro-  
10 gram financed by funds appropriated in this or any other  
11 Act.

12       SEC. 8056. During the current fiscal year, amounts  
13 contained in the Department of Defense Overseas Military  
14 Facility Investment Recovery Account established by sec-  
15 tion 2921(c)(1) of the National Defense Authorization Act  
16 of 1991 (Public Law 101-510; 10 U.S.C. 2687 note) shall  
17 be available until expended for the payments specified by  
18 section 2921(c)(2) of that Act.

19       SEC. 8057. During the current fiscal year, annual  
20 payments granted under the provisions of section 4416 of  
21 the National Defense Authorization Act for Fiscal Year  
22 1993 (Public Law 102-428; 106 Stat. 2714) shall be  
23 made from appropriations in this Act which are available  
24 for the pay of reserve component personnel.

1        SEC. 8058. During the current fiscal year, appropria-  
2 tions available for the pay and allowances of active duty  
3 members of the Armed Forces shall be available to pay  
4 the retired pay which is payable pursuant to section 4403  
5 of Public Law 102-484 (10 U.S.C. 1293 note) under the  
6 terms and conditions provided in section 4403.

7        SEC. 8059. None of the funds provided in this Act  
8 shall be available for use by a Military Department to  
9 modify an aircraft, weapon, ship or other item of equip-  
10 ment, that the Military Department concerned plans to  
11 retire or otherwise dispose of within five years after com-  
12 pletion of the modification: *Provided*, That this prohibition  
13 shall not apply to safety modifications: *Provided further*,  
14 That this prohibition may be waived by the Secretary of  
15 a Military Department if the Secretary determines it is  
16 in the best national security interest of the United States  
17 to provide such waiver and so notifies the congressional  
18 defense committees in writing.

19        SEC. 8060. None of the funds appropriated by this  
20 Act for programs of the Central Intelligence Agency shall  
21 remain available for obligation beyond the current fiscal

24 ber 30, 1997.

1        SEC. 8061. Notwithstanding any other provision of  
2 law, funds made available in this Act for the Defense In-  
3 telligence Agency may be used for the design, develop-  
4 ment, and deployment of General Defense Intelligence  
5 Program intelligence communications and intelligence in-  
6 formation systems for the Services, the Unified and Speci-  
7 fied Commands, and the component commands.

8        SEC. 8062. (a) None of the funds appropriated or  
9 otherwise made available in this Act may be used to trans-  
10 port or provide for the transportation of chemical muni-  
11 tions to the Johnston Atoll for the purpose of storing or

13        (b) The prohibition in subsection (a) shall not apply

24 ization Act, 1986 and deposited to the special account es-  
25 tablished under subsection 1459(g)(2) of that Act are ap-

1 appropriated and shall be available until expended for the  
2 operation and maintenance of the Center as provided for  
3 in subsection 1459(g)(2).

4       SEC. 8064. None of the funds appropriated in this  
5 Act may be expended by an entity of the Department of  
6 Defense unless the entity, in expending the funds, com-  
7 plies with the Buy American Act. For purposes of this  
8 subsection, the term “Buy American Act” means title III  
9 of the Act entitled “An Act making appropriations for the  
10 Treasury and Post Office Departments for the fiscal year  
11 ending June 30, 1934, and for other purposes”, approved

1 *vided*, That the total contingent liability of the United  
2 States for guarantees issues under the authority of this  
3 section may not exceed \$15,000,000,000: *Provided further*,  
4 That the Secretary shall provide quarterly reports to the  
5 Committees on Appropriations, Armed Services and For-  
6 eign Relations of the Senate and the Committees of Ap-  
7 propriations, National Security and International Rela-  
8 tions in the House of Representatives on the implementa-  
9 tion of this program.

10 SEC. 8068. Funds appropriated by this Act for intel-  
11 ligence activities are deemed to be specifically authorized  
12 by the Congress for purposes of section 504 of the Na-  
13 tional Security Act of 1947 (50 U.S.C. 414) during fiscal  
14 year 1996 until the enactment of the Intelligence Author-  
15 ization Act for fiscal year 1996.

16 SEC. 8069. None of the funds provided in this Act  
17 may be obligated or expended for the sale of zinc in the  
18 National Defense Stockpile if zinc commodity prices de-  
19 cline more than five percent below the London Metals Ex-  
20 change market price reported on the date of enactment  
21 of this Act.

22 SEC. 8070. During the current fiscal year, funds ap-  
23 propriated in this Act are available to compensate mem-  
24 bers of the National Guard for duty performed pursuant  
25 to a plan submitted by a Governor of a State and approved

1 by the Secretary of Defense under section 112 of title 32,  
2 United States Code: *Provided*, That during the perform-  
3 ance of such duty, the members of the National Guard  
4 shall be under State command and control: *Provided fur-*  
5 *ther*, That such duty shall be treated as full-time National  
6 Guard duty for purposes of sections 3686(2) and 8686(2)  
7 of title 10, United States Code.

8       SEC. 8071. Funds appropriated in this Act for oper-  
9 ation and maintenance of the Military Departments, Uni-  
10 fied and Specified Commands and Defense Agencies shall  
11 be available for reimbursement of pay, allowances, and  
12 other expenses which would otherwise be incurred against
