A BILL

To make certain technical corrections in laws relating to
Native Americans, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CORRECTION TO POKAGON RESTORATION ACT.**

4 Section 9 of the Act entitled “An Act to restore Fed-
5 eral services to the Pokagon Band of Potawatomi Indians”

6 (25 U.S.C. 1300j–7a) is amended—

1 (1) by striking “Bands” each place it appears
2 and inserting “Band”;

3 (2) in subsection (a), by striking “respective”;
4 and

5 (3) in subsection (b)—

6 (A) in paragraph (1)—

7 (i) in the first sentence—

8 (I) by striking “membership rolls
9 that contain” and inserting “a mem-
10 bership roll that contains”; and

11 (II) by striking “in such” and in-
12 sserting “in the”; and

13 (ii) in the second sentence, by striking
14 “Each such” and inserting “The”;

15 (B) in paragraph (2), by striking “rolls”
16 both places it appears and inserting “roll”;

17 (C) in the heading for paragraph (3), by
18 striking “ROLLS” and inserting “ROLL”; and

19 (D) in paragraph (3), by striking “rolls are
20 maintained” and inserting “roll is maintained”.

21 **SEC. 2. CORRECTION TO ODAWA AND OTTAWA RESTORA-**
22 **TION ACT.**

23 Section 9 of the Little Traverse Bay Bands of Odawa
24 and the Little River Band of Ottawa Indians Act (25
25 U.S.C. 1300k-7) is amended—

1 (1) in subsection (a)—

2 (A) by striking “Band” the first place it
3 appears and inserting “Bands”; and

4 (B) by striking “the Band.” and inserting
5 “the respective Bands.”; and

6 (2) in subsection (b)(1)—

7 (A) in the first sentence, by striking
8 “Band” both places it appears and inserting
9 “Bands”; and

10 (B) in the second sentence, by striking
11 “The Band, in consultation” and inserting
12 “Each such Band, in consultation”.

13 **SEC. 3. FEDERAL EMPLOYEES CONTRACTING OR TRADING**
14 **WITH INDIANS.**

15 (a) REPEAL.—Section 437 of title 18, United States
16 Code, is repealed.

17 (b) CONFORMING AMENDMENT.—The table of sec-
18 tions at the beginning of chapter 23 of title 18, United
19 States Code, is amended by striking the item relating to
20 section 437.

21 (c) EFFECTIVE DATE.—The repeal made by sub-
22 section (a) shall—

23 (1) take effect on the date of enactment of this
24 Act; and

1 (2) apply with respect to any contract obtained,
2 and any purchase or sale occurring, on or after the
3 date of enactment of this Act.
