## A BILL

To authorize the Alpha Phi Alpha Fraternity to establish a memorial to Martin Luther King, Jr., in the District of Columbia, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. MARTIN LUTHER KING, JR., MEMORIAL.**

2 (a) IN GENERAL.—

3 (1) ESTABLISHMENT.—Subject to subsection  
4 (b), the Alpha Phi Alpha Fraternity is authorized to  
5 establish a memorial to Martin Luther King, Jr., in  
6 the District of Columbia and its environs in accord-  
7 ance with the Act entitled “An Act to provide stand-  
8 ards for placement of commemorative works on cer-  
9 tain Federal lands in the District of Columbia and  
10 its environs, and for other purposes”, approved No-  
11 vember 14, 1986 (40 U.S.C. 1001 et seq.), to honor  
12 Martin Luther King, Jr.

13 (2) DEFINITION.—For purposes of paragraph  
14 (1), the term “the District of Columbia and its envi-  
15 rons” has the same meaning given to the term by  
16 section 2(e) of the Act (40 U.S.C. 1002(e)).

17 (b) NO EXPENSE TO THE UNITED STATES.—The  
18 United States shall not pay any of the expenses of estab-  
19 lishing the memorial under subsection (a).
