## CONCURRENT RESOLUTION

Directing the President pursuant to section 5(c) of the War Powers Resolution to remove United States Armed Forces from the Republic of Bosnia and Herzegovina.

1        *Resolved by the House of Representatives (the Senate*  
2        *concurring),*

1 **SECTION 1. REMOVAL OF UNITED STATES ARMED FORCES**  
2 **FROM THE REPUBLIC OF BOSNIA AND**  
3 **HERZEGOVINA.**

4 (a) FINDINGS.—The Congress finds the following:

5 (1) The Congress has the sole power to declare  
6 war under article I, section 8, of the Constitution.

7 (2) A state of war has not been declared to  
8 exist with respect to the situation in the Republic of  
9 Bosnia and Herzegovina.

10 (3) A specific authorization for the use of  
11 United States Armed Forces with respect to the sit-  
12 uation in the Republic of Bosnia and Herzegovina  
13 has not been enacted.

14 (4) The situation in the Republic of Bosnia and  
15 Herzegovina constitutes, within the meaning of sec-  
16 tion 4(a)(1) of the War Powers Resolution (50  
17 U.S.C. 1543(a)(1)), either hostilities or a situation  
18 where imminent involvement in hostilities is clearly  
19 indicated by the circumstances into which United  
20 States Armed Forces have been introduced.

21 (b) REMOVAL OF ARMED FORCES.—Pursuant to sec-  
22 tion 5(e) of the War Powers Resolution (50 U.S.C.  
23 1544(e)), the Congress hereby directs the President to re-  
24 move United States Armed Forces from the Republic of  
25 Bosnia and Herzegovina by June 30, 1998 (unless the  
26 President requests and the Congress authorizes a later

1 date), except for a limited number of members of the  
2 Armed Forces sufficient only to protect United States dip-  
3 lomatic facilities and citizens, and noncombatant person-  
4 nel to advise the North Atlantic Treaty Organization  
5 (NATO) Commander in the Republic of Bosnia and  
6 Herzegovina, and unless and until a declaration of war  
7 or specific authorization for such use of United States  
8 Armed Forces has been enacted.

9       (c) DECLARATION OF POLICY.—The requirement to  
10 remove United States Armed Forces from the Republic of  
11 Bosnia and Herzegovina under subsection (b) does not  
12 necessarily reflect any disagreement with the purposes or  
13 accomplishments of such Armed Forces, nor does it con-  
14 stitute any judgment of how the Congress would vote, if  
15 given the opportunity to do so, on either a declaration of  
16 war or a specific authorization for the use of such Armed  
17 Forces.
