A BILL

To amend title 38, United States Code, to extend the authority of the Secretary of Veterans Affairs to enter into enhanced-use leases for Department of Veterans Affairs property, to rename the United States Court of Veterans Appeals and the National Cemetery System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REFERENCES TO TITLE 38, UNITED STATES**
4 **CODE.**

5 Except as otherwise expressly provided, whenever in
6 this Act an amendment or repeal is expressed in terms

1 of an amendment to, or repeal of, a section or other provi-
 2 sion, the reference shall be considered to be made to a
 3 section or other provision of title 38, United States Code.

4 **TITLE I—ENHANCED-USE**
 5 **LEASES OF DEPARTMENT OF**
 6 **VETERANS AFFAIRS REAL**
 7 **PROPERTY**

8 **SEC. 101. EXPANSION OF AUTHORITY FOR ENHANCED-USE**
 9 **LEASES OF DEPARTMENT OF VETERANS AF-**
 10 **FAIRS REAL PROPERTY.**

11 (a) FIVE-YEAR EXTENSION OF AUTHORITY.—Sec-
 12 tion 8169 is amended by striking out “December 31,
 13 1997” and inserting in lieu thereof “December 31, 2002”.

14 (b) REPEAL OF LIMITATION ON NUMBER OF AGREE-
 15 MENTS.—(1) Section 8168 is repealed.

16 (2) The table of sections at the beginning of chapter
 17 81 is amended by striking out the item relating to section
 18 8168.

19 **TITLE II—RENAMING**
 20 **PROVISIONS**

21 **SEC. 201. RENAMING OF THE COURT OF VETERANS AP-**
 22 **PEALS.**

23 (a) IN GENERAL.—(1) The United States Court of
 24 Veterans Appeals shall hereafter be known and designated

1 as the United States Court of Appeals for Veterans
2 Claims.

3 (2) Section 7251 is amended by striking out “United
4 States Court of Veterans Appeals” and inserting in lieu
5 thereof “United States Court of Appeals for Veterans
6 Claims”.

7 (b) CONFORMING AMENDMENTS.—

8 (1) The following sections are amended by
9 striking out “Court of Veterans Appeals” each place
10 it appears and inserting in lieu thereof “Court of

21 **SEC. 202. REDESIGNATION OF NATIONAL CEMETERY SYS-
22 TEM.**

23 (a) REDESIGNATION AS NATIONAL CEMETERY AD-
24 MINISTRATION.—(1) The National Cemetery System of
25 the Department of Veterans Affairs shall hereafter be

1 known and designated as the National Cemetery Adminis-
2 tration. The position of Director of the National Cemetery
3 System is hereby redesignated as Assistant Secretary of
4 Veterans Affairs for Memorial Affairs.

5 (2) Section 301(c)(4) is amended by striking out
6 “National Cemetery System” and inserting in lieu thereof
7 “National Cemetery Administration”.

8 (3) Section 307 of such title is amended—

9 (A) in the first sentence, by striking out “a Di-
10 rector of the National Cemetery System” and insert-
11 ing in lieu thereof “an Assistant Secretary for Me-
12 morial Affairs”; and

13 (B) in the second sentence, by striking out
14 “The Director” and all that follows through “Na-
15 tional Cemetery System” and inserting in lieu there-
16 of “The Assistant Secretary is the head of the Na-
17 tional Cemetery Administration”.

18 (b) CONFORMING AMENDMENTS.—

7 under the control of the National Cemetery Ad-
8 ministration”; and

23 States to the National Cemetery System shall be
24 deemed to be a reference to the National Cemetery
25 Administration.

1 (2) Any reference in a law, map, regulation,
2 document, paper, or other record of the United
3 States to the Director of the National Cemetery Sys-
4 tem shall be deemed to be a reference to the Assist-
5 ant Secretary of Veterans Affairs for Memorial Af-
6 fairs.

7 (d) INITIAL APPOINTMENT.—The initial appointment
8 of an individual to the position of Assistant Secretary of
9 Veterans Affairs for Memorial Affairs may be made by
10 the President alone if the individual appointed is the indi-
11 vidual who was serving as the Director of the National
12 Cemetery System on the day before the date of the enact-
13 ment of this Act.

12 (2) in subsection (a)(2), by striking out “\$169”
 13 and inserting in lieu thereof “\$182”;

¹If the veteran served as sergeant major of the Army, senior enlisted advisor of the Navy, chief master sergeant of the Air Force, sergeant major of the Marine Corps, or master chief petty officer of the Coast Guard, at the applicable time designated by section 1302 of this title, the surviving spouse's rate shall be \$1,023.

²If the veteran served as Chairman or Vice-Chairman of the Joint Chiefs of Staff, Chief of Staff of the Army, Chief of Naval Operations, Chief of Staff of the Air Force, Commandant of the Marine Corps, or Commandant of the Coast Guard, at the applicable time designated by section 1302 of this title, the surviving spouse's rate shall be \$1,902.”;
