A BILL

To provide for an increase in funding for programs for the prevention and treatment of substance abuse in the Federal prison system.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. INCREASED FUNDING FOR PREVENTION AND**
2 **TREATMENT OF SUBSTANCE ABUSE IN FED-**
3 **ERAL PRISON SYSTEM.**

4 (a) **IN GENERAL.**—In carrying out section 4005 of
5 title 18, United States Code, the Attorney General (acting
6 through the Director of the Bureau of Prisons), in collabo-
7 ration with the Secretary of Health and Human Services
8 (acting through the Administrator of the Health Re-
9 sources and Services Administration), shall carry out a
10 program for the prevention and treatment of substance
11 abuse among individuals who are in Federal penal or cor-
12 rectional institutions and in the criminal custody of the
13 Attorney General.

14 (b) **SPECIAL CONSIDERATION IN PROVISION OF**
15 **TREATMENT.**—In providing treatment under subsection
16 (a), the officials specified in such subsection shall give spe-
17 cial consideration to individuals whose terms of criminal
18 custody are within 12 months of completion.

19 **SEC. 2. AUTHORIZATION OF APPROPRIATIONS.**

20 For the purpose of carrying out section 1, there are
21 authorized to be appropriated \$250,000,000 for fiscal year
22 1998, and such sums as may be necessary for each of the
23 fiscal years 1999 through 2002. Such authorization is in
24 addition to any other authorization of appropriations that
25 is available for such purpose.
