1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. BOUNDARY ADJUSTMENT, DEVILS BACKBONE**  
4                   **WILDERNESS, MARK TWAIN NATIONAL FOR-**  
5                   **EST, MISSOURI.**

6       The boundary of the Devils Backbone Wilderness es-  
7 tablished by section 201(d) of Public Law 96–560 (16  
8 U.S.C. 1132 note) in the Mark Twain National Forest,  
9 Missouri, is hereby modified to exclude from the area en-  
10 compassed by the Devils Backbone Wilderness a parcel of  
11 real property consisting of approximately two acres in  
12 Ozark County, Missouri, and containing a garage, well,  
13 mailbox, driveway, and other improvements, as depicted  
14 on a map entitled “Devils Backbone Wilderness Boundary  
15 Modification”, dated June 1996. The map shall be re-  
16 tained with other Forest Service maps and legal descrip-  
17 tions regarding the Devils Backbone Wilderness and shall  
18 be made available for public inspection as provided in sec-  
19 tion 202 of Public Law 96–560 (94 Stat. 3274).
