## A BILL

To amend section 304 of the Tariff Act of 1930 to require the marking of frozen produce with the country of origin on the front panel of the package for retail sale.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. MARKING OF FROZEN PRODUCE.**

4 (a) IN GENERAL.—Section 304 of the Tariff Act of  
5 1930 (19 U.S.C. 1304) is amended—

1           (1) by redesignating subsections (h) through (k)  
2 as subsections (i) through (l), respectively; and

3           (2) by inserting after subsection (g) the follow-  
4 ing new subsection:

5           “(h) FROZEN PRODUCE.—

6           “(1) MARKING OF FROZEN PRODUCE.—Unless  
7 otherwise excepted under paragraph (3) of sub-  
8 section (a), frozen produce shall be marked, on the  
9 front panel of its package for retail sale, with the  
10 country of origin of the produce in permanent, indel-  
11 ible, and clearly legible print or type.

12           “(2) DEFINITIONS.—As used in this subsection:

13           “(A) FROZEN PRODUCE.—The term ‘fro-  
14 zen produce’ means—

15           “(i) frozen vegetables or mixtures of  
16 frozen vegetables provided for in chapter 7  
17 of the Harmonized Tariff Schedule of the  
18 United States; and

19           “(ii) frozen fruits or mixtures of fro-  
20 zen fruits provided for in chapter 8 of such  
21 Schedule.

22           “(B) FRONT PANEL.—The ‘front panel’ of  
23 a package is that part of the package that is  
24 most likely to be displayed, presented, shown,

1           or examined by the ultimate purchaser under  
2           customary conditions of display for retail sale.”.

3           (b) CONFORMING AMENDMENT.—Section 304(j) of  
4 such Act, as redesignated by subsection (a)(1), is amended  
5 by striking “subsection (h)” and inserting “subsection  
6 (i)”.

7 **SEC. 2. EFFECTIVE DATE.**

8           The amendments made by section 1 apply to goods  
9 entered, or withdrawn from warehouse for consumption,  
10 after the end of the 18-month period beginning on the date  
11 of the enactment of this Act.
