## A BILL

To amend the Controlled Substances Act to provide a mandatory life penalty for certain offenses involving methamphetamine.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Speed Trafficking Life  
3 in Prison Act of 1997”.

4 **SEC. 2. MANDATORY LIFE PENALTY FOR CERTAIN METH-**  
5 **AMPHETAMINE OFFENSES.**

6 (a) IN GENERAL.—Section 401 of the Controlled  
7 Substances Act (21 U.S.C. 841) is amended—

8 (1) by striking clause (viii) of subsection  
9 (b)(1)(A);

10 (2) by striking clause (viii) of subsection  
11 (b)(1)(B); and

12 (3) by adding at the end of subsection (b) the  
13 following:

14 “(h) Whoever engages in a violation of subsection (a)  
15 involving methamphetamine, its salts, isomers, or salts of  
16 its isomers shall be fined not more than \$8,000,000 (if  
17 an individual) or \$20,000,000 (if other than an individual)  
18 and shall be imprisoned for life, unless the death penalty  
19 is imposed.”.

20 (b) CONFORMING AMENDMENTS.—

21 (1) CIVIL PENALTY.—Section 405(a) of the  
22 Controlled Substances Act (21 U.S.C. 844a) is  
23 amended by inserting “or described in section  
24 401(h),” after “401(b)(1)(A)”.

1           (2) CONTINUING CRIMINAL ENTERPRISE.—Sec-  
2           tion 408 of the Controlled Substances Act (21  
3           U.S.C. 848) is amended—

4                   (A) in subsection (b)(2)(A), by inserting  
5                   “a substance described in section 401(h) or”  
6                   after “involved”;

7                   (B) in subsection (b)(2)(B), by inserting  
8                   “a substance described in section 401(h) or”  
9                   after “distribution of”; and

10                   (C) in subsection (e)(1)(A), by inserting  
11                   “section 841(h),” after “punishable under”.
