To authorize major medical facility projects and major medical facility leases for the Department of Veterans Affairs for fiscal year 1998, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. AUTHORIZATION OF MAJOR MEDICAL FACILITY**
2 **PROJECTS.**

3 The Secretary of Veterans Affairs may carry out the
4 following major medical facility projects, with each project
5 to be carried out in the amount specified for that project:

6 (1) Seismic corrections at the Department of
7 Veterans Affairs medical center in Memphis, Ten-
8 nessee, in an amount not to exceed \$34,600,000.

9 (2) Seismic corrections and clinical and other
10 improvements to the McClellan Hospital at Mather
11 Field, Sacramento, California, in an amount not to
12 exceed \$48,000,000, to be derived only from funds
13 appropriated for Construction, Major Projects, for a
14 fiscal year before fiscal year 1998 that remain avail-
15 able for obligation.

16 (3) Outpatient improvements at Mare Island,
17 Vallejo, California, and Martinez, California, in a
18 total amount not to exceed \$7,000,000, to be derived
19 only from funds appropriated for Construction,
20 Major Projects, for a fiscal year before fiscal year
21 1998 that remain available for obligation.

22 **SEC. 2. AUTHORIZATION OF MAJOR MEDICAL FACILITY**
23 **LEASES.**

24 The Secretary of Veterans Affairs may enter into
25 leases for medical facilities as follows:

1 (1) Lease of an information management field
2 office, Birmingham, Alabama, in an amount not to
3 exceed \$595,000.

4 (2) Lease of a satellite outpatient clinic, Jack-
5 sonville, Florida, in an amount not to exceed
6 \$3,095,000.

7 (3) Lease of a satellite outpatient clinic, Bos-
8 ton, Massachusetts, in an amount not to exceed
9 \$5,215,000.

10 (4) Lease of a satellite outpatient clinic, Can-
11 ton, Ohio, in an amount not to exceed \$2,115,000.

12 (5) Lease of a satellite outpatient clinic, Port-
13 land, Oregon, in an amount not to exceed
14 \$1,919,000.

15 (6) Lease of a satellite outpatient clinic, Tulsa,
16 Oklahoma, in an amount not to exceed \$2,112,000.

17 (7) Lease of an information resources manage-
18 ment field office, Salt Lake City, in an amount not
19 to exceed \$652,000.

20 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

21 (a) IN GENERAL.—There are authorized to be appro-
22 priated to the Secretary of Veterans Affairs for fiscal year
23 1998—

1 (1) for the Construction, Major Projects, ac-
2 count, \$34,600,000 for the project authorized in sec-
3 tion 1(1); and

4 (2) for the Medical Care account, \$15,703,000
5 for the leases authorized in section 2.

6 (b) LIMITATION.—The projects authorized in section
7 1 may only be carried out using—

8 (1) funds appropriated for fiscal year 1998 pur-
9 suant to the authorization of appropriations in sub-
10 section (a);

11 (2) funds appropriated for Construction, Major
12 Projects for a fiscal year before fiscal year 1998 that
13 remain available for obligation; and

14 (3) funds appropriated for Construction, Major
15 Projects for fiscal year 1998 for a category of activ-
16 ity not specific to a project.
