 3 **SEC. 101. REVIEW OF PROTESTS AGAINST DECISIONS OF**
 4 **CUSTOMS SERVICE.**

5 (a) IN GENERAL.—Section 515(a) of the Tariff Act
 6 of 1930 (19 U.S.C. 1515(a)) is amended by inserting after
 7 the third sentence the following: “Within 30 days from
 8 the date an application for further review is filed, the ap-
 9 propriate customs officer shall allow or deny the applica-
 10 tion and, if allowed, the protest shall be forwarded to the
 11 customs officer who will be conducting the further re-
 12 view.”.

13 (b) EFFECTIVE DATE.—The amendment made by
 14 subsection (a) shall apply with respect to applications for
 15 further review filed on or after the date of the enactment
 16 of this Act.

17 **SEC. 102. FINISHED PETROLEUM DERIVATIVES DRAWBACK.**

18 The Secretary of the Treasury shall convene a work-
 19 ing group of interested parties and, not later than March
 20 31, 1998, publish regulations and, if necessary, submit
 21 legislation to the Congress, to modify and simplify the

1 processing of finished petroleum derivatives drawback
2 claims.

3 **SEC. 103. DRAWBACK AND REFUND OF PACKAGING MATE-**
