## A BILL

To redesignate Washington National Airport as “Ronald  
Reagan Washington National Airport”.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REDESIGNATION.**

4       The airport located in Alexandria, Virginia, and  
5 known as Washington National Airport, shall be known  
6 and designated as the “Ronald Reagan Washington Na-  
7 tional Airport”.

8 **SEC. 2. REFERENCES.**

9       Any reference in a law, map, regulation, document,  
10 paper, or other record of the United States to the airport  
11 referred to in section 1 shall be deemed to be a reference  
12 to the “Ronald Reagan Washington National Airport”.

13 **SECTION 1. REDESIGNATION.**

14       *The airport described in the Act entitled “An Act to*  
15 *provide for the administration of the Washington National*  
16 *Airport, and for other purposes”, approved June 29, 1940*  
17 *(Chapter 444; 54 Stat. 686), and known as the Washington*

1 *National Airport, shall hereafter be known and designated*  
2 *as the “Ronald Reagan National Airport”.*

3 **SEC. 2. REFERENCES.**

4 *(a) IN GENERAL.—(1) The following provisions of law*  
5 *are amended by striking “Washington National Airport”*  
6 *each place it appears and inserting “Ronald Reagan Na-*  
7 *tional Airport”:*

8 *(A) Section 1(b) of the Act of June 29, 1940*  
9 *(Chapter 444; 54 Stat. 686).*

10 *(B) Sections 106 and 107 of the Act of October*  
11 *31, 1945 (Chapter 443; 59 Stat. 553).*

12 *(C) Section 41714 of title 49, United States*  
13 *Code.*

14 *(D) Chapter 491 of title 49, United States Code.*

15 *(2) Section 41714(d) of title 49, United States Code,*  
16 *is amended in the subsection heading by striking “WASH-*  
17 *INGTON NATIONAL AIRPORT” and inserting “RONALD*  
18 *REAGAN NATIONAL AIRPORT”.*

19 *(b) OTHER REFERENCES.—Any reference in a law,*  
20 *map, regulation, document, paper, or other record of the*  
21 *United States to the Washington National Airport shall be*  
22 *deemed to be a reference to the “Ronald Reagan National*  
23 *Airport”.*

Amend the title so as to read as follows: “A bill to  
rename the Washington National Airport located in the

District of Columbia and Virginia as the ‘Ronald Reagan National Airport’.”.
