A BILL

To provide for the transfer of public lands to certain California Indian Tribes.

- 1 *Be it enacted by the Senate and House of Representa-*
- 2 *tives of the United States of America in Congress assembled,*
- 3 **SECTION 1. SHORT TITLE.**
- 4 *This Act may be cited as the “California Indian Land*
- 5 *Transfer Act”.*

1 **SEC. 2. LANDS HELD IN TRUST FOR VARIOUS TRIBES OF**
 2 **CALIFORNIA INDIANS.**

3 (a) *IN GENERAL.*—Subject to valid existing rights, all
 4 right, title, and interest of the United States in and to the
 5 lands, including improvements and appurtenances, de-
 6 scribed in a paragraph of subsection (b) in connection with
 7 the respective tribe, band, or group of Indians named in
 8 such paragraph are hereby declared to be held in trust by
 9 the United States for the benefit of such tribe, band, or
 10 group.

11 (b) *LANDS DESCRIBED.*—The lands described in this
 12 subsection, comprising approximately 3525.8 acres, and the
 13 respective tribe, band, or group, are as follows:

14 **SEC. 3. MISCELLANEOUS PROVISIONS.**

15 (a) *PROCEEDS FROM RENTS AND ROYALTIES TRANS-*
 16 *FERRED TO INDIANS.—Amounts which accrue to the United*
 17 *States after the date of the enactment of this Act from sales,*
 18 *bonuses, royalties, and rentals relating to any land de-*
 19 *scribed in section 2 shall be available for use or obligation,*
 20 *in such manner and for such purposes as the Secretary may*
 21 *approve, by the tribe, band, or group of Indians for whose*
 22 *benefit such land is taken into trust.*

23 (b) *NOTICE OF CANCELLATION OF GRAZING PREF-*
 24 *ERENCES.—Grazing preferences on lands described in sec-*

1 tion 2 shall terminate 2 years after the date of the enact-
2 ment of this Act.

3 (c) LAWS GOVERNING LANDS TO BE HELD IN
4 TRUST.—Any lands which are to be held in trust for the
5 benefit of any tribe, band, or group of Indians pursuant
6 to this Act shall be added to the existing reservation of the
7 tribe, band, or group, and the official boundaries of the res-
8 ervation shall be modified accordingly. These lands shall be
9 subject to the laws of the United States relating to Indian
10 land in the same manner and to the same extent as other
11 lands held in trust for such tribe, band, or group on the
12 day before the date of enactment of this Act.
