Mr. TRAFICANT introduced the following bill; which was referred to the Committee on National Security

A BILL

To authorize certain military construction projects for fiscal year 1999 for the 910th Airlift Wing at Youngstown, Ohio.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AUTHORIZED AIR FORCE CONSTRUCTION**

4 **PROJECTS, YOUNGSTOWN, OHIO.**

5 (a) PROJECT AUTHORIZATIONS.—Using amounts ap-
6 propriated pursuant to the authorization of appropriations
7 in subsection (b), the Secretary of the Air Force may carry
8 out military construction projects for the 910th Airlift
9 Wing, Youngstown Air Reserve Station, Youngstown,
10 Ohio, in the amounts shown, as follows:

1 (1) For an Apron Runoff/Deicing Facility
2 (project number 98–9003), \$3,080,000, of which
3 \$280,000 is for design and \$2,800,000 is for con-
4 struction.

5 (2) For a Regional Dirt Shortfield Runway and
6 Support Facilities (project number 91–0023),
7 \$5,190,000, of which \$290,000 is for design and
8 \$4,900,000 is for construction.

9 (3) For Phase 1 of a Regional Lodging/Con-
10 ference Facility (project number 99–9009),
11 \$10,800,000, of which \$900,000 is for design and
12 \$9,900,000 is for construction.

13 (4) For Phase 2 of a Regional Lodging/Con-
14 ference Facility (project number 00–9007),
15 \$8,700,000, of which \$700,000 is for design and
16 \$8,000,000 is for construction.

17 (5) For a Regional Mobility Training and Sim-
18 ulator Center (project number 01–9005),
19 \$10,400,000, of which \$900,000 is for design and
20 \$9,500,000 is for construction.

21 (6) For a Consolidated Engineering Complex
22 (project number 99–9007), \$13,000,000, of which
23 \$1,000,000 is for design and \$12,000,000 is for con-
24 struction.

1 (b) AUTHORIZATION OF APPROPRIATIONS.—There is
2 hereby authorized to be appropriated for military con-
3 struction for the Air Force for fiscal years beginning after
4 September 30, 1998, for the projects authorized by sub-
5 section (a) the amount of \$51,170,000.
