## A BILL

To amend section 507 of the Omnibus Parks and Public Land Management Act of 1996 to provide additional funding for the preservation and restoration of historic buildings and structures at historically black colleges and universities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. ADDITIONAL FUNDING FOR BUILDINGS AND**  
2 **STRUCTURES AT HISTORICALLY BLACK COL-**  
3 **LEGES AND UNIVERSITIES.**

4 Subsection (d) of section 507 of the Omnibus Parks  
5 and Public Land Management Act of 1996 (16 U.S.C.  
6 470a note; 110 Stat. 4156) is amended to read as follows:

7 “(d) FUNDING.—For fiscal years beginning after fis-  
8 cal year 1998 \$377,500,000 shall be made available pur-  
9 suant to section 108 of the National Historic Preservation  
10 Act to carry out the purposes of this section. In addition  
11 to other funds covered into the Historic Preservation  
12 Fund under section 108 of the National Historic Preserva-  
13 tion Act or under any other authority of law, there is au-  
14 thorized to be appropriated to such Fund \$377,500,000  
15 for fiscal years beginning after fiscal year 1998.”.
