Mr. TRAFICANT introduced the following bill; which was referred to the Committee on Transportation and Infrastructure

A BILL

To provide for the installation of enhanced vision technologies to replace and enhance conventional lighting systems with respect to airport improvement projects.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Airport Safety Act”.

5 **SEC. 2. REGULATIONS REQUIRING INSTALLATION OF EN-**

6 **HANCED VISUAL TECHNOLOGIES AT AIR-**

7 **PORTS.**

8 Not later than 365 days after the date of the enact-
9 ment of this Act, the Secretary of Transportation shall

1 issue regulations requiring sponsors of airports to install
2 enhanced visual technologies to replace or enhance conven-
3 tional landing light systems over a period of 10 years be-
4 ginning on the date of issuance of the regulations.

5 **SEC. 3. INCLUSION OF INSTALLATION OF ENHANCED VIS-**
6 **UAL TECHNOLOGIES AS AIRPORT DEVELOP-**
7 **MENT.**

8 Section 47102 of title 49, United States Code, is
9 amended—

10 (1) in paragraph (3)(B)—

11 (A) by striking “and” at the end of clause
12 (v);

13 (B) by striking the period at the end of
14 clause (vi) and inserting “; and”; and

15 (C) by inserting after clause (vi) the fol-
16 lowing:

17 “(vii) enhanced visual technologies to
18 replace or enhance conventional landing
19 light systems.”; and

20 (2) by adding at the end the following:

21 “(21) ENHANCED VISION TECHNOLOGIES.—The
22 term “enhanced vision technologies” means laser
23 guidance, ultraviolet guidance, and cold cathode
24 technologies.”.

1 **SEC. 4. DEFINITIONS.**

2 In this Act, the following definitions apply:

3 (1) AIRPORT.—The term “airport” has the
4 meaning such term has under section 47102 of title
5 49, United States Code.

6 (2) ENHANCED VISION TECHNOLOGIES.—The
7 term “enhanced vision technologies” means laser
8 guidance, ultraviolet guidance, and cold cathode
9 technologies.

10 (3) SPONSOR.—The term “sponsor” has the
11 meaning such term has under such section.
