A BILL

For the relief of Margarito Domantay.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SATISFACTION OF CLAIM AGAINST THE UNITED**
4 **STATES.**

5 The Secretary of the Treasury shall pay, out of any
6 funds in the Treasury not otherwise appropriated, to Petty
7 Officer Margarito Domantay, United States Navy (re-

1 tired); of Tampa, Florida, the amount of retired pay that
2 he would have received for the period beginning on June
3 8, 1979, and ending on March 12, 1985, had he been ini-
4 tially retired in the grade of E-5, second class (rather
5 than the grade of E-4, third class, in which he was mis-
6 takenly retired due to administrative error).

7 **SEC. 2. LIMITATION ON AGENT AND ATTORNEY FEES.**

8 It shall be unlawful for an amount exceeding 10 per-
9 cent of the amount paid pursuant to section 1 to be paid
10 to, or received by, any agent or attorney for any service
11 rendered in connection with the claim described in such
12 section. Any person who violates this section shall be
13 guilty of an infraction, and shall be subject to a fine in
14 the amount provided in title 18, United States Code.

15 **SECTION 1. PAYMENT OF CLAIM AGAINST THE UNITED**
16 **STATES FOR ERRONEOUS COMPUTATION OF**
17 **RETIRED PAY.**

18 *The Secretary of the Treasury shall pay, out of any*
19 *funds in the Treasury not otherwise appropriated, to Petty*
20 *Officer Margarito Domantay, United States Navy (retired),*
21 *of Tampa, Florida, the sum of \$6,386.30, such amount rep-*
22 *resenting the amount of retired pay (with interest) that*
23 *Petty Officer Domantay would have received for the period*
24 *beginning on June 8, 1979, and ending on March 12, 1985,*
25 *had that retired pay been properly computed based upon*

1 pay grade E-5 second class (rather than pay grade of E-
2 4, third class, with which such retired pay was computed
3 due to administrative error).

4 **SEC. 2. LIMITATION ON AGENT AND ATTORNEY FEES.**

5 *It shall be unlawful for an amount exceeding 10 per-*
6 *cent of the amount paid pursuant to section 1 to be paid*
7 *to, or received by, any agent or attorney for any service*
8 *rendered in connection with the claim described in such sec-*
9 *tion. Any person who violates this section shall be guilty*
10 *of an infraction, and shall be subject to a fine in the amount*
11 *provided in title 18, United States Code.*
