Mr. LEWIS of Kentucky introduced the following bill; which was referred to the Committee on Resources

A BILL

To revise the boundary of the Abraham Lincoln Birthplace National Historic Site to include Knob Creek Farm, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REVISION OF BOUNDARY OF ABRAHAM LIN-**
4 **COLN BIRTHPLACE NATIONAL HISTORIC**
5 **SITE.**

6 (a) IN GENERAL.—Upon acquisition of the land
7 known as Knob Creek Farm pursuant to subsection (b),
8 the boundary of the Abraham Lincoln Birthplace National
9 Historic Site, established by the Act of July 17, 1916 (39

1 Stat. 385, chapter 247; 16 U.S.C. 211 et seq.), is revised
2 to include such land.

3 (b) ACQUISITION OF KNOB CREEK FARM.—The Sec-
4 retary of the Interior may acquire, by donation only, the
5 approximately 228 acres of land known as Knob Creek
6 Farm in Larue County, Kentucky.

7 **SEC. 2. STUDY OF THE ACQUISITION RESOURCES.**

8 (a) STUDY AND REPORT.—The Secretary of the Inte-
9 rior shall study the Knob Creek Farm in Larue County,
10 Kentucky, and not later than 1 year after the date of en-
11 actment of this Act, submit a report to the Congress con-
12 taining the results of the study. The purpose of the study
13 shall be to:

14 (1) Identify significant resources associated
15 with the Knob Creek Farm and the early boyhood
16 of Abraham Lincoln.

17 (2) Evaluate the threats to the long-term pro-
18 tection of the Knob Creek Farm's cultural, rec-
19 reational, and natural resources.

20 (3) Examine the incorporation of the Knob
21 Creek Farm into the operations of the Abraham
22 Lincoln Birthplace National Historic Site and estab-
23 lish a strategic management plan for implementing
24 such incorporation. In developing the plan, the Sec-
25 retary shall—

1 (A) determine infrastructure requirements
2 and property improvements needed at Knob
3 Creek Farm to meet National Park Service
4 Standards;

5 (B) identify current and potential uses of
6 Knob Creek Farm for recreational, interpretive,
7 and educational opportunities; and

8 (C) project costs and potential revenues as-
9 sociated with acquisition, development, and op-
10 eration of Knob Creek Farm.

11 (b) AUTHORIZATION.—There are authorized to be ap-
12 propriated such sums as may be necessary to carry out
13 this section.
