A BILL

To expand homeownership in the United States.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE AND TABLE OF CONTENTS.**

5 “American Homeownership Act of 1998”.

1 **SEC. 2. FINDINGS AND PURPOSE.**

2 (a) FINDINGS.—The Congress finds that—

3 (1) the priorities of our Nation should include
4 expanding homeownership opportunities by providing
5 access to affordable housing that is safe, clean, and
6 healthy;

7 (2) our Nation has an abundance of conven-
8 tional capital sources available for homeownership fi-
9 nancing; and

10 (3) experience with local homeownership pro-
11 grams has shown that if flexible capital sources are
12 available, communities possess ample will and cre-
13 ativity to provide opportunities uniquely designed to
14 assist their citizens in realizing the American dream
15 of homeownership.

16 (b) PURPOSE.—It is the purpose of this Act—

17 (1) to encourage and facilitate homeownership
18 by families in the United States who are not other-
19 wise able to afford homeownership; and

20 (2) to expand homeownership through policies
21 that—

22 (A) promote the ability of the private sec-
23 tor to produce affordable housing without exces-
24 sive government regulation;

1 (B) encourage tax incentives, such as the
 2 mortgage interest deduction, at all levels of gov-
 3 ernment; and

4 (C) facilitate the availability of flexible
 5 capital for homeownership opportunities.

6 **TITLE I—REMOVAL OF BAR-**
 7 **RIERS TO AFFORDABLE**
 8 **HOUSING**

9 **SEC. 101. SHORT TITLE.**

10 This title may be cited as the “Affordable Housing
 11 Barrier Removal Act of 1998”.

12 **SEC. 102. HOUSING IMPACT ANALYSIS.**

13 (a) **APPLICABILITY.**—The requirements of this sec-
 14 tion shall apply with respect to—

15 (1) any proposed rule, unless the head of the
 16 agency promulgating the rule—

17 (A) has certified that the proposed rule
 18 will not, if given force or effect as a final rule,
 19 have a significant deleterious impact on the
 20 availability of affordable housing; and

21 (B) has caused such certification to be
 22 published in the Federal Register at the time of
 23 publication of general notice of proposed rule-
 24 making for the rule, together with a statement

1 providing the factual basis for the certification;
2 and

3 (2) any final rule, unless the head of the agency
4 promulgating the rule—

5 (A) has certified that the rule will not, if
6 given force or effect, have a significant delete-
7 rious impact on the availability of affordable
8 housing; and

9 (B) has caused such certification to be
10 published in the Federal Register at the time of
11 publication of the final rule, together with a
12 statement providing the factual basis for the
13 certification.

14 Any agency making a certification under this subsection
15 shall provide a copy of such certification and the state-
16 ment providing the factual basis for the certification to
17 the Secretary of Housing and Urban Development.

18 (b) STATEMENT OF PROPOSED RULEMAKING.—
19 Whenever an agency publishes general notice of proposed
20 rulemaking for any proposed rule, the agency shall—

21 (1) in the notice of proposed rulemaking—

22 (A) state with particularity the text of the
23 proposed rule; and

24 (B) request any interested persons to sub-
25 mit to the agency any written data, views, and

1 arguments, and any specific alternatives to the
2 proposed rule that—

3 (i) accomplish the stated objectives of
4 the applicable statutes;

5 (ii) result in costs to the Federal Gov-
6 ernment not more than 5 percent higher
7 than such costs resulting from the pro-
8 posed rule; and

9 (iii) result in a quantity of affordable
10 housing that is 5 or more percent greater
11 than the quantity resulting from the pro-
12 posed rule;

13 (2) provide an opportunity for interested per-
14 sons to take the actions specified under paragraph
15 (1)(B) before promulgation of the final rule; and

16 (3) prepare and make available for public com-
17 ment an initial housing impact analysis in accord-
18 ance with the requirements of subsection (c).

19 (c) INITIAL HOUSING IMPACT ANALYSIS.—

20 (1) REQUIREMENTS.—Each initial housing im-
21 pact analysis shall describe the impact of the pro-
22 posed rule on the availability of affordable housing.
23 The initial housing impact analysis or a summary
24 shall be published in the Federal Register at the
25 same time as, and together with, the publication of

1 general notice of proposed rulemaking for the rule.
2 The agency shall transmit a copy of the initial hous-
3 ing impact analysis to the Secretary of Housing and
4 Urban Development.

5 (2) MONTHLY HUD LISTING.—On a monthly
6 basis, the Secretary of Housing and Urban Develop-
7 ment shall cause to be published in the Federal Reg-
8 ister, and shall make available through a World
9 Wide Web site of the Department, a listing of all
10 proposed rules for which an initial housing impact
11 analysis was prepared during the preceding month.

12 (3) CONTENTS.—Each initial housing impact
13 analysis required under this subsection shall con-
14 tain—

15 (A) a description of the reasons why action
16 by the agency is being considered;

17 (B) a succinct statement of the objectives
18 of, and legal basis for, the proposed rule;

19 (C) a description of and, where feasible, an
20 estimate of the extent to which the proposed
21 rule would impact the cost or supply of housing
22 or land; and

23 (D) an identification, to the extent prac-
24 ticable, of all relevant Federal rules which may

1 duplicate, overlap, or conflict with the proposed
2 rule.

3 (d) PROPOSAL OF LESS DELETERIOUS ALTERNATIVE
4 RULE.—

5 (1) ANALYSIS.—The agency publishing a gen-
6 eral notice of proposed rulemaking shall analyze any
7 specific alternatives to the proposed rule which have
8 been submitted to the agency pursuant to subsection
9 (b)(2) to determine whether any alternative to the
10 proposed rule—

11 (A) accomplishes the stated objectives of
12 the applicable statutes;

13 (B) results in costs to the Federal Govern-
14 ment not more than 5 percent higher than such
15 costs resulting from the proposed rule; and

16 (C) results in a quantity of affordable
17 housing that is 5 or more percent greater than
18 the quantity resulting from the proposed rule.

19 (2) NEW NOTICE OF PROPOSED RULE-
20 MAKING.—If the agency determines that an alter-
21 native to the proposed rule meets the requirements
22 under subparagraphs (A) through (C) of paragraph
23 (1), the agency shall publish a general notice of pro-
24 posed rulemaking for a proposed rule that accom-
25 plishes the stated objectives of the applicable stat-

1 utes, the text of which is based upon such alter-
2 native to the original proposed rule. In any case in
3 which the agency determines that more than one al-
4 ternative to the proposed rule meet such require-
5 ments, the new proposed rule contained in the gen-
6 eral notice of proposed rulemaking shall be based
7 upon the alternative that the agency determines is
8 most appropriate after considering the costs, effects
9 on affordable housing, and effectiveness in accom-
10 plishing the objective of the rule, of each such alter-
11 native. The rulemaking for the new proposed rule
12 shall be subject to the requirements under sub-
13 section (b).

14 (e) FINAL HOUSING IMPACT ANALYSIS.—

15 (1) REQUIREMENT.—Whenever an agency pro-
16 mulgates a final rule after publication of a general
17 notice of proposed rulemaking, the agency shall pre-
18 pare a final housing impact analysis.

19 (2) CONTENTS.—Each final housing impact
20 analysis shall contain—

21 (A) a succinct statement of the need for,
22 and objectives of, the rule;

23 (B) a summary of the significant issues
24 raised during the public comment period in re-
25 sponse to the initial housing impact analysis, a

1 summary of the assessment of the agency of
2 such issues, and a statement of any changes
3 made in the proposed rule as a result of such
4 comments; and

5 (C) a description of and an estimate of the
6 extent to which the rule will impact the avail-
7 ability of affordable housing or an explanation
8 of why no such estimate is available.

9 (3) AVAILABILITY.—The agency shall make
10 copies of the final housing impact analysis available
11 to members of the public and shall publish in the
12 Federal Register such analysis or a summary there-
13 of.

14 (f) AVOIDANCE OF DUPLICATIVE OR UNNECESSARY
15 ANALYSES.—

16 (1) DUPLICATION.—Any Federal agency may
17 perform the analyses required by subsections (c) and
18 (e) in conjunction with or as a part of any other
19 agenda or analysis required by any other law if such
20 other analysis satisfies the provisions of such sub-
21 sections.

22 (2) JOINDER.—In order to avoid duplicative ac-
23 tion, an agency may consider a series of closely re-
24 lated rules as one rule for the purposes of sub-
25 sections (c) and (e).

1 (g) PREPARATION OF ANALYSES.—In complying with
2 the provisions of subsections (c) and (e), an agency may
3 provide either a quantifiable or numerical description of
4 the effects of a proposed rule or alternatives to the pro-
5 posed rule, or more general descriptive statements if quan-
6 tification is not practicable or reliable.

7 (h) EFFECT ON OTHER LAW.—The requirements of
8 subsections (c) and (e) do not alter in any manner stand-
9 ards otherwise applicable by law to agency action.

10 (i) PROCEDURE FOR WAIVER OR DELAY OF COMPLE-
11 TION.—

12 (1) INITIAL HOUSING IMPACT ANALYSIS.—An
13 agency head may waive or delay the completion of
14 some or all of the requirements of subsection (c) by
15 publishing in the Federal Register, not later than
16 the date of publication of the final rule, a written
17 finding, with reasons therefor, that the final rule is
18 being promulgated in response to an emergency that
19 makes compliance or timely compliance with the pro-
20 visions of subsection (a) impracticable.

21 (2) FINAL HOUSING IMPACT ANALYSIS.—An
22 agency head may not waive the requirements of sub-
23 section (e). An agency head may delay the comple-
24 tion of the requirements of subsection (e) for a pe-
25 riod of not more than 180 days after the date of

1 publication in the Federal Register of a final rule by
2 publishing in the Federal Register, not later than
3 such date of publication, a written finding, with rea-
4 sons therefor, that the final rule is being promul-
5 gated in response to an emergency that makes time-
6 ly compliance with the provisions of subsection (e)
7 impracticable. If the agency has not prepared a final
8 housing impact analysis pursuant to subsection (e)
9 within 180 days from the date of publication of the
10 final rule, such rule shall lapse and have no force
11 or effect. Such rule shall not be repromulgated until
12 a final housing impact analysis has been completed
13 by the agency.

14 (j) DEFINITIONS.—For purposes of this section, the
15 following definitions shall apply:

16 (1) AFFORDABLE HOUSING.—The term “afford-
17 able housing” means housing that is affordable to
18 families having incomes that do not exceed 150 per-
19 cent of the median income of families in the area in
20 which the housing is located, with adjustments for
21 smaller and larger families. For purposes of this
22 paragraph, area, median family income for an area,
23 and adjustments for family size shall be determined
24 in the same manner as such factors are determined

1 for purposes of section 3(b)(2) of the United States
2 Housing Act of 1937.

3 (2) AGENCY.—The term “agency” means each
4 authority of the Government of the United States,
5 whether or not it is within or subject to review by
6 another agency, but does not include—

7 (A) the Congress;

8 (B) the courts of the United States;

9 (C) the governments of the territories or
10 possessions of the United States;

11 (D) the government of the District of Co-
12 lumbia;

13 (E) agencies composed of representatives
14 of the parties or of representatives of organiza-
15 tions of the parties to the disputes determined
16 by them;

17 (F) courts-martial and military commis-
18 sions;

19 (G) military authority exercised in the field
20 in time of war or in occupied territory; or

21 (H) functions conferred by—

22 (i) sections 1738, 1739, 1743, and
23 1744 of title 12, United States Code;

24 (ii) chapter 2 of title 41, United
25 States Code;

1 (iii) subchapter II of chapter 471 of
2 title 49, United States Code; or

3 (iv) sections 1884, 1891–1902, and
4 former section 1641(b)(2), of title 50, ap-
5 pendix, United States Code.

6 (3) FAMILIES.—The term “families” has the
7 meaning given such term in section 3 of the United
8 States Housing Act of 1937.

9 (4) RULE.—The term “rule” means any rule
10 for which the agency publishes a general notice of
11 proposed rulemaking pursuant to section 553(b) of
12 title 5, United States Code, or any other law, includ-
13 ing any rule of general applicability governing grants
14 by an agency to State and local governments for
15 which the agency provides an opportunity for notice
16 and public comment; except that such term does not
17 include a rule of particular applicability relating to
18 rates, wages, corporate or financial structures or re-
19 organizations thereof, prices, facilities, appliances,
20 services, or allowances therefor or to valuations,
21 costs or accounting, or practices relating to such
22 rates, wages, structures, prices, appliances, services,
23 or allowances.

24 (5) SIGNIFICANT.—The term “significant”
25 means, with respect to an impact on the availability

1 of affordable housing, a difference in quantity of 5
2 percent or more.

3 (k) DEVELOPMENT.—Not later than 120 days after
4 the date of the enactment of this Act, the Secretary of
5 Housing and Urban Development shall develop model ini-
6 tial and final housing impact analyses under this section
7 and shall cause such model analyses to be published in
8 the Federal Register. The model analyses shall be de-
9 signed to provide examples to other agencies of how to
10 carry out and develop the analyses required under sub-
11 sections (a) and (c).

12 **SEC. 103. GRANTS FOR REGULATORY BARRIER REMOVAL**
13 **STRATEGIES.**

14 (a) AUTHORIZATION OF APPROPRIATIONS.—Sub-
15 section (a) of section 1204 of the Housing and Community
16 Development Act of 1992 (42 U.S.C. 12705c(a)) is
17 amended to read as follows:

18 “(a) FUNDING.—There is authorized to be appro-
19 priated for grants under subsections (b) and (c)
20 \$15,000,000 for fiscal year 1999 and each fiscal year
21 thereafter through fiscal year 2003.”.

22 (b) APPLICATION AND SELECTION.—The last sen-
23 tence of section 1204(e) of the Housing and Community
24 Development Act of 1992 (42 U.S.C. 12705c(e)) is
25 amended by inserting before the period at the end the fol-

1 lowing: “and such criteria shall require that grant
2 amounts be used in a manner consistent with the strategy
3 contained in the comprehensive housing affordability
4 strategy for the jurisdiction pursuant to section 105(b)(4)
5 of the Cranston-Gonzalez National Affordable Housing
6 Act”.

7 (c) TECHNICAL AMENDMENTS.—Section 107(a)(1) of
8 the Housing and Community Development Act of 1974
9 (42 U.S.C. 5307(a)(1)) is amended—

10 (1) in subparagraph (G), by inserting “and”
11 after the semicolon at the end;

12 (2) by striking subparagraph (H); and

13 (3) by redesignating subparagraph (I) as sub-
14 paragraph (H).

15 **SEC. 104. ELIGIBILITY FOR COMMUNITY DEVELOPMENT**
16 **BLOCK GRANTS.**

17 Section 104(c)(1) of the Housing and Community
18 Development Act of 1974 (42 U.S.C. 5304(c)(1)) is
19 amended by inserting before the comma the following:
20 “, which shall include making a good faith effort to carry
21 out the strategy established under section 105(b)(4) of
22 such Act by the unit of general local government to remove
23 barriers to affordable housing”.

1 **SEC. 105. REGULATORY BARRIERS CLEARINGHOUSE.**

2 Section 1205 of the Housing and Community Devel-
3 opment Act of 1992 (42 U.S.C. 12705d) is amended—

4 (1) in subsection (a)—

5 (A) in the matter preceding paragraph (1),
6 by striking “receive, collect, process, and assem-
7 ble” and inserting “serve as a national reposi-
8 tory to receive, collect, process, assemble, and
9 disseminate”;

10 (B) in paragraph (1)—

11 (i) by striking “, including” and in-
12 serting “(including”;

13 (ii) by inserting before the semicolon
14 at the end the following: “), and the preva-
15 lence and effects on affordable housing of
16 such laws, regulations, and policies”;

17 (C) in paragraph (2), by inserting before
18 the semicolon the following: “, including par-
19 ticularly innovative or successful activities,
20 strategies, and plans”;

21 (D) in paragraph (3), by inserting before
22 the period at the end the following: “, including
23 particularly innovative or successful strategies,
24 activities, and plans”;

25 (2) in subsection (b)—

1 (A) in paragraph (1), by striking “and” at
2 the end;

3 (B) in paragraph (2), by striking the pe-
4 riod at the end and inserting “; and”; and

5 (C) by adding at the end the following new
6 paragraph:

7 “(3) by making available through a World Wide
8 Web site of the Department, by electronic mail, or
9 otherwise, provide to each housing agency of a unit
10 of general local government that serves an area hav-
11 ing a population greater than 100,000, an index of
12 all State and local strategies and plans submitted
13 under subsection (a) to the clearinghouse, which—

14 “(A) shall describe the types of barriers to
15 affordable housing that the strategy or plan
16 was designed to ameliorate or remove; and

17 “(B) shall, not later than 30 days after
18 submission to the clearinghouse of any new
19 strategy or plan, be updated to include the new
20 strategy or plan submitted.”; and

21 (3) by adding at the end the following new sub-
22 sections:

23 “(c) ORGANIZATION.—The clearinghouse under this
24 section shall be established within the Office of Policy De-
25 velopment of the Department of Housing and Urban De-

1 velopment and shall be under the direction of the Assist-
 2 ant Secretary for Policy Development and Research.

3 “(d) TIMING.—The clearinghouse under this section
 4 (as amended by section 105 of the Affordable Housing
 5 Barrier Removal Act of 1998) shall be established and
 6 commence carrying out the functions of the clearinghouse
 7 under this section not later than 1 year after the date of
 8 the enactment of such Act. The Secretary of Housing and
 9 Urban Development may comply with the requirements
 10 under this section by reestablishing the clearinghouse that
 11 was originally established to comply with this section and
 12 updating and improving such clearinghouse to the extent
 13 necessary to comply with the requirements of this section
 14 as in effect pursuant to the enactment of such Act.”.

15 **TITLE II—HOMEOWNERSHIP**
 16 **THROUGH MORTGAGE INSUR-**
 17 **ANCE AND LOAN GUARAN-**
 18 **TEES**

19 **SEC. 201. ADJUSTABLE RATE MORTGAGES.**

20 Section 251(c) of the National Housing Act (12
 21 U.S.C. 1715z–16(c)) is amended—

22 (1) by striking “(c) The” and inserting “(c)(1)

23 Except as provided in paragraph (2), the”; and

24 (2) by adding at the end the following new
 25 paragraph:

1 “(2)(A) The Secretary may, upon submitting to the
2 Congress a written finding under subparagraph (B), in-
3 sure under this section in the fiscal year for which the
4 finding is submitted an aggregate number of mortgages
5 and loans not exceeding 40 percent of the aggregate num-
6 ber of mortgages and loans insured by the Secretary under
7 this title during the preceding fiscal year.

8 “(B) A finding under this subparagraph is a finding
9 that the limitation under paragraph (1) on authority to
10 insure mortgages and loans during a fiscal year will be
11 reached before the end of that fiscal year and that an in-
12 crease in such limitation is necessary to meet the demand
13 for insurance under this section during the fiscal year.

14 “(C) Notwithstanding any other provision of this Act,
15 the Secretary shall increase the mortgage insurance pre-
16 miums otherwise chargeable under this Act for mortgages
17 and loans insured pursuant to the authority under sub-
18 paragraph (A) by the amount that the Secretary deter-
19 mines is necessary to cover any additional risk involved
20 in providing such insurance.”.

21 **SEC. 202. HOME EQUITY CONVERSION MORTGAGES.**

22 (a) PERMANENT MORTGAGE INSURANCE AUTHOR-
23 ITY.—Section 255(g) of the National Housing Act (12
24 U.S.C. 1715z–20(g)) is amended by striking the first 2
25 sentences.

1 (b) DOLLAR AMOUNT LIMITATION FOR INSURANCE
2 AUTHORITY.—Section 255(g) of the National Housing
3 Act (12 U.S.C. 1715z–20(g)), as amended by subsection
4 (a), is amended by inserting before the first sentence the
5 following new sentence: “The aggregate principal balance
6 of all mortgages insured under this section and outstand-
7 ing at any one time shall not exceed \$5,000,000,000.”.

8 (c) OTHER APPROACHES TO CONSUMER EDU-
9 CATION.—The Secretary of Housing and Urban Develop-
10 ment shall consult with consumer groups, industry rep-
11 resentatives, representatives of counseling organizations,
12 and other interested parties to identify alternative ap-
13 proaches to providing consumer information required by
14 section 255(f) of the National Housing Act that may be
15 feasible and desirable for home equity conversion mort-
16 gages insured under such section 255 and other types of
17 reverse mortgages. The Secretary may, in lieu of providing
18 the consumer education required by such section 255(f),
19 adopt alternative approaches to consumer education that
20 may be developed as a result of such consultations, but
21 only if the alternative approaches provide all of the infor-
22 mation specified in section 255(f).

23 (d) FUNDING FOR COUNSELING AND CONSUMER
24 EDUCATION AND OUTREACH.—Of any amounts made
25 available for any of fiscal years 1999 through 2003 for

1 housing counseling under section 106 of the Housing and
2 Urban Development Act of 1968, up to a total of
3 \$1,000,000 shall be available to the Secretary in each such
4 fiscal year, in such amounts as the Secretary determines
5 appropriate, for the following purposes in connection with
6 home equity conversion mortgages insured under section
7 255 of the National Housing Act:

8 (1) For housing counseling authorized by sec-
9 tion 106 of the Housing and Urban Development
10 Act of 1968.

11 (2) For transfer to the departmental salaries
12 and expenses account for consumer education and
13 outreach activities.

14 (e) CONFORMING AMENDMENTS.—Section 255 of the

23 after the semicolon at the end;

24 (B) in paragraph (2), by striking “; and”
25 at the end and inserting a period; and

1 (C) by striking paragraph (3); and

2 (4) by striking subsection (k).

3 (f) DISCLOSURE REQUIREMENTS AND PROHIBITION
4 OF FUNDING OF UNNECESSARY OR EXCESSIVE COSTS.—

5 (1) IN GENERAL.—Section 255(d) of the Na-
6 tional Housing Act (12 U.S.C. 1715z–20(d)) is
7 amended—

8 (A) in paragraph (2)—

9 (i) in subparagraph (B), by striking
10 “and” at the end;

11 (ii) by redesignating subparagraph
12 (C) as subparagraph (D); and

13 (iii) by inserting after subparagraph
14 (B) the following:

15 “(C) has received full disclosure of all costs
16 to the mortgagor for obtaining the mortgage,
17 including any costs of estate planning, financial
18 advice, or other related services; and”;

19 (B) in paragraph (9)(F), by striking
20 “and”;

21 (C) in paragraph (10), by striking the pe-
22 riod at the end and inserting “; and”; and

23 (D) by adding at the end the following:

24 “(11) have been made with such restrictions as
25 the Secretary determines to be appropriate to ensure

1 that the mortgagor does not fund any unnecessary
2 or excessive costs for obtaining the mortgage, includ-
3 ing any costs of estate planning, financial advice, or
4 other related services.”.

5 (2) IMPLEMENTATION.—

6 (A) NOTICE.—The Secretary of Housing
7 and Urban Development shall, by interim no-
8 tice, implement the amendments made by para-
9 graph (1) in an expeditious manner, as deter-
10 mined by the Secretary. Such notice shall not
11 be effective after the date of the effectiveness of
12 the final regulations issued under subparagraph
13 (B) of this paragraph.

14 (B) REGULATIONS.—The Secretary shall,

9 into any commitment to insure a mortgage covering
10 a 1- to 4-family residence that was constructed more
11 than 1 year before the date of the application for
12 mortgage insurance unless the Secretary determines
13 that—

14 “(A) the prospective mortgagor has ob-
15 tained a property inspection of the property
16 that will be subject to the mortgage, in accord-
17 ance with paragraph (2);

18 “(B) the contract providing for sale or
19 transfer of the property created, on the part of
20 the prospective mortgagor, a unilateral right to
21 rescind the contract or condition the sale or
22 offer upon the completion of repairs to the
23 property, for a period of not less than 72 hours
24 beginning upon the completion of the inspec-
25 tion; and

1 “(C) the rights referred to in subpara-
2 graph (B) were not waived, limited, or other-
3 wise impaired in any manner before the comple-
4 tion of the period referred to in such subpara-
5 graph.

6 “(2) PROPERTY INSPECTION.—A property in-
7 spection in accordance with this subsection for a res-
8 idence is an inspection that—

9 “(A) examines the condition of the physical
10 structure and systems of the residence, includ-
11 ing any heating, air conditioning, and interior
12 plumbing electrical systems, the roof, attic, vis-
13 ual insulation, walls, ceilings, floors, windows,
14 doors, foundation, basement, and other visible
15 structure;

16 “(B) provides to the prospective mortgagor
17 a written report that describes the results of
18 the examination; and

19 “(C) is conducted in accordance with the
20 guidelines established under paragraph (3) by
21 an inspector who is selected by the prospective
22 mortgagor from among inspectors certified in
23 accordance with such guidelines as qualified to
24 conduct such inspections.

1 “(3) GUIDELINES.—The Secretary shall issue
2 guidelines providing for conducting of inspections
3 under this subsection, which shall provide—

4 “(A) that inspections shall be performed in
5 accordance with the Standards of Practice and
6 Code of Ethics of the American Society of
7 Home Inspectors or such other generally ac-
8 cepted standards for home inspections that the
9 Secretary determines provide equivalent or
10 greater assurance to the homebuyer that the in-
11 spections will be performed thoroughly and im-
12 partially; and

13 “(B) for the Secretary to certify inspectors
14 as qualified to conduct inspections under this
15 subsection based upon demonstrated com-
16 petence and periodic reviews of professional
17 conduct, and to make widely publicly available
18 (including through posting on the World Wide
19 Web site of the Department) lists of certified
20 inspectors.”.

21 (b) FINANCING INSPECTION COSTS.—

22 (1) The National Housing Act is amended by
23 inserting “, except that the amount included because
24 of a property inspection pursuant to subsection (l)
25 may not exceed the maximum amount (not to exceed

1 \$300), which shall be established by the Secretary”
2 in each of the following places:

3 (A) In section 203 (12 U.S.C. 1709)—

4 (i) in subsection (b)(2), in the matter

15 (B) In section 220(d)(3)(A)(i) (12 U.S.C.
16 1715k(d)(3)(A)(i)), after “approve”.

17 (C) In section 221(d)(2) (12 U.S.C.
18 1715l(d)(2)), after “approve”.

19 (D) In section 221(i)(2)(A)(ii) (12 U.S.C.
20 1715l(i)(2)(A)(ii)), after “approve”.

21 (E) In section 237(c)(2) (12 U.S.C.
22 1715z-2(c)(2)), after “approve”.

23 (2) The last sentence of the penultimate undes-
24 ignated paragraph of section 203(b)(2) of the Na-
25 tional Housing Act (12 U.S.C. 1709(b)(2)) is

1 amended by inserting “, except to the extent that
2 this section specifically provides for limitation by
3 percentage or amount” before the period at the end.

4 (3) Section 203(b)(10)(B) of the National
5 Housing Act (12 U.S.C. 1709(b)(10)(B)) is amend-
6 ed by inserting after “approve” the following: “, ex-
7 cept that the amount approved for property inspec-
8 tion pursuant to subsection (l) shall be the maxi-
9 mum amount (not to exceed \$300) for such inspec-
10 tion as established by the Secretary”.

11 (c) INSPECTION REQUIREMENT UNDER VARIOUS
12 SINGLE FAMILY PROGRAMS.—The National Housing Act
13 is amended—

14 (1) in section 222(b)(1) (12 U.S.C.
15 1715m(b)(1)), by inserting before the semicolon the
16 following: “, and meet the requirements of section
17 203(l)”;

18 (2) in section 234(c) (12 U.S.C. 1715y(c)), by
19 inserting before “and (2)” the following: “, and
20 meets the requirements of section 203(l)”;

21 (3) in section 809(c) (12 U.S.C. 1748h–1(c)),
22 by striking “section 203(b)” and inserting the fol-
23 lowing: “subsections (b) and (l) of section 203”.

1 **SEC. 204. DEFINITION OF AREA.**

2 Section 203(b)(2) of the National Housing Act (12
3 U.S.C. 1709(b)(2)) is amended, in the first sentence after
4 subparagraph (B), by inserting before the period the fol-
5 lowing: “; except that the Secretary may provide that any
6 county or statistical area, together with any counties con-

23 amounts made available for fiscal year 1996 to carry out
24 this section, within 36 months)” in each of the following
25 places:

26 (1) In subsection (i)(5), before the comma.

1 (2) In subsection (j), before the second comma.

2 **SEC. 302. AUTHORIZATION OF APPROPRIATIONS.**

3 Section 11 of the Housing Opportunity Program Ex-
4 tension Act of 1996 (42 U.S.C. 12805 note) is amended
5 by adding at the end the following new subsection:

6 “(q) AUTHORIZATION OF APPROPRIATIONS.—To
7 carry out this section, there are authorized to be appro-
8 priated for fiscal year 1999 such sums as may be nec-
9 essary.”.

10 **TITLE IV—SECTION 8**
11 **HOMEOWNERSHIP OPTION**

12 **SEC. 401. PROGRAM FLEXIBILITY.**

13 Section 8(y) of the United States Housing Act of
14 1937 (42 U.S.C. 1437f(y)) is amended—

15 (1) in paragraph (1)—

16 (A) by striking “A family receiving” and
17 all that follows through “if the family” and in-
18 serting the following: “A public housing agency
19 providing tenant-based assistance on behalf of
20 an eligible family under this section may pro-
21 vide assistance for an eligible family that pur-
22 chases a dwelling unit (including a unit under
23 a lease-purchase agreement) that will be owned
24 by 1 or more members of the family, and will
25 be occupied by the family, if the family”;

1 (B) in subparagraph (A), by inserting be-
2 fore the semicolon “, or owns or is acquiring
3 shares in a cooperative”; and

4 (C) in subparagraph (B)—

5 (i) by striking “(i) participates” and
6 all that follows through “(ii)”; and

7 (ii) by inserting “, except that the
8 Secretary may provide for the consider-
9 ation of public assistance in the case of an
10 elderly family or a disabled family” after
11 “other than public assistance”;

12 (2) by striking paragraphs (2), (3), and (4) and
13 inserting the following new paragraphs:

14 “(2) DETERMINATION OF AMOUNT OF ASSIST-
15 ANCE.—

16 “(A) MONTHLY EXPENSES DO NOT EX-
17 CEED PAYMENT STANDARD.—If the monthly
18 homeownership expenses, as determined in ac-
19 cordance with requirements established by the
20 Secretary, do not exceed the payment standard,
21 the monthly assistance payment shall be the
22 amount by which the homeownership expenses
23 exceed the highest of the following amounts,
24 rounded to the nearest dollar:

1 “(i) 30 percent of the monthly ad-
2 justed income of the family.

3 “(ii) 10 percent of the monthly in-
4 come of the family.

5 “(iii) If the family is receiving pay-
6 ments for welfare assistance from a public
7 agency, and a portion of those payments,
8 adjusted in accordance with the actual
9 housing costs of the family, is specifically
10 designated by that agency to meet the
11 housing costs of the family, the portion of
12 those payments that is so designated.

13 “(B) MONTHLY EXPENSES EXCEED PAY-
14 MENT STANDARD.—If the monthly homeowner-
15 ship expenses, as determined in accordance with
16 requirements established by the Secretary, ex-
17 ceed the payment standard, the monthly assist-
18 ance payment shall be the amount by which the
19 applicable payment standard exceeds the high-
20 est of the 3 amounts, rounded to the nearest
21 dollar, under clauses (i), (ii), and (iii) of sub-
22 paragraph (A).

23 “(3) INSPECTIONS AND CONTRACT CONDI-
24 TIONS.—

1 “(A) IN GENERAL.—Each contract for the
2 purchase of a unit to be assisted under this sec-
3 tion shall—

4 “(i) provide for pre-purchase inspec-
5 tion of the unit by an independent profes-
6 sional; and

7 “(ii) require that any cost of nec-
8 essary repairs be paid by the seller.

9 “(B) ANNUAL INSPECTIONS NOT RE-
10 QUIRED.—The requirement under subsection
11 (o)(5)(B) for annual inspections shall not apply
12 to units assisted under this section.

13 “(4) OTHER AUTHORITY OF THE SECRETARY.—
14 The Secretary may—

15 “(A) limit the term of assistance for a
16 family assisted under this subsection; and

17 “(B) modify the requirements of this sub-
18 section as the Secretary determines to be nec-
19 essary to make appropriate adaptations for
20 lease-purchase agreements.”;

21 (3) by striking paragraph (5); and

22 (4) by redesignating paragraphs (6) and (7) as
23 paragraphs (5) and (6), respectively.

1 **SEC. 402. DOWNPAYMENT ASSISTANCE.**

2 Section 8(y) of the United States Housing Act of
3 1937 (42 U.S.C. 1437f(y)), as amended by section 401
4 of this Act, is amended by inserting after paragraph (6)
5 the following new paragraph:

6 “(7) DOWNPAYMENT ASSISTANCE.—

7 “(A) AUTHORITY.—A public housing agen-
8 cy may, in lieu of providing monthly assistance
9 payments under this subsection on behalf of a
10 family eligible for such assistance and at the
11 discretion of the public housing agency, provide
12 assistance for the family in the form of a single
13 grant to be used only as a contribution toward
14 the downpayment required in connection with
15 the purchase of a dwelling.

16 “(B) AMOUNT.—The amount of a down-
17 payment grant on behalf of an assisted family
18 may not exceed the amount that is equal to 3
19 times the sum of the assistance payments that
20 would be made during the first year of assist-
21 ance on behalf of the family, based upon the in-
22 come of the family at the time the grant is to
23 be made.”.

1 **TITLE V—HOME INVESTMENT**
2 **PARTNERSHIPS PROGRAM**

3 **SEC. 501. REAUTHORIZATION.**

4 Section 205 of the Cranston-Gonzalez National Af-
5 fordable Housing Act (42 U.S.C. 12724) is amended to
6 read as follows:

7 **“SEC. 205. AUTHORIZATION.**

8 “(a) IN GENERAL.—There are authorized to be ap-
9 propriated to carry out this title \$1,500,000,000 for each
10 of fiscal years 1999 through 2003, of which—

11 “(1) not more than \$25,000,000 in each such
12 fiscal year shall be for community housing partner-
13 ship activities authorized under section 233; and

14 “(2) not more than \$15,000,000 in each such
15 fiscal year shall be for activities in support of State
16 and local housing strategies authorized under sub-
17 title C.

18 “(b) PROHIBITION OF SET-ASIDES.—Except as pro-
19 vided in subsection (a) of this section and section
20 217(a)(3), amounts appropriated pursuant to subsection
21 (a) or otherwise to carry out this title shall be used only
22 for formula-based grants allocated pursuant to section 217
23 and may not be otherwise used unless the provision of law
24 providing for such other use specifically refers to this sub-

1 section and specifically states that such provision modifies
2 or supersedes the provisions of this subsection.”.

3 **SEC. 502. INCOME ELIGIBILITY TO FACILITATE HOME-**
4 **OWNERSHIP IN HIGH COST AREAS.**

5 (a) HOME INVESTMENT PARTNERSHIPS.—The Cran-
6 ston-Gonzalez National Affordable Housing Act is amend-
7 ed as follows:

8 (1) DEFINITIONS.—In section 104(10) (42
9 U.S.C. 12704(10))—

10 (A) by striking “income ceilings higher or
11 lower” and inserting “an income ceiling high-
12 er”;

13 (B) by striking “variations are” and in-
14 serting “variation is”; and

15 (C) by striking “high or”.

16 (2) INCOME TARGETING.—In section 214(1)(A)
17 (42 U.S.C. 12744(1)(A))—

18 (A) by striking “income ceilings higher or
19 lower” and inserting “an income ceiling high-
20 er”;

21 (B) by striking “variations are” and in-
22 serting “variation is”; and

23 (C) by striking “high or”.

24 (3) LIMITATIONS.—In section 215(a)(1)(A) (42
25 U.S.C. 12745(a)(1)(A))—

1 (A) by striking “income ceilings higher or
2 lower” and inserting “an income ceiling high-
3 er”;

4 (B) by striking “variations are” and in-
5 serting “variation is”; and

6 (C) by striking “high or”.

7 **SEC. 503. ELIGIBILITY OF LIMITED EQUITY COOPERATIVES**
8 **AND MUTUAL HOUSING ASSOCIATIONS.**

9 (a) CONGRESSIONAL FINDINGS.—Section 202(10) of
10 the Cranston-Gonzalez National Affordable Housing Act
11 (42 U.S.C. 12721(10)) is amended by inserting “mutual
12 housing associations,” after “limited equity cooperatives,”.

13 (b) DEFINITIONS.—Section 104 of the Cranston-
14 Gonzalez National Affordable Housing Act (42 U.S.C.
15 12704) is amended—

16 (1) by redesignating paragraph (23) as para-
17 graph (22);

18 (2) by redesignating paragraph (24) (relating to
19 the definition of “insular area”) as paragraph (23);
20 and

21 (3) by adding at the end the following new
22 paragraphs:

23 “(26) The term ‘limited equity cooperative’
24 means a cooperative housing corporation which, in a
25 manner determined by the Secretary to be accept-

1 able, restricts income eligibility of purchasers of
2 membership shares of stock in the cooperative cor-
3 poration or the initial and resale price of such
4 shares, or both, so that the shares remain available
5 and affordable to low-income families.

6 “(27) The term ‘mutual housing association’
7 means a private entity that—

8 “(A) is organized under State law;

9 “(B) is described in section 501(c) of the
10 Internal Revenue Code of 1986 and exempt
11 from taxation under section 501(a) of such
12 Code;

13 “(C) owns, manages, and continuously de-
14 velops affordable housing by providing long-
15 term housing for low- and moderate-income
16 families; and

17 “(D) provides that eligible families who
18 purchase membership interests in the associa-
19 tion shall have a right to residence in a dwelling
20 unit in the housing during the period that they
21 hold such membership interest; and

22 “(E) provides for the residents of such
23 housing to participate in the ongoing manage-
24 ment of the housing.”.

1 (c) ELIGIBILITY.—Section 215 of the Cranston-Gon-
2 zalez National Affordable Housing Act (42 U.S.C. 12745)
3 is amended—

4 (1) in subsection (b), by adding after and below
5 paragraph (4) the following:

6 “Housing that is owned by a limited equity cooperative
7 or a mutual housing association may be considered by a
8 participating jurisdiction to be housing for homeownership
9 for purposes of this title to the extent that ownership or
10 membership in such a cooperative or association, respec-
11 tively, constitutes homeownership under State or local
12 laws.”; and

13 (2) in subsection (a), by adding at the end the
14 following new paragraph:

15 “(6) LIMITED EQUITY COOPERATIVES AND MU-
16 TUAL HOUSING ASSOCIATIONS.—Housing that is
17 owned by a limited equity cooperative or a mutual
18 housing association may be considered by a partici-
19 pating jurisdiction to be rental housing for purposes
20 of this title to the extent that ownership or member-
21 ship in such a cooperative or association, respec-
22 tively, constitutes rental of a dwelling under State or
23 local laws.”.

1 **SEC. 504. LEVERAGING AFFORDABLE HOUSING INVEST-**
2 **MENT THROUGH LOCAL LOAN POOLS.**

3 (a) **ELIGIBLE INVESTMENTS.**—Section 212(b) of the
4 Cranston-Gonzalez National Affordable Housing Act (42
5 U.S.C. 12742(b)) is amended by inserting after “interest
6 subsidies” the following: “, advances to provide reserves
7 for loan pools or to provide partial loan guarantees,”.

8 (b) **TIMELY INVESTMENT OF TRUST FUNDS.**—Sec-
9 tion 218(e) of the Cranston-Gonzalez National Affordable
10 Housing Act (42 U.S.C. 12748) is amended to read as
11 follows:

12 “(e) **INVESTMENT WITHIN 15 DAYS.**—

13 “(1) **IN GENERAL.**—The participating jurisdic-
14 tion shall, not later than 15 days after funds are
15 drawn from the jurisdiction’s **HOME** Investment
16 Trust Fund, invest such funds, together with any in-
17 terest earned thereon, in the affordable housing for
18 which the funds were withdrawn.

19 “(2) **LOAN POOLS.**—In the case of a participat-
20 ing jurisdiction that withdraws Trust Fund amounts
21 for investment in the form of an advance for re-
22 serves or partial loan guarantees under a program
23 providing such credit enhancement for loans for af-
24 fordable housing, the amounts shall be considered to
25 be invested for purposes of paragraph (1) upon the
26 completion of both of the following actions:

1 “(A) Control of the amounts is transferred
2 to the program.

3 “(B) The jurisdiction and the entity oper-
4 ating the program enter into a written agree-
5 ment that—

6 “(i) provides that such funds may be
7 used only in connection with such program;

8 “(ii) defines the terms and conditions
9 of the loan pool reserve or partial loan
10 guarantees; and

11 “(iii) provides that such entity shall
12 ensure that amounts from non-Federal
13 sources have been contributed, or are com-
14 mitted for contribution, to the pool avail-
15 able for loans for affordable housing that
16 will be backed by such reserves or loan
17 guarantees in an amount equal to 10 times
18 the amount invested from Trust Fund
19 amounts.”.

20 (c) EXPIRATION OF RIGHT TO WITHDRAW FUNDS.—
21 Section 218(g) of the Cranston-Gonzalez National Afford-
22 able Housing Act (42 U.S.C. 12748(g)) is amended to
23 read as follows:

24 “(g) EXPIRATION OF RIGHT TO DRAW FUNDS.—

1 “(1) IN GENERAL.—If any funds becoming
2 available to a participating jurisdiction under this
3 title are not placed under binding commitment to af-
4 fordable housing within 24 months after the last day
5 of the month in which such funds are deposited in
6 the jurisdiction’s HOME Investment Trust Fund,
7 the jurisdiction’s right to draw such funds from the
8 HOME Investment Trust Fund shall expire. The
9 Secretary shall reduce the line of credit in the par-
10 ticipating jurisdiction’s HOME Investment Trust
11 Fund by the expiring amount and shall reallocate
12 the funds by formula in accordance with section
13 217(d).

14 “(2) LOAN POOLS.—In the case of a participat-
15 ing jurisdiction that withdraws Trust Fund amounts
16 for investment in the manner provided under sub-
17 section (e)(2), the amounts shall be considered to be
18 placed under binding commitment to affordable
19 housing for purposes of paragraph (1) of this sub-
20 section at the time that the amounts are obligated
21 for use under, and are subject to, a written agree-
22 ment described in subsection (e)(2)(B).”.

23 (d) TREATMENT OF MIXED INCOME LOAN POOLS AS
24 AFFORDABLE HOUSING.—

1 (1) IN GENERAL.—Section 215 of the Cran-
2 ston-Gonzalez National Affordable Housing Act (42
3 U.S.C. 12745) is amended by adding at the end the
4 following new subsection:

5 “(c) LOAN POOLS.—Notwithstanding subsections (a)
6 and (b), housing financed using amounts invested as pro-
7 vided in subsection (e)(2) shall qualify as affordable hous-
8 ing only if the housing complies with the following require-
9 ments:

10 “(1) In the case of housing that is for home-
11 ownership—

12 “(A) of the units financed with amounts so
13 invested—

14 “(i) not less than 75 percent are prin-
15 cipal residences of owners whose families
16 qualify as low-income families at the time
17 of purchase;

18 “(ii) all are principal residences of
19 owners whose families qualify as moderate-
20 income families at the time of purchase;
21 and

22 “(iii) all comply with paragraphs (3)
23 and (4) of subsection (b), except that para-
24 graph (3) shall be applied for purposes of
25 this clause by substituting ‘subsection

1 (c)(2)(B)’ and ‘low- and moderate-income
2 homebuyers’ for ‘paragraph (2)’ and ‘low-
3 income homebuyers’, respectively; and

4 “(B) units made available for purchase
5 only by families who qualify as low-income fam-
6 ilies at the time of purchase shall have an ini-
7 tial purchase price that complies with the re-
8 quirements of subsection (b)(1).

9 “(2) In the case of housing that is for rental,
10 the housing—

11 “(A) complies with subparagraphs (D)
12 through (F) of subsection (a)(1);

13 “(B)(i) has not less than 75 percent of the
14 units occupied by households that qualify as
15 low-income families and is occupied only by
16 households that qualify as moderate-income
17 families; or

18 “(ii) temporarily fails to comply with
19 clause (i) only because of increases in the in-
20 comes of existing tenants and actions satisfac-
21 tory to the Secretary are being taken to ensure
22 that all vacancies in the housing are being filled
23 in accordance with clause (i) until such non-
24 compliance is corrected; and

1 “(C) bears rents, in the case of units made
2 available for occupancy only by households that
3 qualify as low-income families, that comply with
4 the requirements of subsection (a)(1)(A).

5 Paragraphs (4) and (5) of subsection (a) shall apply
6 to housing that is subject to this subsection.”.

7 (2) DEFINITION.—Section 104 of the Cranston-
8 Gonzalez National Affordable Housing Act (42
9 U.S.C. 12704) is amended—

10 (A) by redesignating paragraph (25) as
11 paragraph (26);

12 (B) by redesignating paragraph (24) (re-
13 lating to the definition of energy efficient mort-
14 gage) as paragraph (25);

15 (C) by redesignating paragraphs (11)
16 through (21) as paragraphs (12) through (22),
17 respectively; and

18 (D) by inserting after paragraph (10) the
19 following new paragraph:

20 “(11) The term ‘moderate income families’
21 means families whose incomes do not exceed the me-
22 dian income for the area, as determined by the Sec-
23 retary with adjustments for smaller and larger fami-
24 lies, except that the Secretary may establish income
25 ceilings higher or lower than the median income for

1 the area on the basis of the Secretary’s findings that
2 such variations are necessary because of prevailing
3 levels of construction costs or fair market rents, or
4 unusually high or low family incomes.”.

5 **SEC. 505. LOAN GUARANTEES.**

6 Subtitle A of title II of the Cranston-Gonzalez Na-
7 tional Affordable Housing Act (42 U.S.C. 12741 et seq.)
8 is amended by adding at the end the following new section:

9 **“SEC. 227. LOAN GUARANTEES.**

10 “(a) **AUTHORITY.**—The Secretary may, upon such
11 terms and conditions as the Secretary may prescribe,
12 guarantee and make commitments to guarantee, only to
13 such extent or in such amounts as provided in appropria-
14 tions Acts, the notes or other obligations issued by eligible
15 participating jurisdictions or by public agencies designated
16 by and acting on behalf of eligible participating jurisdic-
17 tions for purposes of financing (including credit enhance-
18 ments and debt service reserves) the acquisition, new con-
19 struction, reconstruction, or moderate or substantial reha-
20 bilitation of affordable housing (including real property ac-
21 quisition, site improvement, conversion, and demolition),
22 and other related expenses (including financing costs and
23 relocation expenses of any displaced persons, families,
24 businesses, or organizations). Housing funded under this
25 section shall meet the requirements of this subtitle.

1 “(b) REQUIREMENTS.—Notes or other obligations
2 guaranteed under this section shall be in such form and
3 denominations, have such maturities, and be subject to
4 such conditions as may be prescribed by the Secretary.
5 The Secretary may not deny a guarantee under this sec-
6 tion on the basis of the proposed repayment period for
7 the note or other obligation, unless the period is more than
8 20 years or the Secretary determines that the period oth-
9 erwise causes the guarantee to constitute an unacceptable
10 financial risk.

11 “(c) LIMITATION ON TOTAL NOTES AND OBLIGA-
12 TIONS.—The Secretary may not guarantee or make a com-
13 mitment to guarantee any note or other obligation if the
14 total outstanding notes or obligations guaranteed under
15 this section on behalf of the participating jurisdiction
16 issuing the note or obligation (excluding any amount
17 defeased under a contract entered into under subsection
18 (e)(1)) would thereby exceed an amount equal to 5 times
19 the amount of the participating jurisdiction’s latest alloca-
20 tion under section 217.

21 “(d) USE OF PROGRAM FUNDS.—Notwithstanding
22 any other provision of this subtitle, funds allocated to the
23 participating jurisdiction under this subtitle (including
24 program income derived therefrom) are authorized for use
25 in the payment of principal and interest due on the notes

1 or other obligations guaranteed pursuant to this section
2 and the payment of such servicing, underwriting, or other
3 issuance or collection charges as may be specified by the
4 Secretary.

5 “(e) SECURITY.—To assure the full repayment of
6 notes or other obligations guaranteed under this section,
7 and payment of the issuance or collection charges specified
8 by the Secretary under subsection (d), and as a prior con-
9 dition for receiving such guarantees, the Secretary shall
10 require the participating jurisdiction (and its designated
11 public agency issuer, if any) to—

12 “(1) enter into a contract, in a form acceptable
13 to the Secretary, for repayment of such notes or
14 other obligations and the other specified charges;

15 “(2) pledge as security for such repayment any
16 allocation for which the participating jurisdiction
17 may become eligible under this subtitle; and

18 “(3) furnish, at the discretion of the Secretary,
19 such other security as may be deemed appropriate
20 by the Secretary in making such guarantees, which
21 may include increments in local tax receipts gen-
22 erated by the housing assisted under this section or
23 disposition proceeds from the sale of land or hous-
24 ing.

1 “(f) REPAYMENT AUTHORITY.—The Secretary may,
2 notwithstanding any other provision of this subtitle or any
3 other Federal, State, or local law, apply allocations
4 pledged pursuant to subsection (e) to any repayments due
5 the United States as a result of such guarantees.

6 “(g) FULL FAITH AND CREDIT.—The full faith and
7 credit of the United States is pledged to the payment of
8 all guarantees made under this section. Any such guaran-
9 tee made by the Secretary shall be conclusive evidence of
10 the eligibility of the notes or other obligations for such
11 guarantee with respect to principal and interest, and the
12 validity of any such guarantee so made shall be incontest-
13 able in the hands of a holder of the guaranteed obligations.

14 “(h) TAX STATUS.—With respect to any obligation
15 guaranteed pursuant to this section, the interest paid on
16 such obligation shall be included in gross income for pur-
17 poses of the Internal Revenue Code of 1986.

18 “(i) MONITORING.—The Secretary shall monitor the
19 use of guarantees under this section by eligible participat-
20 ing jurisdictions. If the Secretary finds that 50 percent
21 of the aggregate guarantee authority for any fiscal year
22 has been committed, the Secretary may impose limitations
23 on the amount of guarantees any 1 participating jurisdic-
24 tion may receive during that fiscal year.

25 “(j) GUARANTEE OF TRUST CERTIFICATES.—

1 “(1) AUTHORITY.—The Secretary may, upon
2 such terms and conditions as the Secretary deems
3 appropriate, guarantee the timely payment of the
4 principal of and interest on such trust certificates or
5 other obligations as may—

6 “(A) be offered by the Secretary or by any
7 other offeror approved for purposes of this sub-
8 section by the Secretary; and

9 “(B) be based on and backed by a trust or
10 pool composed of notes or other obligations
11 guaranteed or eligible for guarantee by the Sec-
12 retary under this section.

13 “(2) FULL FAITH AND CREDIT.—To the same
14 extent as provided in subsection (g), the full faith
15 and credit of the United States is pledged to the
16 payment of all amounts which may be required to be
17 paid under any guarantee by the Secretary under
18 this subsection.

19 “(3) SUBROGATION.—In the event the Sec-
20 retary pays a claim under a guarantee issued under
21 this section, the Secretary shall be subrogated fully
22 to the rights satisfied by such payment.

23 “(4) OTHER POWERS AND RIGHTS.—No State
24 or local law, and no Federal law, shall preclude or
25 limit the exercise by the Secretary of—

1 “(A) the power to contract with respect to
2 public offerings and other sales of notes, trust
3 certificates, and other obligations guaranteed
4 under this section, upon such terms and condi-
5 tions as the Secretary deems appropriate;

6 “(B) the right to enforce, by any means
7 deemed appropriate by the Secretary, any such
8 contract; and

9 “(C) the Secretary’s ownership rights, as
10 applicable, in notes, certificates or other obliga-
11 tions guaranteed under this section, or con-
12 stituting the trust or pool against which trust
13 certificates or other obligations guaranteed
14 under this section are offered.

15 “(k) AGGREGATE LIMITATION.—The total amount of
16 outstanding obligations guaranteed on a cumulative basis
17 by the Secretary under this section shall not at any time
18 exceed \$2,000,000,000.”.

19 **TITLE VI—LOCAL**
20 **HOMEOWNERSHIP INITIATIVES**

21 **SEC. 601. REAUTHORIZATION OF NEIGHBORHOOD REIN-**
22 **VESTMENT CORPORATION.**

23 Section 608(a)(1) of the Neighborhood Reinvestment
24 Corporation Act (42 U.S.C. 8107(a)(1)) is amended by
25 striking the first sentence and inserting the following:

1 “There are authorized to be appropriated to the corpora-
2 tion to carry out this title \$90,000,000 for each of fiscal
3 years 1999 through 2003. Of any amounts made available
4 pursuant to this subsection for fiscal year 1999,
5 \$25,000,000 shall be for a pilot homeownership initiative,
6 including an evaluation by an independent third party to
7 determine its effectiveness.”.

8 **SEC. 602. INCOME ELIGIBILITY UNDER CDBG TO FACILI-**
9 **TATE HOMEOWNERSHIP IN HIGH-COST**
10 **AREAS.**

11 Section 102(a)(20) of the Housing and Community
12 Development Act of 1974 (42 U.S.C. 5302(a)(20)) is
13 amended by striking subparagraph (B) and inserting the
14 following new subparagraph:

15 “(B) The Secretary may—

16 “(i) with respect to any reference in sub-
17 paragraph (A) to 50 percent of the median in-
18 come of the area involved, establish percentages
19 of median income for any area that are higher
20 or lower than 50 percent if the Secretary finds
21 such variations to be necessary because of un-
22 usually high or low family incomes in such area;
23 and

24 “(ii) with respect to any reference in sub-
25 paragraph (A) to 80 percent of the median in-

1 come of the area involved, establish a percent-
2 age of median income for any area that is high-
3 er than 80 percent if the Secretary finds such
4 variation to be necessary because of unusually
5 low family incomes in such area.”.

6 **SEC. 603. HOMEOWNERSHIP ZONES.**

7 Section 186 of the Housing and Community Develop-
8 ment Act of 1992 (42 U.S.C. 12898a) is amended to read
9 as follows:

10 **“SEC. 186. HOMEOWNERSHIP ZONE GRANTS.**

11 “(a) **AUTHORITY.**—The Secretary of Housing and
12 Urban Development may make grants to units of general
13 local government to assist homeownership zones. Home-
14 ownership zones are contiguous, geographically defined
15 areas, primarily residential in nature, in which large-scale
16 development projects are designed to reclaim distressed
17 neighborhoods by creating homeownership opportunities
18 for low- and moderate-income families. Projects in home-
19 ownership zones are intended to serve as a catalyst for
20 private investment, business creation, and neighborhood
21 revitalization.

22 “(b) **ELIGIBLE ACTIVITIES.**—Amounts made avail-
23 able under this section may be used for projects that in-
24 clude any of the following activities in the homeownership
25 zone:

1 “(1) Acquisition, construction, and rehabilita-
2 tion of housing.

3 “(2) Site acquisition and preparation, including
4 demolition, construction, reconstruction, or installa-
5 tion of public and other site improvements and utili-
6 ties directly related to the homeownership zone.

7 “(3) Direct financial assistance to homebuyers.

8 “(4) Homeownership counseling.

9 “(5) Relocation assistance.

10 “(6) Marketing costs, including affirmative
11 marketing activities.

12 “(7) Other project-related costs.

13 “(8) Reasonable administrative costs (up to 5
14 percent of the grant amount).

15 “(9) Other housing-related activities proposed
16 by the applicant as essential to the success of the
17 homeownership zone and approved by the Secretary.

18 “(c) APPLICATION.—To be eligible for a grant under
19 this section, a unit of general local government shall sub-
20 mit an application for a homeownership zone grant in such
21 form and in accordance with such procedures as the Sec-
22 retary shall establish.

23 “(d) SELECTION CRITERIA.—The Secretary shall se-
24 lect applications for funding under this section through

1 a national competition, using selection criteria established
2 by the Secretary, which shall include—

3 “(1) the degree to which the proposed activities
4 will result in the improvement of the economic, so-
5 cial, and physical aspects of the neighborhood and
6 the lives of its residents through the creation of new
7 homeownership opportunities;

8 “(2) the levels of distress in the homeownership
9 zone as a whole, and in the immediate neighborhood
10 of the project for which assistance is requested;

11 “(3) the financial soundness of the plan for fi-
12 nancing homeownership zone activities;

13 “(4) the leveraging of other resources; and

14 “(5) the capacity to successfully carry out the
15 plan.

16 “(e) GRANT APPROVAL AMOUNTS.—The Secretary
17 may establish a maximum amount for any grant for any
18 funding round under this section. A grant may not be
19 made in an amount that exceeds the amount that the Sec-
20 retary determines is necessary to fund the project for
21 which the application is made.

22 “(f) PROGRAM REQUIREMENTS.—A homeownership
23 zone proposal shall—

1 “(1) provide for a significant number of new
2 homeownership opportunities that will make a visible
3 improvement in an immediate neighborhood;

4 “(2) not be inconsistent with such planning and
5 design principles as may be prescribed by the Sec-
6 retary;

7 “(3) be designed to stimulate additional invest-
8 ment in that area;

9 “(4) provide for partnerships with persons or
10 entities in the private and nonprofit sectors;

11 “(5) incorporate a comprehensive approach to
12 revitalization of the neighborhood;

13 “(6) establish a detailed time-line for com-
14 mencement and completion of construction activities;
15 and

16 “(7) provide for affirmatively furthering fair
17 housing.

18 “(g) INCOME TARGETING.—At least 51 percent of
19 the homebuyers assisted with funds under this section
20 shall have household incomes at or below 80 percent of
21 median income for the area, as determined by the Sec-
22 retary.

23 “(h) ENVIRONMENTAL REVIEW.—For purposes of
24 environmental review, decisionmaking, and action pursu-
25 ant to the National Environmental Policy Act of 1969 and

1 other provisions of law that further the purposes of such
2 Act, a grant under this section shall be treated as assist-
3 ance under the HOME Investment Partnerships Act and
4 shall be subject to the regulations issued by the Secretary
5 to implement section 288 of such Act.

6 “(i) REVIEW, AUDIT, AND REPORTING.—The Sec-
7 retary shall make such reviews and audits and establish
8 such reporting requirements as may be necessary or ap-
9 propriate to determine whether the grantee has carried out
10 its activities in a timely manner and in accordance with
11 the requirements of this section. The Secretary may ad-
12 just, reduce, or withdraw amounts made available, or take
13 other action as appropriate, in accordance with the Sec-
14 retary’s performance reviews and audits under this sec-
15 tion.

16 “(j) AUTHORIZATION.—There are authorized to be
17 appropriated to carry out this section \$25,000,000 for fis-
18 cal year 1999 and such sums as may be necessary for fis-
19 cal year 2000, to remain available until expended.”.

20 **SEC. 604. LEASE-TO-OWN.**

21 (a) SENSE OF CONGRESS.—It is the sense of the Con-
22 gress that residential tenancies under lease-to-own provi-
23 sions can facilitate homeownership by low- and moderate-
24 income families and provide opportunities for homeowner-

1 ship for such families who might not otherwise be able
2 to afford homeownership.

3 (b) REPORT.—Not later than the expiration of the
4 3-month period beginning on the date of the enactment
5 of this Act, the Secretary of Housing and Urban Develop-
6 ment shall submit a report to the Congress—

7 (1) analyzing whether lease-to-own provisions
8 can be effectively incorporated within the HOME in-
9 vestment partnerships program, the public housing
10 program, the tenant-based rental assistance program
11 under section 8 of the United States Housing Act of
12 1937, or any other programs of the Department to
13 facilitate homeownership by low- or moderate-income
14 families;

15 (2) any legislative or administrative changes
16 necessary to alter or amend such programs to allow
17 the use of lease-to-own options to provide home-
18 ownership opportunities.

19 **SEC. 605. HOUSING COUNSELING.**

20 (a) EXTENSION OF EMERGENCY HOMEOWNERSHIP
21 COUNSELING.—Section 106(c)(9) of the Housing and
22 Urban Development Act of 1968 (12 U.S.C. 1701x(c)(9))
23 is amended by striking “September 30, 1994” and insert-
24 ing “September 30, 2003”.

1 (b) EXTENSION OF PREPURCHASE AND FORE-
2 CLOSURE PREVENTION COUNSELING DEMONSTRATION.—
3 Section 106(d)(13) of the Housing and Urban Develop-
4 ment Act of 1968 (12 U.S.C. 1701x(d)(12)) is amended
5 by striking “fiscal year 1994” and inserting “fiscal year
6 2003”.

7 (c) NOTIFICATION OF DELINQUENCY ON VETERANS
8 HOME LOANS.—Subparagraph (C) of section 106(c)(5) of
9 the Housing and Urban Development Act of 1968 is
10 amended to read as follows:

11 “(C) NOTIFICATION.—Notification under
12 subparagraph (A) shall not be required with re-
13 spect to any loan for which the eligible home-
14 owner pays the amount overdue before the expi-
15 ration of the 45-day period under subparagraph
16 (B)(ii).”.

17 **SEC. 606. LOCAL CAPACITY BUILDING.**

18 Section 4 of the HUD Demonstration Act of 1993
19 (42 U.S.C. 9816 note) is amended—

20 (1) in subsection (a), by inserting “National
21 Association of Housing Partnerships,” after “Hu-
22 manity,”; and

23 (2) in subsection (e), by striking “\$25,000,000”
24 and all that follows and inserting “, for each fiscal

1 year, such sums as may be necessary to carry out
 2 this section.”.

3 **TITLE VII—MANUFACTURED**
 4 **HOUSING IMPROVEMENT**

5 **SEC. 701. SHORT TITLE AND REFERENCES.**

6 (a) **SHORT TITLE.**—This title may be cited as the
 7 “Manufactured Housing Improvement Act”.

8 (b) **REFERENCES.**—Whenever in this title an amend-
 9 ment is expressed in terms of an amendment to, or repeal
 10 of, a section or other provision, the reference shall be con-
 11 sidered to be made to that section or other provision of
 12 the National Manufactured Housing Construction and
 13 Safety Standards Act of 1974 (42 U.S.C. 5401 et seq.).

14 **SEC. 702. FINDINGS AND PURPOSES.**

15 Section 602 (42 U.S.C. 5401) is amended to read as
 16 follows:

17 **“FINDINGS AND PURPOSES**

18 **“SEC. 602. (a) FINDINGS.**—The Congress finds
 19 that—

20 “(1) manufactured housing plays a vital role in
 21 meeting the housing needs of the Nation; and

22 “(2) manufactured homes provide a significant
 23 resource for affordable homeownership and rental
 24 housing accessible to all Americans.

25 **“(b) PURPOSES.**—The purposes of this title are—

1 “(1) to promote the quality, durability, safety,
2 and affordability of manufactured housing;

3 “(2) to promote the availability of affordable
4 manufactured homes and to increase homeownership
5 for all Americans;

6 “(3) to provide for the establishment of prac-
7 tical, uniform, and, to the extent possible, perform-
8 ance-based Federal construction standards;

9 “(4) to encourage innovative and cost-effective
10 construction techniques;

11 “(5) to protect owners of manufactured homes
12 from unreasonable risk of personal injury and prop-
13 erty damage;

14 “(6) to establish a balanced consensus process
15 for the development, revision, and interpretation of
16 Federal construction and safety standards for manu-
17 factured homes and related regulations for the en-
18 forcement of such standards;

19 “(7) to ensure uniform and effective enforce-
20 ment of Federal construction and safety standards
21 for manufactured homes; and

22 “(8) to ensure that the public interest in, and
23 need for, affordable manufactured housing is duly
24 considered in all determinations relating to the Fed-
25 eral standards and their enforcement.”.

1 **SEC. 703. DEFINITIONS.**

2 (a) IN GENERAL.—Section 603 (42 U.S.C. 5402) is
3 amended—

4 (1) in paragraph (2), by striking “dealer” and
5 inserting “retailer”;

6 (2) in paragraph (12), by striking “and” at the
7 end;

8 (3) in paragraph (13), by striking the period at
9 the end and inserting a semicolon; and

10 (4) by adding at the end the following new
11 paragraphs:

12 “(14) ‘administering organization’ means the
13 qualified technical or building code organization that
14 administers the consensus development process,
15 which—

16 “(A) with respect to the period during
17 which the agreement under section
18 604(a)(2)(A) is in force, shall be the Council of
19 American Building Officials; and

20 “(B) with respect to the period during
21 which a competitively procured contract under
22 section 604(a)(2)(B) is in force, shall be the or-
23 ganization selected by the Secretary;

24 “(15) ‘consensus committee’ means the commit-
25 tee established under section 604(a)(3);

1 “(16) ‘consensus standards development proc-
2 ess’ means the process by which additions, revisions,
3 and interpretations to the Federal manufactured
4 home construction and safety standards and enforce-
5 ment regulations shall be developed and rec-
6 ommended to the Secretary by the consensus com-
7 mittee;

8 “(17) ‘primary inspection agency’ means a
9 State agency or private organization that has been
10 approved by the Secretary to act as a design ap-
11 proval primary inspection agency or a production in-
12 spection primary inspection agency, or both;

13 “(18) ‘design approval primary inspection agen-
14 cy’ means a State agency or private organization
15 that has been approved by the Secretary to evaluate
16 and either approve or disapprove manufactured
17 home designs and quality control procedures;

18 “(19) ‘production inspection primary inspection
19 agency’ means a State agency or private organiza-
20 tion that has been approved by the Secretary to
21 evaluate the ability of manufactured home manufac-
22 turing plants to comply with approved quality con-
23 trol procedures and with the Federal manufactured
24 home construction and safety standards promulgated
25 hereunder; and

1 “(20) ‘monitoring’ means the process of peri-
2 odic review of the primary inspection agencies, by
3 the Secretary or by a State agency under an ap-
4 proved State plan pursuant to section 623, in ac-
5 cordance with regulations adopted by the consensus
6 committee and promulgated in accordance with sec-
7 tion 604(a)(4)(B). Such monitoring shall be for the
8 purpose of ensuring that the primary inspection
9 agencies are discharging their duties as defined
10 herein.”.

11 (b) CONFORMING AMENDMENTS.—The National
12 Manufactured Housing Construction and Safety Stand-
13 ards Act of 1974 is amended—

14 (1) in section 613 (42 U.S.C. 5412), by striking
15 “dealer” each place it appears and inserting “re-
16 tailer”;

17 (2) in section 614(f) (42 U.S.C. 5413(f)), by
18 striking “dealer” each place it appears and inserting
19 “retailer”;

20 (3) in section 615 (42 U.S.C. 5414)—

21 (A) in subsection (b)(1), by striking “deal-
22 er” and inserting “retailer”;

23 (B) in subsection (b)(3), by striking “deal-
24 er or dealers” and inserting “retailer or retail-
25 ers”; and

1 (C) in subsections (d) and (f), by striking
2 “dealers” each place it appears and inserting
3 “retailers”;

4 (4) in section 616 (42 U.S.C. 5415), by striking
5 “dealer” and inserting “retailer”; and

6 (5) in section 623(c)(9), by striking “dealers”
7 and inserting “retailers”.

8 **SEC. 704. FEDERAL MANUFACTURED HOME CONSTRUC-**
9 **TION AND SAFETY STANDARDS.**

10 Section 604 (42 U.S.C. 5304) is amended—

11 (1) by striking subsections (a) and (b) and in-
12 serting the following new subsections:

13 “(a) ESTABLISHMENT.—

14 “(1) AUTHORITY.—The Secretary shall estab-
15 lish, by order, appropriate Federal manufactured
16 home construction and safety standards, each of
17 which—

18 “(A) shall—

19 “(i) be reasonable and practical;

20 “(ii) meet high standards of protec-
21 tion consistent with the enumerated pur-
22 poses of this title; and

23 “(iii) where appropriate, be perform-
24 ance-based and stated objectively; and

1 “(B) except as provided in subsection (b),
2 shall be established in accordance with the con-
3 sensus standards development process.

4 “(2) CONSENSUS STANDARDS AND REGU-
5 LATORY DEVELOPMENT PROCESS.—

6 “(A) INITIAL AGREEMENT.—Not later
7 than 180 days after the date of enactment of
8 the Manufactured Housing Improvement Act,
9 the Secretary shall request the Council of
10 American Building Officials (or the successor
11 organization to such Council) to, and if such or-
12 ganization consents, enter into an agreement,
13 which shall—

14 “(i) terminate on the date on which a
15 contract is entered into under subpara-
16 graph (B); and

17 “(ii) require the Council of American
18 Building Officials to—

19 “(I) appoint the initial members
20 of the consensus committee under
21 paragraph (3);

22 “(II) administer the consensus
23 standards development process until
24 the termination of that agreement;
25 and

1 “(III) administer the consensus
2 development and interpretation proc-
3 ess for procedural and enforcement
4 regulations and regulations specifying
5 the permissible scope and conduct of
6 monitoring until the termination of
7 that agreement.

8 If the Council of American Building Officials
9 (or the successor organization to such Council)
10 declines to enter into the agreement as provided
11 in this subparagraph, the Secretary shall enter
12 into the agreement under this subparagraph
13 with an organization described in subparagraph
14 (B).

15 “(B) COMPETITIVELY PROCURED CON-
16 TRACT.—Upon the expiration of the 4-year pe-
17 riod beginning on the date on which all mem-
18 bers of the consensus committee are appointed
19 under paragraph (3), the Secretary shall, using
20 competitive procedures (as such term is defined
21 in section 4 of the Office of Federal Procure-
22 ment Policy Act), enter into a competitively
23 awarded contract with a qualified technical or
24 building code organization (which may be the
25 Council of American Building Officials) under

1 which the organization shall administer the con-
2 sensus process for the development and inter-
3 pretation of the Federal standards, the proce-
4 dural and enforcement regulations and regula-
5 tions specifying the permissible scope and con-
6 duct of monitoring in accordance with this title.

7 “(C) PERFORMANCE REVIEW.—The Sec-
8 retary—

9 “(i) shall periodically review the per-
10 formance of the administering organiza-
11 tion; and

12 “(ii) may replace the administering
13 organization with another qualified tech-
14 nical or building code organization, pursu-
15 ant to competitive procedures, if the Sec-
16 retary determines in writing that the ad-
17 ministering organization is not fulfilling
18 the terms of the agreement or contract to
19 which the administering organization is
20 subject or upon the expiration of the
21 agreement or contract.

22 “(3) CONSENSUS COMMITTEE.—

23 “(A) PURPOSE.—There is established a
24 committee to be known as the ‘consensus com-

1 mittee’, which shall, in accordance with this
2 title—

3 “(i) provide periodic recommendations
4 to the Secretary to adopt, revise, and inter-
5 pret the Federal manufactured housing
6 construction and safety standards in ac-
7 cordance with this subsection;

8 “(ii) provide periodic recommenda-
9 tions to the Secretary to adopt, revise, and
10 interpret the procedural and enforcement
11 regulations, including regulations specify-
12 ing the permissible scope and conduct of
13 monitoring in accordance with this sub-
14 section; and

15 “(iii) be organized and carry out its
16 business in a manner that guarantees a
17 fair opportunity for the expression and
18 consideration of various positions and for
19 public participation.

20 “(B) MEMBERSHIP.—The consensus com-
21 mittee shall be composed of—

22 “(i) 25 voting members appointed,
23 subject to approval by the Secretary, by
24 the administering organization from among
25 individuals who are qualified by back-

1 ground and experience to participate in the
2 work of the consensus committee; and

3 “(ii) 1 member appointed by the Sec-
4 retary to represent the Secretary on the
5 consensus committee, who shall be a non-
6 voting member.

7 “(C) DISAPPROVAL.—The Secretary may
8 disapprove the appointment of an individual
9 under subparagraph (B)(i) only if the Secretary
10 makes a finding, in writing, that—

11 “(i) the appointment was not made in
12 accordance with subparagraph (D); or

13 “(ii) the individual is not qualified to
14 represent the interest category referred to
15 in subparagraph (D) for which the individ-
16 ual has been appointed.

17 “(D) SELECTION PROCEDURES AND RE-
18 QUIREMENTS.—Each member shall be ap-
19 pointed in accordance with the selection proce-
20 dures, which shall be established by the Sec-
21 retary and which shall be based on the proce-
22 dures for consensus committees promulgated by
23 the American National Standards Institute (or
24 successor organization), except that the Amer-
25 ican National Standards Institute interest cat-

1 egories shall be modified for purposes of this
2 paragraph to ensure equal representation on
3 the consensus committee of the following inter-
4 est categories:

5 “(i) Manufacturers.

6 “(ii) Retailers, insurers, suppliers,
7 lenders, community owners, and private in-
8 spection agencies that have a financial in-
9 terest in the manufactured housing indus-
10 try.

11 “(iii) Homeowners and consumer rep-
12 resentatives.

13 “(iv) Public officials, including those
14 from State agencies or local building code
15 enforcement and inspection agencies.

16 “(v) General interest groups, includ-
17 ing academicians, researchers, architects,
18 engineers, private inspection agencies, and
19 others.

20 “(E) ADDITIONAL QUALIFICATIONS.—

21 “(i) FINANCIAL INTEREST.—No mem-
22 ber appointed under clause (iii), (iv), or (v)
23 of subparagraph (D) may have a signifi-
24 cant financial interest in the manufactured
25 housing industry, unless—

1 “(I) such member is a private in-
2 spection agency; or

3 “(II) such bar to participation is
4 waived by the Secretary in writing.

5 “(ii) LIMITATION ON PRIVATE INSPEC-
6 TION AGENCIES.—The number of members
7 appointed under subparagraph (D)(v) who
8 represent private inspection agencies shall
9 not constitute more than 20 percent of the
10 total number of members appointed under
11 subparagraph (D)(v).

12 “(F) MEETINGS.—The consensus commit-
13 tee shall provide advance notice of each meeting
14 of the consensus committee to the Secretary
15 and publish advance notice of each such meet-
16 ing in the Federal Register. All meetings of the
17 consensus committee shall be open to the pub-
18 lic.

19 “(G) INAPPLICABILITY OF OTHER LAWS.—

20 “(i) ADVISORY COMMITTEE ACT.—The
21 consensus committee shall not be consid-
22 ered to be an advisory committee for pur-
23 poses of the Federal Advisory Committee
24 Act.

1 “(ii) TITLE 18.—The members of the
2 consensus committee shall not be subject
3 to section 203, 205, 207, or 208 of title
4 18, United States Code, to the extent of
5 their proper participation as members of
6 the consensus committee.

7 “(iii) ETHICS IN GOVERNMENT ACT
8 OF 1978.—The Ethics in Government Act
9 of 1978 shall not apply to members of the
10 consensus committee to the extent of their
11 proper participation as members of the
12 consensus committee.

13 “(H) ADMINISTRATION.—The consensus
14 committee and the administering organization
15 shall—

16 “(i) operate in conformance with the
17 procedures established by the American
18 National Standards Institute for the devel-
19 opment and coordination of American Na-
20 tional Standards; and

21 “(ii) apply to the American National
22 Standards Institute and take such other
23 actions as may be necessary to obtain ac-
24 creditation from the American National
25 Standards Institute.

1 “(I) STAFF.—The administering organiza-
2 tion shall, upon the request of the consensus
3 committee, provide reasonable staff resources to
4 the consensus committee.

5 “(J) DATE OF INITIAL APPOINTMENTS.—
6 The initial appointments of all of the members
7 of the consensus committee shall be completed
8 not later than 90 days after the date on which
9 an administration agreement under paragraph
10 (2)(A) is completed with the Council of Amer-
11 ican Building Officials.

12 “(4) REVISIONS.—

13 “(A) IN GENERAL.—Beginning on the date
14 on which all members of the consensus commit-
15 tee are appointed under paragraph (3), the con-
16 sensus committee shall, not less than once dur-
17 ing each 2-year period—

18 “(i) consider revisions to the Federal
19 manufactured home construction and safe-
20 ty standards and procedural and enforce-
21 ment regulations (including the adoption of
22 regulations specifying the permissible scope
23 and conduct of monitoring); and

24 “(ii) submit proposed revised stand-
25 ards and regulations to the Secretary.

1 “(B) PUBLICATION OF PROPOSED REVISED
2 STANDARDS AND REGULATIONS.—Before sub-
3 mitting any proposed revised standard or regu-
4 lation under subparagraph (A)(ii), the consen-
5 sus committee shall—

6 “(i) cause to be published in the Fed-
7 eral Register a notice of the proposed re-
8 vised standard or regulation and a descrip-
9 tion of the considerations and decisions of
10 the consensus committee under subsection
11 (e); and

12 “(ii) provide an opportunity for public
13 comment on such proposed revised stand-
14 ard or regulation.

15 “(C) PRESENTATION OF PUBLIC COM-
16 MENTS.—Any public comments, views, and ob-
17 jections to a proposed revised standard or regu-
18 lation published under subparagraph (B) shall
19 be presented to the consensus committee in ac-
20 cordance with procedures established by the
21 American National Standards Institute. The
22 consensus committee shall cause to be published
23 in the Federal Register a notice of the rec-
24 ommended revisions of the consensus committee
25 to the standard or regulation, a notice of the

1 submission of the recommended revisions to the
2 Secretary, and a description of the cir-
3 cumstances under which the proposed revised
4 standards or regulations could become effective.

5 “(5) REVIEW BY THE SECRETARY.—

6 “(A) IN GENERAL.—The Secretary shall
7 either adopt, modify, or reject a standard or
8 regulation, as submitted by the consensus com-
9 mittee under paragraph (4)(A).

10 “(B) TIMING.—Not later than 12 months
11 after the date on which a standard or regula-
12 tion is submitted to the Secretary by the con-
13 sensus committee, the Secretary shall take ac-
14 tion regarding such standard or regulation
15 under subparagraph (C).

16 “(C) PROCEDURES.—If the Secretary—

17 “(i) adopts a standard or regulation
18 recommended by the consensus committee,
19 the Secretary shall—

20 “(I) issue a final order without
21 further rulemaking; and

22 “(II) cause the final order to be
23 published in the Federal Register;

24 “(ii) determines that any standard or
25 regulation should be rejected because the

1 implementation of such standard or regula-
2 tion would jeopardize public health or safe-
3 ty or is inconsistent with the purposes of
4 this title, the Secretary shall—

5 “(I) reject the standard or regula-
6 tion; and

7 “(II) cause to be published in the
8 Federal Register a notice to that ef-
9 fect, together with the reason or rea-
10 sons for rejecting the proposed stand-
11 ard or regulation; or

12 “(iii) determines that a standard or
13 regulation recommended by the consensus
14 committee should be modified because the
15 implementation of such standard or regula-
16 tion would jeopardize public health or safe-
17 ty or is inconsistent with the purposes of
18 this title, the Secretary shall—

19 “(I) cause the proposed modified
20 standard or regulation to be published
21 in the Federal Register, together with
22 an explanation of the reason or rea-
23 sons for the determination of the Sec-
24 retary; and

1 “(II) provide an opportunity for
2 public comment in accordance with
3 section 553 of title 5, United States
4 Code.

5 “(D) FINAL ORDER.—Any final standard
6 or regulation under this paragraph shall become
7 effective pursuant to subsection (c).

8 “(6) FAILURE TO ACT.—If the Secretary fails
9 to take final action under paragraph (5) and to pub-
10 lish notice of the action in the Federal Register be-
11 fore the expiration of the 12-month period beginning
12 on the date on which the proposed standard or regu-
13 lation is submitted to the Secretary under paragraph
14 (4)(A)—

15 “(A) the recommendations of the consen-
16 sus committee—

17 “(i) shall be considered to have been
18 adopted by the Secretary; and

19 “(ii) shall take effect upon the expira-
20 tion of the 180-day period that begins
21 upon the conclusion of such 12-month pe-
22 riod; and

23 “(B) not later than 10 days after the expi-
24 ration of such 12-month period, the Secretary
25 shall cause to be published in the Federal Reg-

1 ister a notice of the failure of the Secretary to
2 act, the revised standard or regulation, and the
3 effective date of the revised standard or regula-
4 tion, which notice shall be deemed to be an
5 order of the Secretary approving the revised
6 standards or regulations proposed by the con-
7 sensus committee.

8 “(7) INTERPRETIVE BULLETINS.—The Sec-
9 retary may issue interpretive bulletins to clarify the
10 meaning of any Federal manufactured home con-
11 struction and safety standard or procedural and en-
12 forcement regulation, subject to the following re-
13 quirements:

14 “(A) REVIEW BY CONSENSUS COMMIT-
15 TEE.—Before issuing an interpretive bulletin—

16 “(i) the Secretary shall—

17 “(I) submit the proposed bulletin
18 to the consensus committee; and

19 “(II) provide the consensus com-
20 mittee with a period of 90 days to
21 provide written comments on the pro-
22 posed bulletin to the Secretary; and

23 “(ii) if the Secretary rejects any sig-
24 nificant comment provided by the consen-

1 sus committee under clause (i), the Sec-
2 retary shall—

3 “(I) provide a written expla-
4 nation of the reasons for the rejection
5 to the consensus committee;

6 “(II) cause the proposed bulletin
7 and the consensus committee’s written
8 comments to be published in the Fed-
9 eral Register; and

10 “(III) provide an opportunity for
11 public comment in accordance with
12 section 553 of title 5, United States
13 Code.

14 “(B) PROPOSALS.—

15 “(i) IN GENERAL.—The consensus
16 committee may submit to the Secretary a
17 proposed interpretive bulletin under this
18 paragraph.

19 “(ii) AUTOMATIC APPROVAL.—If the
20 Secretary fails to issue or rejects a pro-
21 posed interpretive bulletin submitted under
22 clause (i) before the expiration of the 90-
23 day period beginning on the date on which
24 the bulletin is submitted to the Secretary
25 under clause (i), the Secretary shall—

1 “(I) be considered to have ap-
2 proved the bulletin; and

3 “(II) immediately issue the bul-
4 letin.

5 “(b) OTHER ORDERS.—

6 “(1) IN GENERAL.—If the Secretary deter-
7 mines, in writing, that such action is necessary in
8 order to respond to a public health or safety emer-
9 gency, or to address an issue on which the Secretary
10 determines the consensus committee will not make a
11 timely recommendation, the Secretary may issue an
12 order that is not developed under the procedures set
13 forth in subsection (a), if the Secretary—

14 “(A) first submits the proposed order to
15 the consensus committee for review; and

16 “(B) in the case of an order addressing an
17 issue on which the Secretary determines that
18 the consensus committee will not make a timely
19 recommendation, affords the consensus commit-
20 tee 90 days to provide the views of the consen-
21 sus committee on the proposed order to the
22 Secretary.

23 “(2) EXPLANATION REQUIRED.—If the consen-
24 sus committee fails to act before the expiration of
25 the 90-day period described in paragraph (1)(B) or

1 if the Secretary rejects any significant change rec-
2 ommended by the consensus committee under such
3 paragraph, the public notice of an order issued
4 under paragraph (1) shall include an explanation of
5 the reasons for such failure or rejection.

6 “(3) RULEMAKING PROCEDURES.—The Sec-
7 retary may issue an order under this subsection only
8 in accordance with section 553 of title 5, United
9 States Code.”;

10 (2) in subsection (d), by adding at the end the
11 following: “Federal preemption under this subsection
12 shall be broadly and liberally construed. It shall be
13 the duty of the Secretary to ensure that disparate
14 State or local requirements or standards do not af-
15 fect the uniformity and comprehensiveness of the
16 standards promulgated hereunder. Nothing in the
17 preceding sentence shall affect any person’s right to
18 enforce the provisions of this subsection in any court
19 of competent jurisdiction. There is reserved to each
20 State the right to establish standards for the instal-
21 lation of manufactured homes sited within that
22 State and the right to enforce compliance with such
23 standards: *Provided*, That such standards shall be
24 consistent with the purposes of this title and with

1 the applicable manufacturers' installation instruc-
2 tions.”;

3 (3) by striking subsection (e);

4 (4) in subsection (f), by striking the matter pre-
5 ceding paragraph (1) and inserting the following:

6 “(e) CONSIDERATIONS IN ESTABLISHING AND IN-
7 TERPRETING STANDARDS AND REGULATIONS.—The con-
8 sensus committee, in recommending standards, regula-
9 tions, and interpretations, and the Secretary, in establish-
10 ing standards or regulations, or issuing interpretations
11 under this section, shall—”;

12 (5) by striking subsection (g);

13 (6) in the first sentence of subsection (j), by
14 striking “subsection (f)” and inserting “subsection
15 (e)”; and

16 (7) by redesignating subsections (h), (i), and
17 (j), as subsections (f), (g), and (h), respectively.

18 **SEC. 705. ABOLISHMENT OF NATIONAL MANUFACTURED**

19 **HOME ADVISORY COUNCIL.**

20 Section 605 (42 U.S.C. 5404) is hereby repealed.

21 **SEC. 706. PUBLIC INFORMATION.**

22 Section 607 (42 U.S.C. 5406) is amended—

23 (1) in subsection (a)—

24 (A) by inserting “to the Secretary” after
25 “submit”; and

1 (B) by adding at the end the following:

2 “The Secretary shall submit such cost and
3 other information to the consensus committee
4 for evaluation.”;

5 (2) in subsection (d), by inserting “, the con-
6 sensus committee,” after “public”; and

7 (3) by striking subsection (c) and redesignating
8 subsections (d) and (e) as subsections (c) and (d),
9 respectively.

10 **SEC. 707. FEES.**

11 Section 620 (42 U.S.C. 5419) is amended to read as
12 follows:

13 “AUTHORITY TO ESTABLISH FEES

14 “SEC. 620. (a) IN GENERAL.—In carrying out in-
15 spections under this title, in developing standards and reg-
16 ulations pursuant to section 604, and in promoting the
17 affordability and availability of manufactured housing, the
18 Secretary may—

19 “(1) establish and collect from manufactured
20 home manufacturers, distributors, and retailers such
21 reasonable fees as may be necessary to offset the ex-
22 penses incurred by the Secretary in connection
23 with—

24 “(A) conducting those inspections;

25 “(B) administering the consensus commit-
26 tee as set forth in section 604;

1 “(C) providing the funding for a noncareer
2 administrator for the manufactured housing
3 program; and

4 “(D) promoting the availability of afford-
5 able manufactured homes to increase home-
6 ownership for all Americans; and

7 “(2) use any fees collected under paragraph (1)
8 to pay expenses referred to in subparagraphs (A),
9 (B), (C), and (D) of paragraph (1), which shall be
10 exempt and separate from any limitations on the
11 Department of Housing and Urban Development re-
12 garding full-time equivalent positions and travel.

13 “(b) PROHIBITED USE.—Neither the Secretary, an
14 agent of the Secretary, nor the States under section 623
15 of this title may use any fees collected under subsection
16 (a) for any purpose or activities not specifically authorized
17 by this title.

18 “(c) MODIFICATION.—Any fee established by the Sec-
19 retary under this section shall only be modified pursuant
20 to rulemaking in accordance with section 553 of title 5,
21 United States Code.

22 “(d) APPROPRIATION AND DEPOSIT OF FEES.—

23 “(1) IN GENERAL.—There is established in the
24 Treasury of the United States a fund to be known

1 as the ‘Manufactured Housing Fees Fund’ for de-
2 posit of all fees collected pursuant to subsection (a).

3 “(2) APPROPRIATION.—Such fees shall be avail-
4 able for expenditure only to the extent approved in
5 an annual appropriations Act.”.

6 **SEC. 708. ELIMINATION OF ANNUAL REPORT REQUIRE-**
7 **MENT.**

8 The National Manufactured Housing Construction
9 and Safety Standards Act of 1974 is amended—

10 (1) by striking section 626 (42 U.S.C. 5425);

11 and

12 (2) by redesignating sections 627 and 628 (42
13 U.S.C. 5426, 5401 note) as sections 626 and 627,
14 respectively.

15 **SEC. 709. EFFECTIVE DATE.**

16 The amendments made by this title shall take effect
17 on the date of enactment of this Act, except that the
18 amendments shall have no effect on any order or interpre-
19 tive bulletin that is published as a proposed rule pursuant
20 to section 553 of title 5, United States Code, on or before
21 such date.

22 **SEC. 710. SAVINGS PROVISION.**

23 The Federal manufactured home construction and
24 safety standards (as such term is defined in section 603
25 of the National Manufactured Housing Construction and

1 Safety Standards Act of 1974) in effect immediately be-
2 fore the date of the enactment of this Act shall apply until
3 the effective date of the Federal manufactured home con-
4 struction and safety standards promulgated under sub-
5 section (a) or (b) of section 604 of the National Manufac-
6 tured Housing Construction and Safety Standards Act of
7 1974, as amended by this title.

8 **TITLE VIII—INDIAN HOUSING**
9 **HOMEOWNERSHIP**

10 **SEC. 801. INDIAN LANDS STATUS COMMISSION.**

11 (a) ESTABLISHMENT.—There is hereby established a
12 Commission to be known as the Indian Lands Status
13 Commission (hereafter in this section referred to as the
14 “Commission”).

15 (b) MEMBERSHIP.—

16 (1) APPOINTMENT.—The Commission shall be
17 composed of 12 members, appointed not later than
18 90 days after the date of the enactment of this Act
19 as follows:

20 (A) 4 members shall be appointed by the
21 President.

22 (B) 4 members shall be appointed by the
23 Chairman of the Committee on Banking and
24 Financial Services of the House of Representa-
25 tives.

1 (C) 4 members shall be appointed by the
2 Chairman of the Committee on Banking, Hous-
3 ing, and Urban Affairs of the Senate.

4 (2) QUALIFICATIONS.—At all times, not less
5 than 7 of the members of the Commission shall be
6 members of federally recognized Indian tribes.

7 (3) CHAIRMAN.—The Chairman of the Commis-
8 sion shall be one of the members of the Commission
9 appointed under paragraph (1)(C), as elected by the
10 members of the Commission.

11 (4) VACANCIES.—Any vacancy on the Commis-
12 sion shall not affect its powers, but shall be filled in
13 the manner in which the original appointment was
14 made.

15 (5) TRAVEL EXPENSES.—Members of the Com-
16 mission shall serve without pay, but each member
17 shall receive travel expenses, including per diem in
18 lieu of subsistence, in accordance with sections 5702
19 and 5703 of title 5, United States Code.

20 (c) FUNCTIONS.—The Commission shall analyze the
21 system of the Bureau of Indian Affairs of the Department
22 of the Interior for maintaining land ownership records and
23 title documents and issuing certified title status reports
24 relating to Indian trust lands and, pursuant to such analy-
25 sis, determine how best to improve or replace the system—

1 (1) to ensure prompt and accurate responses to
2 requests for title status reports;

3 (2) to eliminate any backlog of requests for title
4 status reports; and

5 (3) to ensure that the administration of the sys-
6 tem will not in any way impair or restrict the ability
7 of Native Americans to obtain conventional loans for
8 purchase of residences located on Indian trust lands,
9 including any actions necessary to ensure that the
10 system will promptly be able to meet future demands
11 for certified title status reports, taking into account
12 the anticipated complexity and volume of such re-
13 quests.

14 (d) REPORT.—Not later than the date of the termi-
15 nation of the Commission under subsection (g), the Com-
16 mission shall submit a report to the Committee on Bank-
17 ing and Financial Services of the House of Representa-
18 tives and the Committee on Banking, Housing, and Urban
19 Affairs of the Senate describing the analysis and deter-
20 minations made under subsection (c).

21 (e) POWERS.—

22 (1) HEARINGS AND SESSIONS.—The Commis-
23 sion may, for the purpose of carrying out this sec-
24 tion, hold hearings, sit and act at times and places,

1 take testimony, and receive evidence as the Commis-
2 sion considers appropriate.

3 (2) STAFF OF FEDERAL AGENCIES.—Upon re-
4 quest of the Commission, the head of any Federal
5 department or agency may detail, on a reimbursable
6 basis, any of the personnel of that department or
7 agency to the Commission to assist it in carrying out
8 its duties under this section.

9 (3) OBTAINING OFFICIAL DATA.—The Commis-
10 sion may secure directly from any department or
11 agency of the United States information necessary
12 to enable it to carry out this section. Upon request
13 of the Chairperson of the Commission, the head of
14 that department or agency shall furnish that infor-
15 mation to the Commission.

16 (4) MAILS.—The Commission may use the
17 United States mails in the same manner and under
18 the same conditions as other departments and agen-
19 cies of the United States.

20 (5) ADMINISTRATIVE SUPPORT SERVICES.—
21 Upon the request of the Commission, the Adminis-
22 trator of General Services shall provide to the Com-
23 mission, on a reimbursable basis, the administrative
24 support services necessary for the Commission to
25 carry out its responsibilities under this section.

1 (6) STAFF.—The Commission may appoint per-
2 sonnel as it considers appropriate, subject to the
3 provisions of title 5, United States Code, governing
4 appointments in the competitive service, and shall
5 pay such personnel in accordance with the provisions
6 of chapter 51 and subchapter III of chapter 53 of
7 that title relating to classification and General
8 Schedule pay rates.

9 (f) FUNDING.—Of any amounts appropriated for
10 grants under title I of the Native American Housing As-
11 sistance and Self-Determination Act of 1996, \$500,000
12 shall be available to carry out this section.

13 (g) TERMINATION.—The Commission shall terminate
14 upon the expiration of the 1-year period beginning upon
15 the completion of the appointment of all the members of
16 the Commission under subsection (b)(1).
