To amend the Immigration and Nationality Act to eliminate the diversity immigrant program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ELIMINATION OF DIVERSITY IMMIGRANT PRO-**

4 **GRAM.**

5 (a) WORLDWIDE LEVEL OF DIVERSITY IMMI-
6 GRANTS.—Section 201 of the Immigration and National-
7 ity Act (8 U.S.C. 1151) is amended by striking sub-
8 sections (a)(3) and (e).

1 (b) ALLOCATION OF DIVERSITY IMMIGRANT VISAS.—
2 Section 203 of the Immigration and Nationality Act
3 (8 U.S.C. 1153) is amended—

4 (1) by striking subsection (c);

5 (2) in subsection (d), by striking “(a), (b), or
6 (c),” and inserting “(a) or (b),”;

7 (3) in subsection (e), by striking paragraph (2)
8 and redesignating paragraph (3) as paragraph (2);

9 (4) in subsection (f), by striking “(a), (b), or
10 (c)” and inserting “(a) or (b)”; and

11 (5) in subsection (g), by striking “(a), (b), and
12 (c)” and inserting “(a) and (b)”.

13 (c) PROCEDURE FOR GRANTING IMMIGRANT STA-
14 TUS.—Section 204 of the Immigration and Nationality
15 Act (8 U.S.C. 1154) is amended—

16 (1) in subsection (a)(1)(A)(i), by striking “(1),
17 (3),” and inserting “(1)”;

18 (2) by striking subsection (a)(1)(G); and

19 (3) in subsection (e), by striking “(a), (b), or
20 (c)” and inserting “(a) or (b)”.

21 **SEC. 2. EFFECTIVE DATE.**

22 The amendments made by section 1 shall take effect
23 on the first day of the first fiscal year beginning after the
24 date of the enactment of this Act.
