AN ACT

To authorize the construction of temperature control devices
at Folsom Dam in California.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AUTHORIZATION TO CONSTRUCT TEMPERA-**
4 **TURE CONTROL DEVICES.**

5 (a) FOLSOM DAM.—The Secretary of the Interior is
6 hereby authorized to construct in accordance with the
7 draft environmental impact statement/environmental im-
8 pact report for the Central Valley Supply contracts under
9 Public Law 101–514 (section 206) and the report entitled

1 “Assessment of the Beneficial and Adverse Impacts of Op-
2 erating a Temperature Control Device (TCD) at the
3 Water Supply Intakes of Folsom Dam”, a temperature
4 control device on Folsom Dam and necessary associated
5 temperature monitoring facilities. The temperature control
6 device and said associated temperature monitoring facili-
7 ties shall be operated as an integral part of the Central
8 Valley Project for the benefit and propagation of fall-run
9 chinook salmon and steelhead trout in the American River,
10 California.

11 (b) DEVICE ON NON-CVP FACILITIES.—The Sec-
12 retary of the Interior is hereby authorized to construct or
13 assist in the construction of 1 or more temperature control
14 devices on existing non-Federal facilities delivering Cen-
15 tral Valley Project water supplies from Folsom Reservoir
16 and necessary associated temperature monitoring facili-
17 ties. These costs of construction of temperature control
18 device and associated temperature monitoring facilities
19 shall be nonreimbursable and operated by the non-Federal
20 facility owner at its expense, in coordination with the Cen-
21 tral Valley Project for the benefit and propagation of chi-
22 nook salmon and steelhead trout in the American River,
23 California.

24 (c) AUTHORIZATION.—There is hereby authorized to
25 be appropriated for the construction of a temperature con-

1 trol device on Folsom Dam and necessary associated tem-
2 perature monitoring facilities the sum of \$5,000,000 (ad-
3 justed for inflation based on October 1997 prices). There
4 is also authorized to be appropriated for the construction
5 of a temperature control device on existing non-Federal
6 facilities and necessary associated temperature monitoring
7 facilities the sum of \$1,000,000 (October 1997 prices).
8 There is also authorized to be appropriated, in addition
9 thereto, such amounts as are required for operation, main-
10 tenance, and replacement of the temperature control de-
11 vices on Folsom Dam and associated temperature mon-
12 itoring facilities.
