A BILL

To amend the Older Americans Act of 1965 to extend the authorizations of appropriations for that Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AUTHORIZATIONS OF APPROPRIATIONS.**

4 (a) FEDERAL COUNCIL ON THE AGING.—Section
5 204(g) of the Older Americans Act of 1965 (42 U.S.C.
6 3015(g)) is amended by striking “\$300,000 for fiscal year
7 1992 and such sums as may be necessary for fiscal years
8 1993, 1994, and 1995” and inserting “such sums as may
9 be necessary for fiscal years 1999 through 2001”.

10 (b) ADMINISTRATION.—Section 215 of such Act (42
11 U.S.C. 3020f) is amended—

12 (1) in subsection (a), by striking “fiscal years
13 1992, 1993, 1994, and 1995” and inserting “fiscal
14 years 1999 through 2001”; and

15 (2) in subsection (b), by striking paragraph (1)
16 and inserting the following:

17 “(1) \$29,000,000 for each of fiscal years 1999
18 through 2001; and”.

19 (c) GRANTS FOR STATE AND COMMUNITY PROGRAMS
20 ON AGING.—Section 303 of such Act (42 U.S.C. 3023)
21 is amended—

1 (1) in subsection (a)(1), by striking
2 “\$461,376,000 for fiscal year 1992 and such sums
3 as may be necessary for fiscal years 1993, 1994, and
4 1995” and inserting “such sums as may be nec-
5 essary for fiscal years 1999 through 2001”;

6 (2) in subsection (b)—

7 (A) in paragraph (1), by striking
8 “\$505,000,000 for fiscal year 1992 and such
9 sums as may be necessary for fiscal years 1993,
10 1994, and 1995” and inserting “such sums as
11 may be necessary for fiscal years 1999 through
12 2001”;

13 (B) in paragraph (2), by striking
14 “\$120,000,000 for fiscal year 1992 and such
15 sums as may be necessary for fiscal years 1993,
16 1994, and 1995” and inserting “such sums as
17 may be necessary for fiscal years 1999 through
18 2001”; and

19 (C) in paragraph (3), by striking
20 “\$15,000,000 for fiscal year 1992 and such
21 sums as may be necessary for fiscal years 1993,
22 1994, and 1995” and inserting “such sums as
23 may be necessary for fiscal years 1999 through
24 2001”;

1 (3) in subsection (d), by striking “\$45,388,000
2 for fiscal year 1992 and such sums as may be nec-
3 essary for fiscal years 1993, 1994, and 1995” and
4 inserting “such sums as may be necessary for fiscal
5 years 1999 through 2001”;

6 (4) in subsection (e), by striking “the fiscal
7 years 1992, 1993, 1994, and 1995” and inserting
8 “fiscal years 1999 through 2001”;

9 (5) in subsection (f), by striking “\$25,000,000
10 for fiscal year 1992 and such sums as may be nec-
11 essary for fiscal years 1993, 1994, and 1995” and
12 inserting “such sums as may be necessary for fiscal
13 years 1999 through 2001”; and

14 (6) in subsection (g), by striking “\$15,000,000
15 for fiscal year 1992 and such sums as may be nec-
16 essary for fiscal years 1993, 1994, and 1995” and
17 inserting “such sums as may be necessary for fiscal
18 years 1999 through 2001”.

19 (d) AVAILABILITY OF SURPLUS COMMODITIES.—Sec-
20 tion 311(c)(1)(A) of such Act (42 U.S.C. 3030a(c)(1)(A))
21 is amended by striking “\$250,000,000 for fiscal year
22 1992, \$310,000,000 for fiscal year 1993, \$380,000,000
23 for fiscal year 1994, and \$460,000,000 for fiscal year
24 1995” and inserting “\$460,000,000 for each of fiscal
25 years 1999 through 2001”.

1 (e) TRAINING, RESEARCH, AND DISCRETIONARY
2 PROJECTS AND PROGRAMS.—Section 431 of such Act (42
3 U.S.C. 3037) is amended—

4 (1) in subsection (a)(1), by striking
5 “\$72,000,000 for fiscal year 1992, and such sums
6 as may be necessary for fiscal years 1993, 1994, and
7 1995” and inserting “such sums as may be nec-
8 essary for fiscal years 1999 through 2001”; and

9 (2) in subsection (b), by striking “\$450,000 for
10 each of fiscal years 1992, 1993, 1994, and 1995”
11 and inserting “\$450,000 for each of fiscal years
12 1999 through 2001”.

13 (f) COMMUNITY SERVICE EMPLOYMENT FOR OLDER
14 AMERICANS.—Section 508(a)(1) of such Act (42 U.S.C.
15 3056f(a)(1)) is amended by striking “\$470,671,000 for
16 fiscal year 1992, and such sums as may be necessary for
17 fiscal years 1993, 1994, and 1995” and inserting “such
18 sums as may be necessary for fiscal years 1999 through
19 2001”.

20 (g) GRANTS FOR NATIVE AMERICANS.—Section
21 633(a) of such Act (42 U.S.C. 3057n(a)) is amended by
22 striking “\$30,000,000 for fiscal year 1992 and such sums
23 as may be necessary for fiscal years 1993, 1994, and
24 1995” and inserting “such sums as may be necessary for
25 fiscal years 1999 through 2001”.

1 (h) ALLOTMENTS FOR VULNERABLE ELDER RIGHTS
2 PROTECTION ACTIVITIES.—Section 702 of such Act (42
3 U.S.C. 3058a) is amended—

4 (1) in subsection (a), by striking “\$40,000,000
5 for fiscal year 1992 and such sums as may be nec-
6 essary for fiscal years 1993, 1994, and 1995” and
7 inserting “such sums as may be necessary for fiscal
8 years 1999 through 2001”;

9 (2) in subsection (b), by striking “\$15,000,000
10 for fiscal year 1992 and such sums as may be nec-
11 essary for fiscal years 1993, 1994, and 1995” and
12 inserting “such sums as may be necessary for fiscal
13 years 1999 through 2001”;

14 (3) in subsection (c), by striking “\$10,000,000
15 for fiscal year 1992 and such sums as may be nec-
16 essary for fiscal years 1993, 1994, and 1995” and
17 inserting “such sums as may be necessary for fiscal
18 years 1999 through 2001”; and

19 (4) in subsection (d), by striking “\$15,000,000
20 for fiscal year 1992 and such sums as may be nec-
21 essary for fiscal years 1993, 1994, and 1995” and
22 inserting “such sums as may be necessary for fiscal
23 years 1999 through 2001”.

24 (i) NATIVE AMERICAN PROGRAM.—Section 751(d) of
25 such Act (42 U.S.C. 3058aa(d)) is amended by striking

1 “\$5,000,000 for fiscal year 1992, and such sums as may
2 be necessary for fiscal years 1993, 1994, and 1995” and
3 inserting “such sums as may be necessary for fiscal years
4 1999 through 2001”.

5 **SEC. 2. TRANSFERS.**

6 Section 308(b) of the Older Americans Act of 1965
7 (42 U.S.C. 3028(b)) is amended—

8 (1) in paragraph (4)(B)—

9 (A) by striking “fiscal year 1993, 1994,
10 1995, or 1996” and inserting “a fiscal year”;
11 and

12 (B) by striking “need—” and all that fol-
13 lows and inserting “need, an additional 10 per-
14 cent of the funds so received for the fiscal
15 year.”; and

16 (2) in paragraph (5)—

17 (A) in subparagraph (A), by striking “not
18 more than 30 percent for fiscal year 1993, not
19 more than 25 percent for fiscal year 1994, not
20 more than 25 percent for fiscal year 1995, and
21 not more than 20 percent for fiscal year 1996”
22 and inserting “not more than 20 percent for
23 the fiscal year involved”; and

24 (B) in subparagraph (B)—

1 (i) by striking “(B)(i)” and all that
2 follows through “(ii) If” and inserting
3 “(B) If”; and

4 (ii) by striking “for fiscal year 1996”
5 and inserting “for a fiscal year”.
