## A BILL

For the relief of Robert Anthony Broley.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. WAIVER OF GROUNDS FOR REMOVAL OF, OR**  
4 **DENIAL OF ADMISSION TO, ROBERT AN-**  
5 **THONY BROLEY.**

6 (a) IN GENERAL.—Notwithstanding sections 212(a)  
7 and 237(a) of the Immigration and Nationality Act, Rob-  
8 ert Anthony Broley may not be removed or deported from  
9 the United States, or denied admission to the United  
10 States, by reason of any act of his that is a ground for  
11 removal or denial of admission and is reflected in the  
12 records of the Immigration and Naturalization Service of

1 the Department of Justice, or the Visa Office of the De-  
2 partment of State, on the date of the enactment of this  
3 Act.

4 (b) RESCISSION OF OUTSTANDING ORDER OF RE-  
5 MOVAL OR DEPORTATION.—The Attorney General shall  
6 rescind any outstanding order of removal or deportation,  
7 or any finding of deportability or removability, that has  
8 been entered against Robert Anthony Broley by reason of  
9 any act described in subsection (a).

10 (c) PERMANENT RESIDENCE STATUS.—Notwith-  
11 standing any order terminating the status of Robert An-  
12 thony Broley as an alien lawfully admitted for permanent  
13 residence, and subject to subsection (e), for purposes of  
14 the Immigration and Nationality Act he shall be consid-  
15 ered lawfully admitted for permanent residence as of No-  
16 vember 5, 1968, and such status shall be considered not  
17 to have changed between such date and the date of the  
18 enactment of this Act.

19 (d) ESTABLISHMENT OF GOOD MORAL CHAR-  
20 ACTER.—Notwithstanding section 101(f) of the Immigra-  
21 tion and Nationality Act, and subject to subsection (e),  
22 any act described in subsection (a) may not be considered  
23 in determining whether Robert Anthony Broley is, or dur-  
24 ing any period has been, a person of good moral character  
25 for purposes of the Immigration and Nationality Act.

1           (e) INELIGIBILITY FOR NATURALIZATION DURING 5-  
2 YEAR PERIOD.—Notwithstanding section 316(a) of the  
3 Immigration and Nationality Act, Robert Anthony Broley  
4 shall not be considered eligible for naturalization during  
5 the 5-year period beginning on the date of the enactment  
6 of this Act.
