## A BILL

To amend title XVIII of the Social Security Act to ensure the proper payment of approved nursing and paramedical education programs under the Medicare Program.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Medicare Nursing and  
5 Paramedical Education Act of 1998”.

1 **SEC. 2. EXCLUSION OF NURSING AND PARAMEDICAL EDU-**  
2 **CATION COSTS IN CALCULATING**  
3 **MEDICARE+CHOICE PAYMENT RATE.**

4 (a) **EXCLUDING COSTS IN CALCULATING PAYMENT**  
5 **RATE.—**

6 (1) **IN GENERAL.—**Section 1853(c)(3)(C)(i) of  
7 the Social Security Act (42 U.S.C. 1395w–  
8 23(c)(3)(C)(i)) is amended—

9 (A) by striking “and” at the end of sub-  
10 clause (I);

11 (B) by striking the period at the end of  
12 subclause (II) and inserting “, and”; and

13 (C) by adding at the end the following new  
14 subclause:

15 “(III) for costs attributable to  
16 approved nursing and paramedical  
17 education programs under section  
18 1861(v).”.

19 (2) **EFFECTIVE DATE.—**The amendments made  
20 by paragraph (1) apply in determining the annual  
21 per capita rate of payment for years beginning with  
22 2000.

23 (b) **PAYMENT TO HOSPITALS OF NURSING AND**  
24 **PARAMEDICAL EDUCATION PROGRAM COSTS FOR**  
25 **MEDICARE+CHOICE ENROLLEES.—**Section 1886(d) of

1 such Act (42 U.S.C. 1395ww(d)) is amended by adding  
2 at the end the following new paragraph:

3 “(12) ADDITIONAL PAYMENT OF NURSING AND  
4 PARAMEDICAL EDUCATION PROGRAM COSTS FOR  
5 MANAGED CARE ENROLLEES.—

6 “(A) IN GENERAL.—For portions of cost  
7 reporting periods occurring on or after January  
8 1, 2000, the Secretary shall provide for an ad-  
9 ditional payment amount to any subsection (d)  
10 hospital that has approved nursing and para-  
11 medical education programs for each discharge  
12 of any individual who is enrolled under a risk-  
13 sharing contract with an eligible organization  
14 under section 1876 and who is entitled to bene-  
15 fits under part A or any individual who is en-  
16 rolled with a Medicare+Choice organization  
17 under part C.

18 “(B) DETERMINATION OF AMOUNT.—The  
19 amount of the payment under this paragraph  
20 with respect to any applicable discharge shall be  
21 equal to an amount estimated by the Secretary  
22 of the average per discharge amount that would  
23 otherwise have been paid to the subsection (d)  
24 hospital to reflect the costs to the hospital of  
25 approved nursing and paramedical education

1 programs under section 1861(v) if the individ-  
2 uals had not been enrolled as described in sub-  
3 paragraph (A).”.
