1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. VISITOR CENTER FOR HOME OF FRANKLIN D.**

4 **ROOSEVELT NATIONAL HISTORIC SITE.**

5 (a) TRANSFER OF ADMINISTRATIVE JURISDIC-
6 TION.—The Secretary of the Interior may transfer to the
7 Archivist of the United States administrative jurisdiction
8 over land located in the Home of Franklin D. Roosevelt
9 National Historic Site, for use by the Archivist for the
10 construction of a visitor center facility to jointly serve the
11 Home of Franklin D. Roosevelt National Historic Site and
12 the Franklin D. Roosevelt Presidential Library, located in
13 Hyde Park, New York.

14 (b) CONDITIONS OF TRANSFER.—

15 (1) PROTECTION OF THE SITE.—The transfer
16 authorized in subsection (a) shall be subject to an
17 agreement between the Secretary and the Archivist
18 that shall include such provisions for the protection
19 of the Home of Franklin D. Roosevelt National His-
20 toric Site and the joint use of the facility to be con-
21 structed as the Secretary and the Archivist may con-
22 sider necessary.

23 (2) CONSIDERATION.—A transfer made pursu-
24 ant to subsection (a) shall be made without consider-
25 ation or reimbursement.

1 (3) TERMINATION.—If use by the Archivist of
2 the land referred to in subsection (a) is terminated
3 by the Archivist at any time, administrative jurisdic-
4 tion over the land shall automatically revert to the
5 Department of the Interior.

6 (c) DESCRIPTION OF LAND.—The land referred to in
7 subsection (a) shall consist of not more than 1 acre of
8 land as may be mutually agreed to by the Secretary and
9 the Archivist and more particularly described in the agree-
10 ment required under subsection (b)(1).
