A BILL

To remove the restriction on the distribution of certain revenues from the Mineral Springs parcel to certain members of the Agua Caliente Band of Cahuilla Indians.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. REMOVAL OF RESTRICTION ON DISTRIBUTION**
2 **OF CERTAIN REVENUES.**

3 (a) **IN GENERAL.**—The fourth undesignated para-
4 graph in section 3(b) of the Act entitled “An Act to pro-
5 vide for the equalization of allotments on the Agua
6 Caliente (Palm Springs) Reservation in California, and for
7 other purposes” approved September 21, 1959 (25 U.S.C.
8 951 et seq.), is amended by striking “*east. Provided,*” and
9 all that follows through “*deceased member.*” and inserting
10 “*east.*”.

11 (b) **EFFECTIVE DATE.**—The amendment made by
12 subsection (a) shall apply with respect to net rents, prof-
13 its, and other revenues that accrue on or after the date
14 of enactment of this Act.

15 (c) **AGREEMENT TO MAKE PAYMENT.**—The Congress
16 finds that the tribe agrees to make payment in accordance
17 with Tribal Ordinance Number 22 dated August 6, 1996,
18 and shall do so not later than 180 days after the date
19 of the enactment of this Act.

20 **SECTION 1. REMOVAL OF RESTRICTION ON DISTRIBUTION**
21 **OF CERTAIN REVENUES.**

22 (a) *IN GENERAL.*—*The fourth undesignated paragraph*
23 *in section 3(b) of the Act entitled “An Act to provide for*
24 *the equalization of allotments on the Agua Caliente (Palm*
25 *Springs) Reservation in California, and for other purposes”*
26 *approved September 21, 1959 (25 U.S.C. 951 et seq.), is*

1 amended by striking “east: Provided,” and all that follows
2 through “deceased member.” and inserting “east.”.

3 (b) *EFFECTIVE DATE AND AGREEMENT TO MAKE PAY-*
4 *MENT.*—The amendment made by subsection (a) shall apply
5 with respect to net rents, profits, and other revenues that
6 accrue on or after the date of distribution of the payment,
7 as provided in Tribal Ordinance 22 dated August 6, 1996,
8 to those referenced in Exhibit B of Tribal Ordinance 22.
