1 **SECTION 1. REDESIGNATION.**

2 The Federal building located at ~~223~~ Sharkey Street
3 in Clarksdale, Mississippi, shall be known and designated
4 as the “Aaron Henry United States Post Office Building”.

5 **SEC. 2. REFERENCES.**

6 Any reference in a law, map, regulation, document,
7 paper, or other record of the United States to the Federal
8 building referred to in section 1 shall be deemed to be
9 a reference to the “Aaron Henry United States Post
10 Office”.

11 **SECTION 1. DESIGNATION.**

12 *The Federal building located at 236 Sharkey Street in*
13 *Clarksdale, Mississippi, shall be known and designated as*
14 *the “Aaron Henry Federal Building and United States*
15 *Courthouse”.*

16 **SEC. 2. REFERENCES.**

17 *Any reference in a law, map, regulation, document,*
18 *paper, or other record of the United States to the Federal*
19 *building referred to in section 1 shall be deemed to be a*
20 *reference to the “Aaron Henry Federal Building and Unit-*
21 *ed States Courthouse”.*

Amend the title so as to read as follows: “A bill to designate the Federal building located at 236 Sharkey Street in Clarksdale, Mississippi, as the ‘Aaron Henry Federal Building and United States Courthouse’.”.
