Mrs. BOXER (for herself, Mr. BINGAMAN, Mrs. FEINSTEIN, Mr. DASCHLE, Mr. DORGAN, Mr. HARKIN, Mr. WELLSTONE, Mr. CONRAD, Ms. LANDRIEU, Mr. REED, and Mrs. MURRAY) introduced the following bill; which was read twice and referred to the Committee on Banking, Housing, and Urban Affairs

A BILL

To authorize the President to award a congressional gold medal to the family of the late Raul Julia, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS.**

4 The Congress finds that—

5 (1) Raul Julia was an accomplished, talented
6 performer, entertaining millions through his work in
7 film and theater;

1 (2) Raul Julia was a leader in the entertain-
2 ment industry, particularly as a tireless mentor and
3 role model to emerging Latino actors;

4 (3) a dedicated activist and humanitarian, Raul
5 Julia was a major supporter and spokesperson for
6 the Hunger Fund, a nonprofit organization commit-
7 ted to the eradication of world hunger; and

8 (4) Raul Julia received the Hispanic Heritage
9 Award recognizing his many career achievements for
10 the Latino community, including his involvement in
11 “La Familia”, a New York City outreach program
12 for Latino families in need, the Puerto Rican travel-
13 ing theater, the Museo del Barrio, and the New
14 York Shakespeare Festival.

15 **SEC. 2. CONGRESSIONAL GOLD MEDAL.**

16 (a) **PRESENTATION AUTHORIZED.**—The President is
17 authorized to present, on behalf of the Congress, to the
18 family of the late Raul Julia a gold medal of appropriate
19 design, in recognition of his dedication to ending world
20 hunger and his great contributions to the Latino commu-
21 nity and to the performing arts.

22 (b) **DESIGN AND STRIKING.**—For purposes of the
23 presentation referred to in subsection (a), the Secretary
24 of the Treasury (hereafter in this Act referred to as the
25 “Secretary”) shall strike a gold medal with suitable em-

1 blem, devices, and inscriptions to be determined by the
2 Secretary.

3 (c) GIFTS AND DONATIONS.—

4 (1) IN GENERAL.—The Secretary may accept,
5 use, and disburse gifts or donations of property or
6 money to carry out this section.

7 (2) APPROPRIATION AUTHORIZED.—No amount
8 is authorized to be appropriated to carry out this
9 section.

10 **SEC. 3. DUPLICATE MEDALS.**

11 The Secretary may strike and sell duplicates in
12 bronze of the gold medal struck pursuant to section 2
13 under such regulations as the Secretary may prescribe, at
14 a price sufficient to cover the cost thereof, including labor,
15 materials, dies, use of machinery, and overhead expenses,
16 and the cost of the gold medal.

17 **SEC. 4. STATUS OF MEDALS.**

18 The medals struck pursuant to this Act are—

19 (1) national medals, for purposes of chapter 51
20 of title 31, United States Code; and

21 (2) numismatic items, for purposes of section
22 5134 of title 31, United States Code.

1 **SEC. 5. TRANSFER OF ANY PROFIT TO LIBRARY OF CON-**
2 **GRESS.**

3 The Secretary shall transfer in equal amounts from
4 the Numismatic Public Enterprise Fund an amount equal
5 to the amount by which the sum of any gifts and donations
6 received by the Secretary in accordance with section
7 2(c)(1) and any proceeds from the sale of duplicate medals
8 pursuant to section 3 exceeds the total amount of the costs
9 incurred by the Secretary in carrying out this Act to—
10 (1) the Raul Julia Ending Hunger Fund; and
11 (2) the National Hispanic Foundation for the
12 Arts.
