To reauthorize the North American Wetlands Conservation
Act and the Partnerships for Wildlife Act.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Wetlands and Wildlife
5 Enhancement Act of 1998”.

6 **SEC. 2. REAUTHORIZATION OF NORTH AMERICAN**
7 **WETLANDS CONSERVATION ACT.**

8 Section 7(c) of the North American Wetlands Con-
9 servation Act (16 U.S.C. 4406(c)) is amended by striking
10 “not to exceed” and all that follows and inserting “not
11 to exceed \$30,000,000 for each of fiscal years 1999
12 through 2003.”.

13 **SEC. 3. REAUTHORIZATION OF PARTNERSHIPS FOR**
14 **WILDLIFE ACT.**

15 Section 7105(h) of the Partnerships for Wildlife Act
16 (16 U.S.C. 3744(h)) is amended by striking “for each of
17 fiscal years” and all that follows and inserting “not to ex-
18 ceed \$6,250,000 for each of fiscal years 1999 through
19 2003.”.
