1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. ADDITION OF THE PAOLI BATTLEFIELD SITE**
 2 **TO VALLEY FORGE NATIONAL HISTORICAL**
 3 **PARK.**

4 Section 2(a) of Public Law 94-337 (16 U.S.C.
 5 410aa-1(a)) is amended in the first sentence by striking
 6 “which shall” and inserting “and the area known as the
 7 ‘Paoli Battlefield’, located in the borough of Malvern,
 8 Pennsylvania, as depicted on the map numbered ____ and
 9 dated ____ (referred to in this Act as the ‘Paoli Battle-
 10 field’), which maps shall”.

11 **SEC. 2. COOPERATIVE MANAGEMENT OF PAOLI BATTLE-**
 12 **FIELD.**

13 Section 3 of Public Law (16 U.S.C. 410aa-2), is
 14 amended by adding at the end the following: “The Sec-
 15 retary may enter into a cooperative agreement with the
 16 borough of Malvern, Pennsylvania for the management by
 17 the borough of the Paoli Battlefield.”.

18 **SEC. 3. ACQUISITION OF LAND FOR PAOLI BATTLEFIELD.**

19 Section 4(a) of Public Law 94-337 (16 U.S.C.
 20 410aa-3) is amended by striking “not more than
 21 \$13,895,000 for the acquisition of lands and interests in
 22 lands” and inserting “not more than—

23 “(1) \$13,895,000 for the acquisition of land
 24 and interests in land; and

25 “(2) if non-Federal funds in the amount of not
 26 less than \$1,000,000 are available for the acquisi-

1 tion and donation to the National Park Service of
2 land and interests in land within the Paoli Battle-
3 field, \$2,500,000 for the acquisition of land and in-
4 terests in land within the Paoli Battlefield”.

5 **SECTION 1. STUDY.**

6 (a) *IN GENERAL.*—Not later than 18 months after the
7 date on which funds are made available for the purpose,
8 the Secretary of the Interior shall submit to the Committee
9 on Energy and Natural Resources of the Senate and the
10 Committee on Resources of the House of Representatives a
11 resource study of the Paoli Battlefield Site and the Brandy-
12 wine Battlefield Site in Pennsylvania.

13 (b) *CONTENTS.*—The study under subsection (a)
14 shall—

15 (1) *identify the full range of resources and his-*
16 *toric themes associated with the battlefields and their*
17 *relationship to the American Revolutionary War and*
18 *the Valley Forge National Historical Park; and*

19 (2) *identify alternatives for National Park Serv-*
20 *ice involvement at the sites and include cost estimates*
21 *for any necessary acquisition, development, interpre-*
22 *tation, operation, and maintenance associated with*
23 *the alternatives identified.*

1 **SEC. 2. AUTHORIZATION OF APPROPRIATIONS.**

2 *There are authorized to be appropriated such sums as*

3 *may be necessary to carry out the purposes of this Act.*
