CONCURRENT RESOLUTION

1 *Resolved by the House of Representatives (the Senate*
2 *concurring),*

1 **SECTION 1. AUTHORIZATION OF TORCH RUN THROUGH**
2 **CAPITOL GROUNDS.**

3 Special Olympics (in this resolution referred to as the
4 “sponsor”) shall be permitted to sponsor a public event,
5 the Law Enforcement Torch Run for the 1999 Special
6 Olympics World Games (in this resolution referred to as
7 the “event”), on the Capitol Grounds on June 18, 1999,
8 or on such other date as the Speaker of the House of Rep-
9 resentatives and the Committee on Rules and Administra-
10 tion of the Senate may jointly designate.

11 **SEC. 2. TERMS AND CONDITIONS.**

12 (a) IN GENERAL.—The event shall be free of admis-
13 sion charge to the public and arranged not to interfere
14 with the needs of Congress, under conditions to be pre-
15 scribed by the Architect of the Capitol and the Capitol
16 Police Board.

17 (b) EXPENSES AND LIABILITIES.—The sponsor shall
18 assume full responsibility for all expenses and liabilities
19 incident to all activities associated with the event.

20 **SEC. 3. STRUCTURES AND EQUIPMENT.**

21 (a) STRUCTURES AND EQUIPMENT.—Subject to the
22 approval of the Architect of the Capitol, the sponsor may
23 erect upon the Capitol Grounds such stage, sound amplifi-
24 cation devices, and other related structures and equipment
25 as may be required for the event.

1 (b) ADDITIONAL ARRANGEMENTS.—The Architect of
2 the Capitol and the Capitol Police Board are authorized
3 to make any such additional arrangements as may be re-
4 quired to carry out the event.

5 **SEC. 4. ENFORCEMENT OF RESTRICTIONS.**

6 The Capitol Police Board shall provide for enforce-
7 ment of the restrictions contained in section 4 of the Act
8 of July 31, 1946 (40 U.S.C. 193d; 60 Stat. 718), con-
9 cerning sales, displays, advertisements, and solicitations
10 on the Capitol Grounds, as well as other restrictions appli-
11 cable to the Capitol Grounds, with respect to the event.

12 **SEC. 5. LIMITATIONS ON REPRESENTATIONS.**

13 (a) IN GENERAL.—No person may represent, either
14 directly or indirectly, that this resolution or any activity
15 carried out under this resolution in any way constitutes
16 approval or endorsement by the Federal Government of
17 any person or any product or service.

18 (b) ENFORCEMENT.—The Architect of the Capitol
19 and the Capitol Police Board shall enter into an agree-
20 ment with the sponsor, and such other persons partici-
21 pating in the event authorized by section 1 as the Archi-
22 tect of the Capitol and the Capitol Police Board consider
23 appropriate, under which such persons shall agree to com-
24 ply with the requirements of subsection (a). The agree-
25 ment shall specifically prohibit the use of any photograph

1 taken at the event for a commercial purpose and shall pro-
2 vide for the imposition of financial penalties if any viola-
3 tions of the agreement occur.
