## A BILL

To authorize the Secretary of the Interior to transfer administrative jurisdiction over land within the boundaries of the Home of Franklin D. Roosevelt National Historic Site to the Archivist of the United States for the construction of a visitor center.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. VISITOR CENTER FOR HOME OF FRANKLIN D.**

4                   **ROOSEVELT NATIONAL HISTORIC SITE, HYDE**

5                   **PARK, NEW YORK.**

6       (a) TRANSFER OF ADMINISTRATIVE JURISDIC-  
7 TION.—The Secretary of the Interior may transfer to the

1 Archivist of the United States administrative jurisdiction  
2 over land located in the Home of Franklin D. Roosevelt  
3 National Historic Site, for use by the Archivist for the  
4 construction of a visitor center facility to jointly serve the  
5 Home of Franklin D. Roosevelt National Historic Site and  
6 the Franklin D. Roosevelt Presidential Library, located in  
7 Hyde Park, New York.

8 (b) CONDITIONS OF TRANSFER.—

9 (1) PROTECTION OF HISTORIC SITE.—The  
10 transfer authorized in subsection (a) shall be subject  
11 to an agreement between the Secretary and the Ar-  
12 chivist that shall include such provisions for the pro-  
13 tection of the Home of Franklin D. Roosevelt Na-  
14 tional Historic Site and the joint use of the facility  
15 to be constructed as the Secretary and the Archivist  
16 may consider necessary.

17 (2) CONSIDERATION.—A transfer made pursu-  
18 ant to subsection (a) shall be made without consider-  
19 ation or reimbursement.

20 (3) TERMINATION.—If use by the Archivist of  
21 the land referred to in subsection (a) is terminated  
22 by the Archivist at any time, administrative jurisdic-  
23 tion over the land shall automatically revert to the  
24 Department of the Interior.

1           (c) DESCRIPTION OF LAND.—The land referred to in  
2 subsection (a) shall consist of not more than 1 acre of  
3 land as may be mutually agreed to by the Secretary and  
4 the Archivist and more particularly described in the agree-  
5 ment required under subsection (b)(1).
