**AN ACT**

To designate certain facilities of the United States Postal Service in Chicago, Illinois.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CARDISS COLLINS POST OFFICE BUILDING.**

4 (a) DESIGNATION.—The facility of the United States  
5 Postal Service located at 433 West Harrison Street in Chi-  
6 cago, Illinois, is hereby designated as the “Cardiss Collins  
7 Post Office Building”.

8 (b) REFERENCES.—Any reference to such facility in  
9 a law, regulation, map, document, paper, or other record

1 of the United States shall be considered to be a reference  
2 to the “Cardiss Collins Post Office Building”.

3 **SEC. 2. OTIS GRANT COLLINS POST OFFICE BUILDING.**

4 (a) DESIGNATION.—The facility of the United States  
5 Postal Service located at 2302 South Pulaski Street in  
6 Chicago, Illinois, is hereby designated as the “Otis Grant  
7 Collins Post Office Building”.

8 (b) REFERENCES.—Any reference to such facility in  
9 a law, regulation, map, document, paper, or other record  
10 of the United States shall be considered to be a reference  
11 to the “Otis Grant Collins Post Office Building”.

12 **SEC. 3. MARY ALICE (MA) HENRY POST OFFICE BUILDING.**

13 (a) DESIGNATION.—The facility of the United States  
14 Postal Service located at 4222 West Madison Street in  
15 Chicago, Illinois, is hereby designated as the “Mary Alice  
16 (Ma) Henry Post Office Building”.

17 (b) REFERENCES.—Any reference to such facility in  
18 a law, regulation, map, document, paper, or other record  
19 of the United States shall be considered to be a reference  
20 to the “Mary Alice (Ma) Henry Post Office Building”.

21 **SEC. 4. ROBERT LEFLORE, JR. POST OFFICE BUILDING.**

22 (a) DESIGNATION.—The facility of the United States  
23 Postal Service located at 50001 West Division Street in  
24 Chicago, Illinois, is hereby designated as the “Robert  
25 LeFlore, Jr. Post Office Building”.

1           (b) REFERENCES.—Any reference to such facility in  
2 a law, regulation, map, document, paper, or other record  
3 of the United States shall be considered to be a reference  
4 to the “Robert LeFlore, Jr. Post Office Building”.
