1 **SECTION 1. DESIGNATION.**

2 The United States courthouse building located at 402
3 North Walnut Street and Prospect Avenue in Harrison,
4 Arkansas, is hereby designated as the “Judge J. Smith
5 Henley Federal Building”.

6 **SEC. 2. REFERENCES.**

7 Any reference in a law, regulation, map, document,
8 paper, or other record of the United States to the United
9 States courthouse building referred to in section 1 shall
10 be considered to be a reference to the “Judge J. Smith
11 Henley Federal Building”.

12 **SECTION 1. DESIGNATION.**

13 *The Federal building and United States courthouse lo-*
14 *cated at 402 North Walnut Street in Harrison, Arkansas,*
15 *shall be known and designated as the “J. Smith Henley*
16 *Federal Building and United States Courthouse”.*

17 **SEC. 2. REFERENCES.**

18 *Any reference in a law, map, regulation, document,*
19 *paper, or other record of the United States to the Federal*
20 *building and United States courthouse referred to in section*
21 *1 shall be deemed to be a reference to the “J. Smith Henley*
22 *Federal Building and United States Courthouse”.*

Amend the title so as to read: “A bill to designate the Federal building and United States courthouse located at 402 North Walnut Street in Harrison, Arkansas, as the ‘J. Smith Henley Federal Building and United States Courthouse’.”.
