

## ***In the Senate of the United States,***

*February 24, 2000.*

*Resolved,* That the bill from the House of Representatives (H.R. 1883) entitled “An Act to provide for the application of measures to foreign persons who transfer to Iran certain goods, services, or technology, and for other purposes.”, do pass with the following
