## AN ACT

Making appropriations for the Legislative Branch for the fiscal year ending September 30, 2000, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*  
3 That the following sums are appropriated, out of any  
4 money in the Treasury not otherwise appropriated, for the  
5 Legislative Branch for the fiscal year ending September  
6 30, 2000, and for other purposes, namely:

9                               *EXPENSE ALLOWANCES*

10       *For expense allowances of the Vice President, \$10,000;*  
11 *the President Pro Tempore of the Senate, \$10,000; Majority*  
12 *Leader of the Senate, \$10,000; Minority Leader of the Sen-*

1 *ate, \$10,000; Majority Whip of the Senate, \$5,000; Minority*  
2 *Whip of the Senate, \$5,000; and Chairmen of the Majority*  
3 *and Minority Conference Committees, \$3,000 for each*  
4 *Chairman; in all, \$56,000.*

5 *REPRESENTATION ALLOWANCES FOR THE MAJORITY AND*  
6 *MINORITY LEADERS*

5       *SEC. 2. Effective on and after October 1, 1999, each*  
6       *of the dollar amounts contained in the table under section*  
7       *105(d)(1)(A) of the Legislative Branch Appropriations Act,*  
8       *1968 (2 U.S.C. 61–1(d)(1)(A)) shall be deemed to be the*  
9       *dollar amounts in that table, as increased by section 8 of*  
10       *Public Law 105–275, increased by an additional \$50,000*  
11       *each.*

12       *SEC. 3. SENATE OFFICE SPACE ALLOCATIONS. Section*  
13       *3 under the heading “ADMINISTRATIVE PROVISIONS” in the*  
14       *appropriation for the Senate in the Legislative Branch Ap-*  
15       *propriations Act, 1975 (2 U.S.C. 59; 88 Stat. 428) is*  
16       *amended—*

17               *(1) in subsection (b)—*

18                       *(A) by striking paragraphs (1) and (2) and*  
19               *inserting the following:*

20                       *“(1) 5,000 square feet if the population of the*  
21               *State of the Senator is less than 3,000,000;”;*

22                       *(B) by striking “8,000” in paragraph (13)*  
23               *and inserting “8,200”; and*

1           (C) by redesignating paragraphs (3)  
2 through (13) as paragraphs (2) through (12), re-  
3 spectively; and

4 (2) in subsection (c)(2)—

5           (A) by striking “\$30,000” and inserting  
6 “\$40,000”;

7           (B) by striking “4,800” and inserting  
8 “5,000”;

9           (C) by striking “\$734” and inserting  
10 “\$1,000”; and

11           (D) by adding at the end the following: “Ef-  
12 fective beginning with the 106th Congress, the  
13 aggregate amount in effect under this paragraph  
14 for any Congress shall be increased by the infla-  
15 tion adjustment factor for the calendar year in  
16 which the Congress begins. For purposes of the  
17 preceding sentence, the inflation adjustment fac-  
18 tor for any calendar year is a fraction the nu-  
19 merator of which is the implicit price deflator  
20 for the gross domestic product as computed and  
21 published by the Department of Commerce for  
22 the preceding calendar year and the denominator  
23 of which is such deflator for the calendar year  
24 1998.”.

1        *SEC. 4. Section 6(c) of the Legislative Branch Appro-*  
2 *priations Act, 1999 (Public Law 105–275; 2 U.S.C. 121b–*  
3 *1(c)) is amended by adding at the end the following:*

4        *“(3) The provisions of section 4 of the Act of July 31,*  
5 *1946 (40 U.S.C. 193d), except for the provisions relating*  
6 *to solicitation, shall not apply to any activity carried out*  
7 *pursuant to this section, subject to approval of such activi-*  
8 *ties by the Committee on Rules and Administration.”.*

9        *SEC. 5. The first section of Public Law 87–82 (40*  
10 *U.S.C. 174j–1) is amended by adding at the end the fol-*  
11 *lowing: “The provisions of section 4 of the Act of July 31,*  
12 *1946 (40 U.S.C. 193d), except for the provisions relating*  
13 *to solicitation, shall not apply to any activity carried out*  
14 *pursuant to this section, subject to the approval of such ac-*  
15 *tivities by the Committee on Rules and Administration.”.*

16        *SEC. 6. The Legislative Counsel may, subject to the ap-*  
17 *proval of the President pro tempore of the Senate, designate*  
18 *one of the Senior Counsels appointed under section 102 of*  
19 *the Legislative Branch Appropriation Act, 1979 (2 U.S.C.*  
20 *274 note; Public Law 95–391; 92 Stat. 771) as Deputy Leg-*  
21 *islative Counsel. The Deputy Legislative Counsel shall per-*  
22 *form the functions of the Legislative Counsel during the ab-*  
23 *sence or disability of the Legislative Counsel, or when the*  
24 *office is vacant.*

1        *SEC. 7. Section 814(i) of the Foreign Relations Au-*  
2 *thorization Act, Fiscal Years 1986 and 1987 (22 U.S.C.*  
3 *2291 note) is amended by striking “September 30, 1999”*  
4 *and inserting “September 30, 2002”.*

16 including \$10,000 for official expenses of the Minority  
17 Leader; Office of the Majority Whip, including the Chief  
18 Deputy Majority Whip, \$1,423,000, including \$5,000 for  
19 official expenses of the Majority Whip; Office of the Mi-  
20 nority Whip, including the Chief Deputy Minority Whip,  
21 \$1,057,000, including \$5,000 for official expenses of the  
22 Minority Whip; Speaker’s Office for Legislative Floor Ac-  
23 tivities, \$406,000; Republican Steering Committee,  
24 \$757,000; Republican Conference, \$1,244,000; Demo-

8 For Members' representational allowances, including  
9 Members' clerk hire, official expenses, and official mail,  
10 \$413,576,000.

11 COMMITTEE EMPLOYEES

12 STANDING COMMITTEES, SPECIAL AND SELECT

13 For salaries and expenses of standing committees,  
14 special and select, authorized by House resolutions,  
15 \$93,878,000: *Provided*, That such amount shall remain  
16 available for such salaries and expenses until December  
17 31, 2000.

18 COMMITTEE ON APPROPRIATIONS

19 For salaries and expenses of the Committee on Ap-  
20 propriations, \$21,308,000, including studies and examina-  
21 tions of executive agencies and temporary personal serv-  
22 ices for such committee, to be expended in accordance with  
23 section 202(b) of the Legislative Reorganization Act of  
24 1946 and to be available for reimbursement to agencies  
25 for services performed: *Provided*, That such amount shall

1 remain available for such salaries and expenses until De-  
2 cember 31, 2000.

3 SALARIES, OFFICERS AND EMPLOYEES

4 For compensation and expenses of officers and em-  
5 ployees, as authorized by law, \$90,633,000, including: for  
6 salaries and expenses of the Office of the Clerk, including  
7 not more than \$3,500, of which not more than \$2,500 is  
8 for the Family Room, for official representation and recep-  
9 tion expenses, \$14,881,000; for salaries and expenses of  
10 the Office of the Sergeant at Arms, including the position  
11 of Superintendent of Garages, and including not more  
12 than \$750 for official representation and reception ex-  
13 penses, \$3,746,000; for salaries and expenses of the Office  
14 of the Chief Administrative Officer, \$57,289,000, of which  
15 \$2,500,000 shall remain available until expended, includ-  
16 ing \$25,169,000 for salaries, expenses and temporary per-  
17 sonal services of House Information Resources, of which  
18 \$24,641,000 is provided herein: *Provided*, That of the  
19 amount provided for House Information Resources,  
20 \$6,260,000 shall be for net expenses of telecommuni-  
21 cations: *Provided further*, That House Information Re-  
22 sources is authorized to receive reimbursement from Mem-  
23 bers of the House of Representatives and other govern-  
24 mental entities for services provided and such reimburse-  
25 ment shall be deposited in the Treasury for credit to this

1 account; for salaries and expenses of the Office of the In-  
2 spector General, \$3,926,000; for salaries and expenses of  
3 the Office of General Counsel, \$840,000; for the Office  
4 of the Chaplain, \$136,000; for salaries and expenses of  
5 the Office of the Parliamentarian, including the Parlia-  
6 mentarian and \$2,000 for preparing the Digest of Rules,  
7 \$1,172,000; for salaries and expenses of the Office of the  
8 Law Revision Counsel of the House, \$2,045,000; for sala-  
9 ries and expenses of the Office of the Legislative Counsel  
10 of the House, \$5,085,000; for salaries and expenses of the  
11 Corrections Calendar Office, \$825,000; and for other au-  
12 thorized employees, \$688,000.

13 ALLOWANCES AND EXPENSES

14 For allowances and expenses as authorized by House  
15 resolution or law, \$135,422,000, including: supplies, mate-  
16 rials, administrative costs and Federal tort claims,  
17 \$2,741,000; official mail for committees, leadership of-  
18 fices, and administrative offices of the House, \$410,000;  
19 Government contributions for health, retirement, Social  
20 Security, and other applicable employee benefits,  
21 \$131,595,000; and miscellaneous items including pur-  
22 chase, exchange, maintenance, repair and operation of  
23 House motor vehicles, interparliamentary receptions, and  
24 gratuities to heirs of deceased employees of the House,  
25 \$676,000.

## 1 CHILD CARE CENTER

2 For salaries and expenses of the House of Represent-  
3 atives Child Care Center, such amounts as are deposited  
4 in the account established by section 312(d)(1) of the Leg-  
5 islative Branch Appropriations Act, 1992 (40 U.S.C.  
6 184g(d)(1)), subject to the level specified in the budget  
7 of the Center, as submitted to the Committee on Appro-  
8 priations of the House of Representatives.

## 9 ADMINISTRATIVE PROVISIONS

10 SEC. 101. (a) COMPLIANCE WITH ADMISSION RE-  
11 QUIREMENTS.—The General Counsel of the House of Rep-  
12 resentatives and any other counsel in the Office of the  
13 General Counsel of the House of Representatives, includ-  
14 ing any counsel specially retained by the Office of General  
15 Counsel, shall be entitled, for the purpose of performing  
16 the counsel's functions, to enter an appearance in any pro-  
17 ceeding before any court of the United States or of any  
18 State or political subdivision thereof without compliance  
19 with any requirements for admission to practice before  
20 such court, except that the authorization conferred by this  
21 subsection shall not apply with respect to the admission  
22 of any such person to practice before the United States  
23 Supreme Court.

24 (b) NOTIFICATION BY ATTORNEY GENERAL.—The  
25 Attorney General shall notify the General Counsel of the

1 House of Representatives with respect to any proceeding  
2 in which the United States is a party of any determination  
3 by the Attorney General or Solicitor General not to appeal  
4 any court decision affecting the constitutionality of an Act  
5 or joint resolution of Congress within such time as will  
6 enable the House to direct the General Counsel to inter-  
7 vene as a party in such proceeding pursuant to applicable  
8 rules of the House of Representatives.

9 (c) GENERAL COUNSEL DEFINITION.—In this sec-  
10 tion, the term “General Counsel of the House of Rep-  
11 resentatives” means—

12 (1) the head of the Office of General Counsel  
13 established and operating under clause 8 of rule II  
14 of the Rules of the House of Representatives;

15 (2) the head of any successor office to the Of-  
16 fice of General Counsel which is established after the  
17 date of the enactment of this Act; and

18 (3) any other person authorized and directed in  
19 accordance with the Rules of the House of Rep-  
20 resentatives to provide legal assistance and represen-  
21 tation to the House in connection with the matters  
22 described in this section.

23 SEC. 102. section 104(a) of the Legislative Branch  
24 Appropriations Act, 1999 (Public Law 105–275; 112 Stat.

1 2439) is amended by striking “(2 U.S.C. 59(e)(2))” and  
2 inserting “(2 U.S.C. 59e(e)(2))”.

3 SEC. 103. (a) CLARIFICATION OF RULES REGARDING  
4 USE OF FUNDS FOR OFFICIAL MAIL.—

5 (1) IN GENERAL.—Section 311(e)(1) of the  
6 Legislative Branch Appropriations Act, 1991 (2  
7 U.S.C. 59e(e)(1)) is amended—

8 (A) in the matter preceding subparagraph  
9 (A), by striking “There is established” and all  
10 that follows through “shall be prescribed—”  
11 and inserting the following: “The use of funds  
12 of the House of Representatives which are  
13 made available for official mail of Members, of-  
14 ficers, and employees of the House of Rep-  
15 resentatives who are persons entitled to use the  
16 congressional frank shall be governed by regula-  
17 tions promulgated—”; and

18 (B) in subparagraph (A), by striking “the  
19 Allowance” and inserting “official mail (except  
20 as provided in subparagraph (B))”.

21 (2) LIMITATIONS ON AVAILABILITY OF  
22 FUNDS.—Section 311(e)(2) of such Act (2 U.S.C.  
23 59e(e)(2)), as amended by section 104(a) of the  
24 Legislative Branch Appropriations Act, 1999, is  
25 amended—

1 (A) in the matter preceding subparagraph  
2 (A), by striking “The Official Mail Allowance”  
3 and inserting “Funds used for official mail”;

4 (B) by striking subparagraph (A); and

5 (C) by redesignating subparagraphs (B)  
6 and (C) as subparagraphs (A) and (B).

7 (3) REPEAL OF OBSOLETE TRANSFER AUTHOR-  
8 ITY.—Section 311(e) of such Act (2 U.S.C. 59e(e))  
9 is amended by striking paragraph (3).

10 (4) CONFORMING AMENDMENTS.—(A) section  
11 1(a) of House Resolution 457, Ninety-second Con-  
12 gress, agreed to July 21, 1971, as enacted into per-  
13 manent law by chapter IV of the Supplemental Ap-  
14 propriations Act, 1972 (2 U.S.C. 57(a)), is amended  
15 by striking “the Official Mail Allowance” each place  
16 it appears and inserting “official mail”.

17 (B) section 311(a)(3) of the Legislative Branch  
18 Appropriations Act, 1991 (2 U.S.C. 59e(a)(3)) is  
19 amended by striking “costs charged against the Offi-  
20 cial Mail Allowance for” and inserting “costs in-  
21 curred for official mail by”.

22 (b) REPEAL OF OBSOLETE REFERENCES TO CLERK  
23 HIRE ALLOWANCE.—

24 (1) IN GENERAL.—Section 104(a) of the House  
25 of Representatives Administrative Reform Technical

1 Corrections Act (2 U.S.C. 92(a)) is amended by  
2 striking “clerk hire” each place it appears.

3 (2) CONFORMING AMENDMENT.—The heading  
4 of section 104 of such Act (2 U.S.C. 92(a)) is  
5 amended by striking “**CLERK HIRE**”.

6 (c) EFFECTIVE DATE.—The amendments made by  
7 this section shall apply with respect to the first session  
8 of the One Hundred Sixth Congress and each succeeding  
9 session of Congress.

10 SEC. 104. (a) REQUIRING AMOUNTS REMAINING IN  
11 MEMBERS’ REPRESENTATIONAL ALLOWANCES TO BE  
12 USED FOR DEFICIT REDUCTION OR TO REDUCE THE  
13 FEDERAL DEBT.—Notwithstanding any other provision of  
14 law, any amounts appropriated under this Act for  
15 “HOUSE OF REPRESENTATIVES—SALARIES AND  
16 EXPENSES—MEMBERS’ REPRESENTATIONAL ALLOW-  
17 ANCES” shall be available only for fiscal year 2000. Any  
18 amount remaining after all payments are made under such  
19 allowances for fiscal year 2000 shall be deposited in the  
20 Treasury and used for deficit reduction (or, if there is no  
21 Federal budget deficit after all such payments have been  
22 made, for reducing the Federal debt, in such manner as  
23 the Secretary of the Treasury considers appropriate).

24 (b) PUBLICATION.—After each session of Congress or  
25 other period for which the amounts described in subsection

1 (a) are made available, there shall be published in the Con-  
 2 gressional Record a statement showing, with respect to  
 3 such session or period, the amount deposited with respect  
 4 to each Member under subsection (a) and the total depos-  
 5 ited with respect to all Members.

6 (c) REGULATIONS.—The Committee on House Ad-  
 7 ministration of the House of Representatives shall have  
 8 authority to prescribe regulations to carry out this section.

9 (d) DEFINITION.—As used in this section, the term  
 10 “Member of the House of Representatives” means a Rep-  
 11 resentative in, or a Delegate or Resident Commissioner  
 12 to, the Congress.

## 1           OFFICE OF THE ATTENDING PHYSICIAN

2           For medical supplies, equipment, and contingent ex-  
3 penses of the emergency rooms, and for the Attending  
4 Physician and his assistants, including: (1) an allowance  
5 of \$1,500 per month to the Attending Physician; (2) an  
6 allowance of \$500 per month each to three medical officers  
7 while on duty in the Office of the Attending Physician;  
8 (3) an allowance of \$500 per month to one assistant and  
9 \$400 per month each not to exceed eleven assistants on  
10 the basis heretofore provided for such assistants; and (4)  
11 \$1,002,600 for reimbursement to the Department of the  
12 Navy for expenses incurred for staff and equipment as-

## 21   SALARIES

22           For the Capitol Police Board for salaries of officers,  
23 members, and employees of the Capitol Police, including  
24 overtime, hazardous duty pay differential, clothing allow-  
25 ance of not more than \$600 each for members required

1 to wear civilian attire, and Government contributions for  
2 health, retirement, Social Security, and other applicable  
3 employee benefits, \$78,501,000, of which \$37,725,000 is  
4 provided to the Sergeant at Arms of the House of Rep-  
5 resentatives, to be disbursed by the Chief Administrative  
6 Officer of the House, and \$40,776,000 is provided to the  
7 Sergeant at Arms and Doorkeeper of the Senate, to be  
8 disbursed by the Secretary of the Senate: *Provided*, That,  
9 of the amounts appropriated under this heading, such  
10 amounts as may be necessary may be transferred between  
11 the Sergeant at Arms of the House of Representatives and  
12 the Sergeant at Arms and Doorkeeper of the Senate, upon  
13 approval of the Committee on Appropriations of the House  
14 of Representatives and the Committee on Appropriations  
15 of the Senate.

16 GENERAL EXPENSES

17 For the Capitol Police Board for necessary expenses  
18 of the Capitol Police, including motor vehicles, commu-  
19 nications and other equipment, security equipment and in-  
20 stallation, uniforms, weapons, supplies, materials, train-  
21 ing, medical services, forensic services, stenographic serv-  
22 ices, personal and professional services, the employee as-  
23 sistance program, not more than \$2,000 for the awards  
24 program, postage, telephone service, travel advances, relo-  
25 cation of instructor and liaison personnel for the Federal

1 Law Enforcement Training Center, and \$85 per month  
2 for extra services performed for the Capitol Police Board  
3 by an employee of the Sergeant at Arms of the Senate  
4 or the House of Representatives designated by the Chair-  
5 man of the Board, \$6,711,000, to be disbursed by the  
6 Capitol Police Board or their delegee: *Provided*, That, not-  
7 withstanding any other provision of law, the cost of basic  
8 training for the Capitol Police at the Federal Law En-  
9 forcement Training Center for fiscal year 2000 shall be  
10 paid by the Secretary of the Treasury from funds available  
11 to the Department of the Treasury.

12 ADMINISTRATIVE PROVISION

13 SEC. 105. Amounts appropriated for fiscal year 2000  
14 for the Capitol Police Board for the Capitol Police may  
15 be transferred between the headings "SALARIES" and

2 *ferent from that specifically established by such Act, the rate*  
3 *of compensation and the designation in this Act shall be*  
4 *the permanent law with respect thereto: Provided, That the*  
5 *provisions in this Act for the various items of official ex-*  
6 *penses of Members, officers, and committees of the Senate*  
7 *and House of Representatives, and clerk hire for Senators*  
8 *and Members of the House of Representatives shall be the*  
9 *permanent law with respect thereto.*

10       *SEC. 304. The expenditure of any appropriation under*  
11 *this Act for any consulting service through procurement*  
12 *contract, pursuant to 5 U.S.C. 3109, shall be limited to*

4 *Such concerts shall be held on Memorial Day, 4th of July,*

10 *(d), the concerts held on Memorial Day and 4th of July*  
11 *(or their alternate dates) may be broadcast over radio, tele-*  
12 *vision, and other media outlets.*

13       *(3) In order to permit the setting up and taking down*  
14 *of structures and equipment and the conducting of dress*  
15 *rehearsals, the Architect of the Capitol may permit the*  
16 *sponsor to use the West Central Front of the United States*  
17 *Capitol for each event for not more than—*

18               *(A) six days if the concert is televised, and*

19               *(B) four days if the concert is not televised.*

20 *The Architect may not schedule any use under this para-*  
21 *graph if it would interfere with any concert to be performed*  
22 *by a military band of the United States.*

2             (A) *provide for all security related needs, and*

3             (B) *provide for enforcement of the restrictions*

4       *contained in section 4 of the Act of July 31, 1946 (40*

5       *U.S.C. 193d; 60 Stat. 718), concerning sales, dis-*

6       *plays, advertisements, and solicitations on the Capitol*

7       *Grounds, as well as other restrictions applicable to*

8       *the Capitol Grounds.*

9       (2) *Notwithstanding paragraph (1), credits may be ap-*

10       *propriately given to private sponsors of an event at the con-*

11       *clusion of any broadcast of the event.*

12       (3) *The Architect of the Capitol and the Capitol Police*

13       *Board shall enter into an agreement with the sponsor, and*

14       *such other persons participating in an event as the Archi-*

15       *tect of the Capitol and the Capitol Police Board considers*

16       *appropriate, under which the sponsor and such persons*

17       *agree to comply with the requirements of this subsection.*

18       *The agreement shall specifically prohibit the use for a com-*

19       *mercial purpose of any photograph taken at, or broadcast*

20       *production of, the event.*

21       SEC. 312. TRADE DEFICIT REVIEW COMMISSION. (a)

25 *TERS.*—Section 127 of the *Trade Deficit Review Commis-*

1 *sion Act is amended by adding at the end the following*  
 2 *new subsections:*

3       “(j) *FEDERAL ADVISORY COMMITTEE ACT.*—*The pro-*  
 4 *visions of the Federal Advisory Committee Act (Public Law*  
 5 *92-463; 5 U.S.C. App.) shall not apply to the Commission.*

6       “(k) *TERMINATION.*—*The Commission shall terminate*  
 7 *90 days after the date on which the Commission submits*  
 8 *the final report under subsection (e).”.*

9       *SEC. 313. CREDITABLE SERVICE WITH CONGRES-*

13        *munication to or appearance before any person de-*

15        *other person (except the United States) in connection*  
16        *with any matter on which such former employee seeks*  
17        *action by a Member, officer, or employee of either*  
18        *House of Congress, in his or her official capacity,*
