## A BILL

To authorize the Secretary of the Interior to contribute funds

for the establishment of an interpretative center on the life and contributions of President Abraham Lincoln.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CONTRIBUTIONS TOWARD ESTABLISHMENT OF**  
4 **ABRAHAM LINCOLN INTERPRETIVE CENTER.**

5 (a) *GRANTS AUTHORIZED.*—Subject to subsections (b)  
6 and (c), the Secretary of the Interior shall make grants to  
7 contribute funds for the establishment in Springfield, Illi-  
8 nois, of an interpretive center to preserve and make avail-  
9 able to the public materials related to the life of President  
10 Abraham Lincoln and to provide interpretive and edu-  
11 cational services which communicate the meaning of the life  
12 of Abraham Lincoln.

13 (b) *PLAN AND DESIGN.*—

14 (1) *SUBMISSION.*—Not later than 18 months  
15 after the date of enactment of this Act, the entity se-  
16 lected by the Secretary of the Interior to receive  
17 grants under subsection (a) shall submit to the Sec-  
18 retary a plan and design for the interpretive center,  
19 including a description of the following:

20 (A) *The design of the facility and site.*

21 (B) *The method of acquisition.*

22 (C) *The estimated cost of acquisition, con-*  
23 *struction, operation, and maintenance.*

1                   (D) *The manner and extent to which non-*  
2                   *Federal entities will participate in the acquisi-*  
3                   *tion, construction, operation, and maintenance*  
4                   *of the center.*

5                   (2) *CONSULTATION AND COOPERATION.—The*  
6                   *plan and design for the interpretive center shall be*  
7                   *prepared in consultation with the Secretary of the In-*  
8                   *terior and the Governor of Illinois and in cooperation*  
9                   *with such other public, municipal, and private enti-*  
10                  *ties as the Secretary considers appropriate.*

11                  (c) *CONDITIONS ON GRANT.—*

12                  (1) *MATCHING REQUIREMENT.—A grant under*  
13                  *subsection (a) may not be made until such time as the*  
14                  *entity selected to receive the grant certifies to the Sec-*  
15                  *retary of the Interior that funds have been contributed*  
16                  *by the State of Illinois or raised from non-Federal*  
17                  *sources for use to establish the interpretive center in*  
18                  *an amount equal to at least double the amount of that*  
19                  *grant.*

20                  (2) *RELATION TO OTHER LINCOLN-RELATED*  
21                  *SITES AND MUSEUMS.—The Secretary of the Interior*  
22                  *shall further condition the grant under subsection (a)*  
23                  *on the agreement of the grant recipient to operate the*  
24                  *resulting interpretive center in cooperation with other*  
25                  *Federal and non-Federal historic sites, parks, and*

1        *museums that represent significant locations or events*  
2        *in the life of Abraham Lincoln. Cooperative efforts to*  
3        *promote and interpret the life of Abraham Lincoln*  
4        *may include the use of cooperative agreements, cross*  
5        *references, cross promotion, and shared exhibits.*

6        *(d) PROHIBITION ON CONTRIBUTION OF OPERATING*  
7        *FUNDS.—Grant amounts may not be used for the mainte-*  
8        *nance or operation of the interpretive center.*

9        *(e) NON-FEDERAL OPERATION.—The Secretary of In-*  
10       *terior shall have no involvement in the actual operation of*  
11       *the interpretive center, except at the request of the non-Fed-*  
12       *eral entity responsible for the operation of the center.*

13       *(f) AUTHORIZATION OF APPROPRIATIONS.—There are*  
14       *authorized to be appropriated to the Secretary of the Inte-*  
15       *rior a total of \$50,000,000 to make grants under subsection*  
16       *(a). Amounts so appropriated shall remain available for ex-*  
17       *penditure through fiscal year 2006.*
