## A BILL

To amend title 18, United States Code, to provide that certain sexual crimes against children are predicate crimes for the interception of communications, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Child Sex Crimes  
3 Wiretapping Act of 1999”.

4 **SEC. 2. AUTHORIZATION OF INTERCEPTION OF COMMU-**  
5 **NICATIONS IN THE INVESTIGATION OF SEX-**  
6 **UAL CRIMES AGAINST CHILDREN.**

7 (a) **CHILD PORNOGRAPHY.**—Section 2516(1)(c) of  
8 title 18, United States Code, is amended by inserting “sec-  
9 tion 2252A (relating to material constituting or containing  
10 child pornography),” after “2252 (sexual exploitation of  
11 children),”.

12 (b) **COERCION AND ENTICEMENT TO ENGAGE IN**  
13 **PROSTITUTION OR OTHER ILLEGAL SEXUAL ACTIVITY.**—  
14 Section 2516(1)(c) of title 18, United States Code, is  
15 amended by inserting “section 2422 (relating to coercion  
16 and enticement),” after “section 2321 (relating to traf-  
17 ficking in certain motor vehicles or motor vehicle parts),”.

18 (c) **TRANSPORTATION OF MINORS TO ENGAGE IN**  
19 **PROSTITUTION OR OTHER ILLEGAL SEXUAL ACTIVITY.**—  
20 Section 2516(1)(c) of title 18, United States Code, is  
21 amended by inserting after the matter added to that sec-  
22 tion by subsection (b) of this section the following: “sec-  
23 tion 2423 (relating to transportation of minors)”.

1 **SEC. 3. TECHNICAL AMENDMENT ELIMINATING DUPLICA-**  
2 **TIVE PROVISION.**

3 Section 2516(1) of title 18, United States Code, is  
4 amended—

5 (1) by striking the first paragraph (p); and

6 (2) by inserting “or” at the end of paragraph

7 (o).
