A BILL

To establish the Red River National Wildlife Refuge.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Red River National*
5 *Wildlife Refuge Act”.*

1 **SEC. 2. FINDINGS.**

2 *The Congress finds the following:*

3 (1) *The area of Louisiana known as the Red*
4 *River Valley, located along the Red River Waterway*
5 *in Caddo, Bossier, Red River, Natchitoches, and*
6 *DeSoto Parishes, is of critical importance to over 350*
7 *species of birds (including migratory and resident*
8 *waterfowl, shore birds, and neotropical migratory*
9 *birds), aquatic life, and a wide array of other species*
10 *associated with river basin ecosystems.*

11 (2) *The bottomland hardwood forests of the Red*
12 *River Valley have been almost totally cleared. Refore-*
13 *station and restoration of native habitat will benefit*
14 *a host of species.*

15 (3) *The Red River Valley is part of a major con-*
16 *tinental migration corridor for migratory birds fun-*
17 *neling through the mid continent from as far north*
18 *as the Arctic Circle and as far south as South Amer-*
19 *ica.*

20 (4) *There are no significant public sanctuaries*
21 *for over 300 river miles on this important migration*
22 *corridor, and no significant Federal, State, or private*
23 *wildlife sanctuaries along the Red River north of Al-*
24 *exandria, Louisiana.*

25 (5) *Completion of the lock and dam system asso-*
26 *ciated with the Red River Waterway project up to*

1 *Shreveport, Louisiana, has enhanced opportunities for*
2 *management of fish and wildlife.*

3 (6) *The Red River Valley offers extraordinary*
4 *recreational, research, and educational opportunities*
5 *for students, scientists, bird watchers, wildlife observ-*
6 *ers, hunters, anglers, trappers, hikers, and nature*
7 *photographers.*

8 (7) *The Red River Valley is an internationally*
9 *significant environmental resource that has been ne-*
10 *glected and requires active restoration and manage-*
11 *ment to protect and enhance the value of the region*
12 *as a habitat for fish and wildlife.*

13 **SEC. 3. ESTABLISHMENT AND PURPOSES OF REFUGE.**

14 (a) *ESTABLISHMENT.—*

15 (1) *IN GENERAL.—The Secretary shall establish*
16 *the Red River National Wildlife Refuge, consisting of*
17 *approximately 50,000 acres of Federal lands, waters,*
18 *and interests therein within the boundaries depicted*
19 *upon the map entitled “Red River National Wildlife*
20 *Refuge—Proposed”, dated July 20, 2000.*

21 (2) *BOUNDARY REVISIONS.—The Secretary shall*
22 *make such minor revisions of the boundaries of the*
23 *Refuge as may be appropriate to carry out the pur-*
24 *poses of the Refuge or to facilitate the acquisition of*
25 *property within the Refuge.*

1 (3) *AVAILABILITY OF MAP.*—*The Secretary shall*
2 *keep the map referred to in paragraph (1) available*
3 *for inspection in appropriate offices of the United*
4 *States Fish and Wildlife Service.*

5 (b) *PURPOSES.*—*The purposes of the Refuge are the fol-*
6 *lowing:*

7 (1) *To restore and preserve native Red River eco-*
8 *systems.*

9 (2) *To provide habitat for migratory birds.*

10 (3) *To maximize fisheries on the Red River and*
11 *its tributaries, natural lakes, and man-made res-*
12 *ervoirs.*

13 (4) *To provide habitat for and population man-*
14 *agement of native plants and resident animals (in-*
15 *cluding restoration of extirpated species).*

16 (5) *To provide technical assistance to private*
17 *land owners in the restoration of their lands for the*
18 *benefit of fish and wildlife.*

19 (c) *EFFECTIVE DATE.*—*The establishment of the Ref-*
20 *uge under paragraph (1) of subsection (a) shall take effect*
21 *on the date the Secretary publishes, in the Federal Register*
22 *and publications of local circulation in the vicinity of the*
23 *area within the boundaries referred to in that paragraph,*
24 *a notice that sufficient property has been acquired by the*
25 *United States within those boundaries to constitute an area*

1 *that can be efficiently managed as a National Wildlife Ref-*
2 *uge.*

3 **SEC. 4. ADMINISTRATION OF REFUGE.**

4 (a) *IN GENERAL.*—*The Secretary shall administer all*
5 *lands, waters, and interests therein acquired under section*
6 *5 in accordance with—*

7 (1) *the National Wildlife Refuge System Admin-*
8 *istration Act of 1966 (16 U.S.C. 668dd et seq.) and*
9 *the Act of September 28, 1962 (76 Stat. 653; 16*
10 *U.S.C. 460k et seq.; commonly known as the Refuge*
11 *Recreation Act);*

12 (2) *the purposes of the Refuge set forth in section*
13 *3(b); and*

14 (3) *the management plan issued under subsection*
15 *(b).*

16 (b) *MANAGEMENT PLAN.*—

17 (1) *IN GENERAL.*—*Not later than 18 months*
18 *after the date of the enactment of this Act, the Sec-*
19 *retary shall issue a management plan for the Refuge.*

20 (2) *CONTENTS.*—*The management plan shall in-*
21 *clude provisions that provide for the following:*

22 (A) *Planning and design of trails and ac-*
23 *cess points.*

24 (B) *Planning of wildlife and habitat res-*
25 *toration, including reforestation.*

1 (C) *Permanent exhibits and facilities and*
2 *regular educational programs throughout the*
3 *Refuge.*

4 (D) *Provision of opportunities for compat-*
5 *ible fish- and wildlife-oriented recreation, to en-*
6 *sure that hunting, fishing, wildlife observation*
7 *and photography, and environmental education*
8 *and interpretation are the priority general pub-*
9 *lic uses of the Refuge, in accordance with section*
10 *4(a)(3) and (4) of the National Wildlife Refuge*
11 *System Administration Act of 1966 (16 U.S.C.*
12 *668ee(a)(3), (4)).*

13 (3) *PUBLIC PARTICIPATION.—*

14 (A) *IN GENERAL.—The Secretary shall pro-*
15 *vide an opportunity for public participation in*
16 *developing the management plan.*

17 (B) *LOCAL VIEWS.—The Secretary shall*
18 *give special consideration to views by local pub-*
19 *lic and private entities and individuals in devel-*
20 *oping the management plan.*

21 (c) *WILDLIFE INTERPRETATION AND EDUCATION CEN-*
22 *TER.—*

23 (1) *IN GENERAL.—The Secretary shall construct,*
24 *administer, and maintain, at an appropriate site*

1 *within the Refuge, a wildlife interpretation and edu-*
2 *cation center.*

3 (2) *PURPOSES.—The center shall be designed*
4 *and operated—*

5 (A) *to promote environmental education;*
6 *and*

7 (B) *to provide an opportunity for the study*
8 *and enjoyment of wildlife in its natural habitat.*

9 **SEC. 5. ACQUISITION OF LANDS, WATERS, AND INTERESTS**

10 **THEREIN.**

11 (a) *IN GENERAL.—The Secretary may acquire up to*
12 *50,000 acres of lands, waters, or interests therein within*
13 *the boundaries of the Refuge described in section 3(a)(1).*

14 (b) *INCLUSION IN REFUGE.—Any lands, waters, or in-*
15 *terests acquired by the Secretary under this section shall*
16 *be part of the Refuge.*

17 **SEC. 6. AUTHORIZATION OF APPROPRIATIONS.**

18 *There are authorized to be appropriated to the Sec-*
19 *retary such sums as may be necessary to carry out this Act.*

20 **SEC. 7. DEFINITIONS.**

21 *For purposes of this Act:*

22 (1) *REFUGE.—The term “Refuge” means the Red*
23 *River National Wildlife Refuge established under sec-*
24 *tion 3.*

- 1 (2) *SECRETARY.*—*The term “Secretary” means*
2 *the Secretary of the Interior.*
