## A BILL

To amend title 3, United States Code, and the Uniform Time Act of 1966 to establish a single poll closing time for Presidential general elections.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Uniform Poll Closing  
5 Act of 2000”.

1 **SEC. 2. SINGLE POLL CLOSING TIME FOR PRESIDENTIAL**  
2 **GENERAL ELECTIONS.**

3 Chapter 1 of title 3, United States Code, is amended  
4 by—

5 (1) redesignating section 21 as section 22; and

6 (2) inserting after section 20 the following new  
7 section:

8 **“SEC. 21. SINGLE POLL CLOSING TIME.**

9 “(a) Each polling place in each State shall close, with  
10 respect to a Presidential general election, at 9:00 o’clock  
11 post meridiem, eastern standard time. Any person who,  
12 as determined under the law of the State involved, arrives  
13 at a polling place after that time shall not be permitted  
14 to vote in the Presidential general election.

15 “(b) Notwithstanding subsection (a), a polling place  
16 shall close, with respect to a Presidential general election,  
17 as provided by the law of the State involved, in the case  
18 of a polling place at which each person who is eligible to  
19 vote has voted.

20 “(c) Notwithstanding section 1 or any other provision  
21 of law, in the case of the States of Alaska and Hawaii,  
22 a State may open polling places with respect to a Presi-  
23 dential general election during the day preceding the day  
24 provided under such section in addition to the day pro-  
25 vided under such section, so long as the State meets the

1 requirements of subsection (a) with respect to the day pro-  
2 vided under such section.

3 “(d) As used in this section, the term ‘Presidential  
4 general election’ means the election for electors of Presi-  
5 dent and Vice President.”.

6 **SEC. 3. EXTENDED DAYLIGHT SAVING TIME IN PACIFIC**  
7 **TIME ZONE IN PRESIDENTIAL ELECTION**  
8 **YEARS.**

9 Section 3 of the Uniform Time Act of 1966 (15  
10 U.S.C. 260a) is amended by adding at the end the fol-  
11 lowing new subsection:

12 “(d)(1) Notwithstanding subsection (a) of this sec-  
13 tion, in each year in which a Presidential general election  
14 takes place, the period of time during which the standard  
15 time shall be advanced with respect to the Pacific time  
16 zone shall end at 2:00 o’clock ante meridiem on the first  
17 Sunday after the date of that election.

18 “(2) As used in this subsection, the term ‘Presi-  
19 dential general election’ means the election for electors of  
20 President and Vice President.”.

21 **SEC. 4. TECHNICAL AMENDMENTS.**

22 (a) AMENDMENTS TO TITLE 3, UNITED STATES  
23 CODE.—The table of sections for chapter 1 of title 3,  
24 United States Code, is amended—

1           (1) by redesignating the item relating to section  
2           21 as the item relating to section 22; and

3           (2) by inserting after the item relating to sec-  
4           tion 20 the following new item:

“21. Single poll closing time in continental United States.”.

5           (b) AMENDMENTS TO UNIFORM TIME ACT OF  
6 1966.—Section 3(a) of the Uniform Time Act of 1966 (15  
7 U.S.C. 260a(a)) is amended by striking out “2 o’clock  
8 antemeridian” each place it appears and inserting in lieu  
9 thereof “2:00 o’clock ante meridiem”.
