## A BILL

To establish the Thomas Cole National Historic Site in the State of New York as an affiliated area of the National Park System.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

2 (a) *SHORT TITLE.*—*This Act may be cited as the*  
 3 *“Thomas Cole National Historic Site Act”.*

4 (b) *TABLE OF CONTENTS.*—*The table of contents of this*  
 5 *Act is as follows:*

*Sec. 1. Short title; table of contents.*

*Sec. 2. Definitions.*

*Sec. 3. Findings and purposes.*

*Sec. 4. Establishment of Thomas Cole National Historic Site.*

6 **SEC. 2. DEFINITIONS.**

7 *As used in this Act:*

8 (1) *The term “historic site” means the Thomas*  
 9 *Cole National Historic Site established by section 4 of*  
 10 *this Act.*

11 (2) *The term “Hudson River artists” means art-*  
 12 *ists who were associated with the Hudson River school*  
 13 *of landscape painting.*

14 (3) *The term “plan” means the general manage-*  
 15 *ment plan developed pursuant to section 6(d).*

16 (4) *The term “Secretary” means the Secretary of*  
 17 *the Interior.*

18 (5) *The term “Society” means the Greene County*  
 19 *Historical Society of Greene County, New York, which*  
 20 *owns the Thomas Cole home, studio, and other prop-*  
 21 *erty comprising the historic site.*

1 **SEC. 3. FINDINGS AND PURPOSES.**

2 (a) *FINDINGS.*—Congress finds the following:

3 (1) *The Hudson River school of landscape paint-*  
4 *ing was inspired by Thomas Cole and was character-*  
5 *ized by a group of 19th century landscape artists who*  
6 *recorded and celebrated the landscape and wilderness*  
7 *of America, particularly in the Hudson River Valley*  
8 *region in the State of New York.*

9 (2) *Thomas Cole is recognized as America’s most*  
10 *prominent landscape and allegorical painter of the*  
11 *mid-19th century.*

12 (3) *Located in Greene County, New York, the*  
13 *Thomas Cole House, also known as Thomas Cole’s*  
14 *Cedar Grove, is listed on the National Register of*  
15 *Historic Places and has been designated as a Na-*  
16 *tional Historic Landmark.*

17 (4) *Within a 15 mile radius of the Thomas Cole*  
18 *House, an area that forms a key part of the rich cul-*  
19 *tural and natural heritage of the Hudson River Val-*  
20 *ley region, significant landscapes and scenes painted*  
21 *by Thomas Cole and other Hudson River artists, such*  
22 *as Frederic Church, survive intact.*

23 (5) *The State of New York has established the*  
24 *Hudson River Valley Greenway to promote the preser-*  
25 *vation, public use, and enjoyment of the natural and*  
26 *cultural resources of the Hudson River Valley region.*

1           (6) *Establishment of the Thomas Cole National*  
2 *Historic Site will provide opportunities for the illus-*  
3 *tration and interpretation of cultural themes of the*  
4 *heritage of the United States and unique opportuni-*  
5 *ties for education, public use, and enjoyment.*

6           (b) *PURPOSES.—The purposes of this Act are—*

7           (1) *to preserve and interpret the home and stu-*  
8 *dio of Thomas Cole for the benefit, inspiration, and*  
9 *education of the people of the United States;*

10          (2) *to help maintain the integrity of the setting*  
11 *in the Hudson River Valley region that inspired ar-*  
12 *tistic expression;*

13          (3) *to coordinate the interpretive, preservation,*  
14 *and recreational efforts of Federal, State, and other*  
15 *entities in the Hudson Valley region in order to en-*  
16 *hance opportunities for education, public use, and en-*  
17 *joyment; and*

18          (4) *to broaden understanding of the Hudson*  
19 *River Valley region and its role in American history*  
20 *and culture.*

21 **SEC. 4. ESTABLISHMENT OF THOMAS COLE NATIONAL HIS-**  
22 **TORIC SITE.**

23          (a) *ESTABLISHMENT.—There is established, as an af-*  
24 *filiated area of the National Park System, the Thomas Cole*  
25 *National Historic Site in the State of New York.*

1           (b) *DESCRIPTION.*—*The historic site shall consist of the*  
2 *home and studio of Thomas Cole, comprising approxi-*  
3 *mately 3.4 acres, located at 218 Spring Street, in the village*  
4 *of Catskill, New York, as generally depicted on the boundary*  
5 *map numbered TCH/80002, and dated March 1992.*

6 **SEC. 5. RETENTION OF OWNERSHIP AND MANAGEMENT OF**  
7                           **HISTORIC SITE BY GREENE COUNTY HISTOR-**  
8                           **ICAL SOCIETY.**

9           *The Greene County Historical Society of Greene Coun-*  
10 *ty, New York, shall continue to own, administer, manage,*  
11 *and operate the historic site.*

12 **SEC. 6. ADMINISTRATION OF HISTORIC SITE.**

13           (a) *APPLICABILITY OF NATIONAL PARK SYSTEM*  
14 *LAWS.*—*The historic site shall be administered in a manner*  
15 *consistent with this Act and all laws generally applicable*  
16 *to units of the National Park System, including the Act*  
17 *of August 25, 1916 (16 U.S.C. 1 et seq.; commonly known*  
18 *as the National Park Service Organic Act), and the Act*  
19 *of August 21, 1935 (16 U.S.C. 461 et seq.; commonly known*  
20 *as the Historic Sites, Buildings, and Antiquities Act).*

21           (b) *COOPERATIVE AGREEMENTS.*—

22                   (1) *ASSISTANCE TO SOCIETY.*—*The Secretary*  
23 *may enter into cooperative agreements with the Soci-*  
24 *ety to preserve the Thomas Cole House and other*  
25 *structures in the historic site and to assist with edu-*

1        *cation programs and research and interpretation of*  
2        *the Thomas Cole House and associated landscapes.*

3            (2) *OTHER ASSISTANCE.*—*To further the pur-*  
4        *poses of this Act, the Secretary may enter into cooper-*  
5        *ative agreements with the State of New York, the So-*  
6        *cietty, the Thomas Cole Foundation, and other public*  
7        *and private entities to facilitate public understanding*  
8        *and enjoyment of the lives and works of the Hudson*  
9        *River artists through the provision of assistance to de-*  
10       *velop, present, and fund art exhibits, resident artist*  
11       *programs, and other appropriate activities related to*  
12       *the preservation, interpretation, and use of the his-*  
13       *toric site.*

14           (c) *ARTIFACTS AND PROPERTY.*—*The Secretary may*  
15       *acquire personal property associated with, and appropriate*  
16       *for, the interpretation of the historic site.*

17           (d) *GENERAL MANAGEMENT PLAN.*—*Within two com-*  
18       *plete fiscal years after the date of the enactment of this Act,*  
19       *the Secretary shall develop a general management plan for*  
20       *the historic site with the cooperation of the Society. Upon*  
21       *the completion of the plan, the Secretary shall provide a*  
22       *copy of the plan to the Committee on Energy and Natural*  
23       *Resources of the Senate and the Committee on Resources*  
24       *of the House of Representatives. The plan shall include rec-*  
25       *ommendations for regional wayside exhibits, to be carried*

1 *out through cooperative agreements with the State of New*  
2 *York and other public and private entities. The plan shall*  
3 *be prepared in accordance with section 12(b) of Public Law*  
4 *91–383 (16 U.S.C. 1a–1 et seq.; commonly known as the*  
5 *National Park System General Authorities Act).*

6 **SEC. 7. AUTHORIZATION OF APPROPRIATIONS.**

7 *There are authorized to be appropriated such sums as*  
8 *are necessary to carry out this Act.*
