## A BILL

To preserve the cultural resources of the Route 66 corridor and to authorize the Secretary of the Interior to provide assistance.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DEFINITIONS.**

4 *In this Act, the following definitions apply:*

5 (1) *ROUTE 66 CORRIDOR.*—*The term “Route 66*  
6 *corridor” means structures and other cultural re-*  
7 *sources described in paragraph (3), including—*

8 (A) *lands owned by the Federal Government*  
9 *and lands owned by a State or local government*  
10 *within the immediate vicinity of those portions*  
11 *of the highway formerly designated as United*  
12 *States Route 66; and*

13 (B) *private land within that immediate vi-*  
14 *cinity that is owned by persons or entities that*  
15 *are willing to participate in the programs au-*  
16 *thorized by this Act.*

17 (2) *CULTURAL RESOURCE PROGRAMS.*—*The term*  
18 *“Cultural Resource Programs” means the programs*  
19 *established and administered by the National Park*  
20 *Service for the benefit of and in support of preserva-*  
21 *tion of the Route 66 corridor, either directly or indi-*  
22 *rectly.*

23 (3) *PRESERVATION OF THE ROUTE 66 COR-*  
24 *RIDOR.*—*The term “preservation of the Route 66 cor-*  
25 *ridor” means the preservation or restoration of struc-*

1        *tures or other cultural resources of businesses, sites of*  
2        *interest, and other contributing resources that—*

3                *(A) are located within the land described in*  
4                *paragraph (1);*

5                *(B) existed during the route’s period of out-*  
6                *standing historic significance (principally be-*  
7                *tween 1926 and 1970), as defined by the study*  
8                *prepared by the National Park Service and enti-*  
9                *tled “Special Resource Study of Route 66”, dated*  
10               *July 1995; and*

11               *(C) remain in existence as of the date of en-*  
12               *actment of this Act.*

13               *(4) SECRETARY.—The term “Secretary” means*  
14               *the Secretary of the Interior, acting through the Cul-*  
15               *tural Resource Programs at the National Park Serv-*  
16               *ice.*

17               *(5) STATE.—The term “State” means a State in*  
18               *which a portion of the Route 66 corridor is located.*

19        **SEC. 2. MANAGEMENT.**

20               *(a) IN GENERAL.—The Secretary, in collaboration*  
21               *with the entities described in subsection (c), shall facilitate*  
22               *the development of guidelines and a program of technical*  
23               *assistance and grants that will set priorities for the preser-*  
24               *vation of the Route 66 corridor.*

1       (b) *DESIGNATION OF OFFICIALS.*—*The Secretary shall*  
2 *designate officials of the National Park Service stationed*  
3 *at locations convenient to the States to perform the func-*  
4 *tions of the Cultural Resource Programs under this Act.*

5       (c) *GENERAL FUNCTIONS.*—*The Secretary shall—*

6           (1) *support efforts of State and local public and*  
7 *private persons, nonprofit Route 66 preservation enti-*  
8 *ties, Indian tribes, State Historic Preservation Of-*  
9 *fices, and entities in the States for the preservation*  
10 *of the Route 66 corridor by providing technical assist-*  
11 *ance, participating in cost-sharing programs, and*  
12 *making grants;*

13           (2) *act as a clearinghouse for communication*  
14 *among Federal, State, and local agencies, nonprofit*  
15 *Route 66 preservation entities, Indian tribes, State*  
16 *historic preservation offices, and private persons and*  
17 *entities interested in the preservation of the Route 66*  
18 *corridor; and*

19           (3) *assist the States in determining the appro-*  
20 *priate form of and establishing and supporting a*  
21 *non-Federal entity or entities to perform the functions*  
22 *of the Cultural Resource Programs after those pro-*  
23 *grams are terminated.*

24       (d) *AUTHORITIES.*—*In carrying out this Act, the Sec-*  
25 *retary may—*

1           (1) *enter into cooperative agreements, including*  
2           *(but not limited to) cooperative agreements for study,*  
3           *planning, preservation, rehabilitation, and restora-*  
4           *tion related to the Route 66 corridor;*

5           (2) *accept donations of funds, equipment, sup-*  
6           *plies, and services as appropriate;*

7           (3) *provide cost-share grants for projects for the*  
8           *preservation of the Route 66 corridor (but not to ex-*  
9           *ceed 50 percent of total project costs) and information*  
10          *about existing cost-share opportunities;*

11          (4) *provide technical assistance in historic pres-*  
12          *ervation and interpretation of the Route 66 corridor;*  
13          *and*

14          (5) *coordinate, promote, and stimulate research*  
15          *by other persons and entities regarding the Route 66*  
16          *corridor.*

17          (e) *PRESERVATION ASSISTANCE.—*

18           (1) *IN GENERAL.—The Secretary shall provide*  
19           *assistance in the preservation of the Route 66 corridor*  
20           *in a manner that is compatible with the idiosyncratic*  
21           *nature of the Route 66 corridor.*

22           (2) *PLANNING.—The Secretary shall not prepare*  
23           *or require preparation of an overall management*  
24           *plan for the Route 66 corridor, but shall cooperate*  
25           *with the States and local public and private persons*

1        *and entities, State historic preservation offices, non-*  
2        *profit Route 66 preservation entities, and Indian*  
3        *tribes in developing local preservation plans to guide*  
4        *efforts to protect the most important or representative*  
5        *resources of the Route 66 corridor.*

6        **SEC. 3. RESOURCE TREATMENT.**

7        *(a) TECHNICAL ASSISTANCE PROGRAM.—*

8                *(1) PROGRAM REQUIRED.—The Secretary shall*  
9        *develop a program of technical assistance in the pres-*  
10        *ervation of the Route 66 corridor and interpretation*  
11        *of the Route 66 corridor.*

12                *(2) PROGRAM GUIDELINES.—As part of the tech-*  
13        *nical assistance program under paragraph (1), the*  
14        *Secretary shall establish guidelines for setting prior-*  
15        *ities for preservation needs for the Route 66 corridor.*  
16        *The Secretary shall base the guidelines on the Sec-*  
17        *retary's standards for historic preservation.*

18        *(b) PROGRAM FOR COORDINATION OF ACTIVITIES.—*

19                *(1) IN GENERAL.—The Secretary shall coordi-*  
20        *nate a program of historic research, curation, preser-*  
21        *vation strategies, and the collection of oral and video*  
22        *histories of events that occurred along the Route 66*  
23        *corridor.*

24                *(2) DESIGN.—The program under paragraph (1)*  
25        *shall be designed for continuing use and implementa-*

1        *tion by other organizations after the Cultural Re-*  
2        *source Programs are terminated.*

3        **SEC. 4. AUTHORIZATION OF APPROPRIATIONS.**

4        *There are authorized to be appropriated \$10,000,000*  
5        *for the period of fiscal years 2000 through 2009 to carry*  
6        *out the purposes of this Act.*
