## A BILL

To extend for 3 additional months the period for which chapter 12 of title 11 of the United States Code is reenacted.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

1 **SECTION 1. AMENDMENTS.**

2 Section 149 of title I of division C of Public Law 105-  
3 277 is amended—

4 (1) by striking “April 1, 1999” each place it  
5 appears and inserting “July 1, 1999”;

6 (2) in subsection (a)—

7 (A) by striking “September 30, 1998” and  
8 inserting “March 31, 1999”, and

9 (B) by striking “October 1, 1998” and in-  
10 serting “April 1, 1999”, and

11 (3) by striking subsection (e).

12 **SEC. 2. EFFECTIVE DATE.**

13 The amendments made by section 1 shall take effect  
14 on April 1, 1999.

15 **SECTION 1. AMENDMENTS.**

16 *Section 149 of title I of division C of Public Law 105-*  
17 *277 is amended—*

18 (1) *by striking “April 1, 1999” each place it ap-*  
19 *pears and inserting “October 1, 1999”;*

20 (2) *in subsection (a)—*

21 (A) *by striking “September 30, 1998” and*  
22 *inserting “March 31, 1999”, and*

23 (B) *by striking “October 1, 1998” and in-*  
24 *serting “April 1, 1999”, and*

25 (3) *by striking subsection (c).*

1 **SEC. 2. EFFECTIVE DATE.**

2       *The amendments made by section 1 shall take effect*  
3 *on April 1, 1999.*

Amend the title so as to read: “A bill to extend for  
6 additional months the period for which chapter 12 of  
title 11 of the United States Code is reenacted.”.
