A BILL

To designate the Federal building located at 310 New Bern Avenue in Raleigh, North Carolina, as the “Terry Sanford Federal Building”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Terry Sanford Com-
5 memoration Act of 1999”.

6 **SEC. 2. FINDINGS.**

7 Congress makes the following findings:

1 (1) Terry Sanford served the State of North
2 Carolina and the Nation with enthusiasm, bravery,
3 and distinction in many important ways, including—

4 (A) as a paratrooper in World War II;

5 (B) as an agent with the Federal Bureau
6 of Investigation;

7 (C) as a North Carolina State senator;

8 (D) as Governor of North Carolina;

9 (E) as a professor of public policy at Duke
10 University;

11 (F) as President of Duke University;

12 (G) as a United States Senator from
13 North Carolina;

14 (H) as a patron of the arts; and

15 (I) as a loving and committed husband and
16 father.

17 (2) Terry Sanford fought tirelessly and self-
18 lessly throughout his life to improve the lives of his
19 fellow citizens through public education, racial heal-
20 ing, economic development, eradication of poverty,
21 and promotion of the arts.

22 (3) Terry Sanford exemplified the best qualities
23 mankind has to offer.

24 (4) Terry Sanford lived an exemplary life and
25 is owed a debt of gratitude for his untiring service

1 to the State of North Carolina and his fellow Ameri-
2 cans.

3 **SEC. 3. DESIGNATION.**

4 The Federal building located at 310 New Bern Ave-
5 nue in Raleigh, North Carolina, shall be known and des-
6 ignated as the “Terry Sanford Federal Building”.

7 **SEC. 4. REFERENCES.**

8 Any reference in law, map, regulation, document,
9 paper, or other record of the United States to the Federal
10 building referred to in section 3 shall be deemed to be
11 a reference to the “Terry Sanford Federal Building”.
