Whereas United States Capitol Police officers have worked countless hours outside of their normal shifts since the beginning of the impeachment proceedings, often working double shifts;

Whereas United States Capitol Police officers have dutifully guarded all of the critical documents and tapes that were pertinent to the trial;

Whereas United States Capitol Police officers traveled outside of Capitol Hill to ensure the protection of Members of Congress and witnesses of the trial during depositions; and

Whereas the United States Capitol Police force has increased the level of security at the United States Capitol during the impeachment trial: Now, therefore, be it
