Mr. GOSS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 4392) to authorize appropriations for fiscal year 2001 for intelligence and intelligence-related activities of the United States Government, the Community Management Account, and the Central Intelligence Agency Retirement and Disability System, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 2(b) of  
3 rule XVIII, declare the House resolved into the Committee

1 of the Whole House on the state of the Union for consider-  
2 ation of the bill (H.R. 4392) to authorize appropriations  
3 for fiscal year 2001 for intelligence and intelligence-re-  
4 lated activities of the United States Government, the Com-  
5 munity Management Account, and the Central Intelligence  
6 Agency Retirement and Disability System, and for other  
7 purposes. The first reading of the bill shall be dispensed  
8 with. Points of order against consideration of the bill for  
9 failure to comply with clause 4(a) of rule XIII are waived.  
10 General debate shall be confined to the bill and shall not  
11 exceed one hour equally divided and controlled by the  
12 chairman and ranking minority member of the Permanent  
13 Select Committee on Intelligence. After general debate the  
14 bill shall be considered for amendment under the five-  
15 minute rule. It shall be in order to consider as an original  
16 bill for the purpose of amendment under the five-minute  
17 rule the amendment in the nature of a substitute rec-  
18 ommended by the Permanent Select Committee on Intel-  
19 ligence now printed in the bill. The committee amendment  
20 in the nature of a substitute shall be considered by title  
21 rather than by section. Each title shall be considered as  
22 read. Points of order against the committee amendment  
23 in the nature of a substitute for failure to comply with  
24 clause 7 of rule XVI are waived. No amendment to the  
25 committee amendment in the nature of a substitute shall

1 be in order except those printed in the portion of the Con-  
2 gressional Record designated for that purpose in clause  
3 8 of rule XVIII and except pro forma amendments for  
4 the purpose of debate. Each amendment so printed may  
5 be offered only by the Member who caused it to be printed  
6 or his designee and shall be considered as read. The Chair-  
7 man of the Committee of the Whole may: (1) postpone  
8 until a time during further consideration in the Committee  
9 of the Whole a request for a recorded vote on any amend-  
10 ment; and (2) reduce to five minutes the minimum time  
11 for electronic voting on any postponed question that fol-  
12 lows another electronic vote without intervening business,  
13 provided that the minimum time for electronic voting on  
14 the first in any series of questions shall be 15 minutes.  
15 At the conclusion of consideration of the bill for amend-  
16 ment the Committee shall rise and report the bill to the  
17 House with such amendments as may be adopted. Any  
18 Member may demand a separate vote in the House on any  
19 amendment adopted in the Committee of the Whole to the  
20 bill or to the committee amendment in the nature of a  
21 substitute. The previous question shall be considered as  
22 ordered on the bill and amendments thereto to final pas-  
23 sage without intervening motion except one motion to re-  
24 commit with or without instructions.
